# H. R. 5756

To amend title I of the Developmental Disabilities Assistance and Bill of Rights Act of 2000 to provide for grants and technical assistance to improve services rendered to children and adults with autism, and their families, and to expand the number of University Centers for Excellence in Developmental Disabilities Education, Research, and Service.

## A BILL

To amend title I of the Developmental Disabilities Assistance and Bill of Rights Act of 2000 to provide for grants and technical assistance to improve services rendered to children and adults with autism, and their families, and to expand the number of University Centers for Excellence in Developmental Disabilities Education, Research, and Service.

- 1 Be it enacted by the Senate and House of Representa-

#### SECTION 1. SHORT TITLE.

- 2 (a) SHORT TITLE.—This Act may be cited as the
- 3 "Training and Research for Autism Improvements Na-
- 4 tionwide Act".
- 5 SEC. 2. NATIONAL TRAINING INITIATIVES ON AUTISM SPEC-
- 6 TRUM DISORDERS.
- 7 Title I of the Developmental Disabilities Assistance
- 8 and Bill of Rights Act of 2000 (42 U.S.C. 15001 et seq.)
- 9 is amended by adding at the end the following:

- 13 "SEC. 171. NATIONAL TRAINING INITIATIVE.
- 14 "(a) Grants and Technical Assistance.—
- 15 "(1) Grants.—
- 16 "(A) IN GENERAL.—The Secretary, in con-
- sultation with the Interagency Autism Coordi-
- nating Committee, shall award multiyear grants
- to eligible entities to provide individuals (includ-
- ing parents and health, allied health, vocational,
- and educational professionals) with interdiscipli-
- 22 nary training, continuing education, technical
- assistance, and information for the purpose of
- improving services rendered to children and
- adults with autism, and their families, to ad-
- dress unmet needs related to autism.

1	"(B) ELIGIBLE ENTITY.—To be eligible to
2	receive a grant under this subsection, an entity
3	shall be—
4	"(i) a University Center for Excel-
5	lence in Developmental Disabilities Edu-
6	cation, Research, and Service; or
7	"(ii) a comparable interdisciplinary
8	education, research, and service entity.
9	"(C) Application requirements.—An
10	entity that desires to receive a grant for a pro-
11	gram under this paragraph shall submit to the
12	Secretary an application—
13	"(i) demonstrating that the entity has
14	capacity to—
15	"(I) provide training and tech-
16	nical assistance in evidence-based
17	practices to evaluate, and provide ef-
18	fective interventions, services, treat-
19	ments, and supports to, children and
20	adults with autism and their families;
21	"(II) include individuals with au-
22	tism and their families as part of the
23	program to ensure that an individual-
24	and family-centered approach is used;

1	"(III) share and disseminate ma-
2	terials and practices that are devel-
3	oped for, and evaluated to be effective
4	in, the provision of training and tech-
5	nical assistance; and
6	"(IV) provide training, technical
7	assistance, interventions, services,
8	treatments, and supports under this
9	subsection statewide;
10	"(ii) providing assurances that the en-
11	tity will—
12	"(I) provide trainees under this
13	subsection with an appropriate bal-
14	ance of interdisciplinary academic and
15	community-based experiences; and
16	"(II) provide to the Secretary, in
17	the manner prescribed by the Sec-
18	retary, data regarding the number of
19	individuals who have benefitted from,
20	and outcomes of, the provision of
21	training and technical assistance
22	under this subsection;
23	"(iii) providing assurances that train-
24	ing, technical assistance, dissemination of

1	information, and services under this sub-
2	section will be—
3	"(I) consistent with the goals of
4	this Act, the Americans with Disabil-
5	ities Act of 1990, the Individuals with
6	Disabilities Education Act, and the
7	Elementary and Secondary Education
8	Act of 1965; and
9	"(II) conducted in coordination
10	with relevant State agencies, institu-
11	tions of higher education, and service
12	providers; and
13	"(iv) containing such other informa-
14	tion and assurances as the Secretary may
15	require.
16	"(D) USE OF FUNDS.—A grant received
17	under this subsection shall be used to provide
18	individuals (including parents and health, allied
19	health, vocational, and educational profes-
20	sionals) with interdisciplinary training, con-
21	tinuing education, technical assistance, and in-
22	formation for the purpose of improving services
23	rendered to children and adults with autism,
24	and their families, to address unmet needs re-
25	lated to autism. Such training, education, as-

1	sistance, and information shall include each of
2	the following:
3	"(i) Training health, allied health, vo-
4	cational, and educational professionals to
5	identify, evaluate the needs of, and develop
6	interventions, services, treatments, and
7	supports for, children and adults with au-
8	tism.
9	"(ii) Developing model services and
10	supports that demonstrate evidence-based
11	practices.
12	"(iii) Developing systems and prod-
13	ucts that allow for the interventions, serv-
14	ices, treatments, and supports to be evalu-
15	ated for fidelity of implementation.
16	"(iv) Working to expand the avail-
17	ability of evidence-based, lifelong interven-
18	tions; educational, employment, and transi-
19	tion services; and community supports.
20	"(v) Providing statewide technical as-
21	sistance in collaboration with relevant
22	State agencies, institutions of higher edu-
23	cation, autism advocacy groups, and com-
24	munity-based service providers.

1	"(vi) Working to develop comprehen-
2	sive systems of supports and services for
3	individuals with autism and their families,
4	including seamless transitions between
5	education and health systems across the
6	lifespan.
7	"(vii) Promoting training, technical
8	assistance, dissemination of information,
9	supports, and services.
10	"(viii) Developing mechanisms to pro-
11	vide training and technical assistance, in-
12	cluding for-credit courses, intensive sum-
13	mer institutes, continuing education pro-
14	grams, distance based programs, and Web-
15	based information dissemination strategies.
16	"(ix) Promoting activities that sup-
17	port community-based family and indi-
18	vidual services and enable individuals with
19	autism and related developmental disabil-
20	ities to fully participate in society and
21	achieve good quality-of-life outcomes.
22	"(x) Collecting data on the outcomes
23	of training and technical assistance pro-
24	grams to meet statewide needs for the ex-

1	pansion of services to children and adults
2	with autism.
3	"(E) Amount of grants.—The amount
4	of a grant to any entity for a fiscal year under
5	this section shall be not less than \$250,000.
6	"(2) Technical assistance.—The Secretary
7	shall reserve 2 percent of the amount appropriated
8	to carry out this subsection for a fiscal year to make
9	a grant to a national organization with dem-
10	onstrated capacity for providing training and tech-
11	nical assistance to—
12	"(A) assist in national dissemination of
13	specific information, including evidence-based
14	best practices, from interdisciplinary training
15	programs, and when appropriate, other entities
16	whose findings would inform the work per-
17	formed by entities awarded grants;
18	"(B) compile and disseminate strategies
19	and materials that prove to be effective in the
20	provision of training and technical assistance so
21	that the entire network can benefit from the
22	models, materials, and practices developed in
23	individual centers;
24	"(C) assist in the coordination of activities
25	of grantees under this subsection.

1	"(D) develop a Web portal that will pro-
2	vide linkages to each of the individual training
3	initiatives and provide access to training mod-
4	ules, promising training, and technical assist
5	ance practices and other materials developed by
6	grantees;
7	"(E) serve as a research-based resource for
8	Federal and State policymakers on information
9	concerning the provision of training and tech-
10	nical assistance for the assessment, and provi-
11	sion of supports and services for, children and
12	adults with autism;
13	"(F) convene experts from multiple inter-
14	disciplinary training programs, individuals with
15	autism, and the families of such individuals to
16	discuss and make recommendations with regard
17	to training issues related to assessment, inter-
18	ventions, services, treatment, and supports for
19	children and adults with autism; and
20	"(G) undertake any other functions that
21	the Secretary determines to be appropriate.
22	"(3) Authorization of appropriations.—
23	To carry out this subsection, there are authorized to

be appropriated \$17,000,000 for fiscal year 2011

1	and such sums as may be necessary for each of fis-
2	cal years 2012 through 2015.
3	"(b) Expansion of the Number of University
4	CENTERS FOR EXCELLENCE IN DEVELOPMENTAL DIS-
5	ABILITIES EDUCATION, RESEARCH, AND SERVICE.—
6	"(1) Grants.—To provide for the establish-
7	ment of up to 4 new University Centers for Excel-
8	lence in Developmental Disabilities Education, Re-
9	search, and Service, the Secretary shall award up to
10	4 grants to institutions of higher education.
11	"(2) APPLICABLE PROVISIONS.—Except for
12	subsection (a)(3), the provisions of subsection (a)
13	shall apply with respect to grants under this sub-
14	section to the same extent and in the same manner
15	as such provisions apply with respect to grants
16	under subsection (a).
17	"(3) Priority.—In awarding grants under this
18	subsection, the Secretary shall give priority to appli-
19	cants that—
20	"(A) are minority institutions that have
21	demonstrated capacity to meet the requirements
22	of this section and provide services to individ-
23	uals with autism and their families; or
24	"(B) are located in a State with one or
25	more underserved populations.

1	"(4) Authorization of appropriations.—
2	To carry out this subsection, there is authorized to
3	be appropriated \$2,000,000 for each of fiscal years
4	2011 through 2015.
5	"(e) Definitions.—In this section:
6	"(1) The term 'autism' means an autism spec-
7	trum disorder or a related developmental disability.
8	"(2) The term 'interventions' means edu-
9	cational methods and positive behavioral support
10	strategies designed to improve or ameliorate symp-
11	toms associated with autism.
12	"(3) The term 'minority institution' has the
13	meaning given to such term in section 365 of the
14	Higher Education Act of 1965.
15	"(4) The term 'services' means services to as-
16	sist individuals with autism to live more independ-
17	ently in their communities.
18	"(5) The term 'treatments' means health serv-
19	ices, including mental health services, designed to
20	improve or ameliorate symptoms associated with au-
21	tism.
22	"(6) The term 'University Center for Excellence
23	in Developmental Disabilities Education, Research,
24	and Service' means a University Center for Excel-
25	lence in Development Disabilities Education, Re-

- through subtitle D or subsection (b).".
