AN ACT

To amend subtitle D of title I of the Developmental Disabilities Assistance and Bill of Rights Act of 2000 to provide grants and technical assistance to University Centers for Excellence in Developmental Disabilities Education, Research, and Service to improve services rendered to children and adults on the autism spectrum, and their families, and for other purposes.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Training and Research
5	for Autism Improvements Nationwide Act of 2010" or the
6	"TRAIN Act of 2010".
7	SEC. 2. UNIVERSITY CENTERS FOR EXCELLENCE INITIA-
8	TIVES ON AUTISM SPECTRUM DISORDERS.
9	(a) In General.—Subtitle D of title I of the Devel-
10	opmental Disabilities Assistance and Bill of Rights Act of
11	2000 (42 U.S.C. 15061 et seq.) is amended—
12	(1) by inserting before section 151 the fol-
13	lowing:
14	"PART 1—GENERAL GRANT PROGRAMS FOR
15	UNIVERSITY CENTERS FOR EXCELLENCE";
16	and
17	(2) by adding at the end the following:
18	"PART 2—UNIVERSITY CENTERS FOR EXCEL-
19	LENCE INITIATIVES ON AUTISM SPECTRUM
20	DISORDERS
21	"SEC. 157. AUTISM SPECTRUM DISORDERS INITIATIVE
22	GRANTS AND TECHNICAL ASSISTANCE.
23	"(a) Grants.—
24	"(1) IN GENERAL.—The Secretary shall award
25	multiyear grants for the purpose described in para-

graph (2) to University Centers for Excellence in
Developmental Disabilities Education, Research, and
Service that are funded under part 1 and engaged
in the core functions described in section 153(a)(2)
"(2) Purpose.—The purpose described in this
paragraph is to provide individuals with interdiscipli-
nary training, continuing education, technical assist-
ance, and information for the purpose of improving
services rendered to children and adults on the au-
tism spectrum, and their families, to address unmet
needs related to autism spectrum disorder. For pur-
poses of the previous sentence, individuals shall in-
clude children and adults on the autism spectrum
families of such children and adults, health profes-
sionals (including allied health professionals), and
vocational training and educational professionals.
"(3) Application requirements.—A Univer-
sity Center for Excellence in Developmental Disabil-
ities Education, Research, and Service that desires
to receive a grant under this section shall submit to
the Secretary an application—
"(A) demonstrating that the Center has
capacity to—
"(i) provide training and technical as-

sistance in evidence-based practices to

1	evaluate, and provide effective interven-
2	tions, services, treatments, and supports
3	to, children and adults on the autism spec-
4	trum and their families;
5	"(ii) provide individuals on the autism
6	spectrum, and the families of such individ-
7	uals, opportunities to advise and direct ac-
8	tivities under the grant to ensure that an
9	individual-centered, and family-centered,
10	approach is used;
11	"(iii) share and disseminate materials
12	and practices that are developed for, and
13	evaluated to be effective in, the provision
14	of training and technical assistance; and
15	"(iv) provide training, technical assist-
16	ance, interventions, services, treatments,
17	and supports under this section statewide;
18	"(B) providing assurances that the Center
19	will—
20	"(i) provide trainees under this sec-
21	tion with an appropriate balance of inter-
22	disciplinary didactic and community-based
23	experiences; and
24	"(ii) provide to the Secretary, in the
25	manner prescribed by the Secretary, data

1	regarding the number of individuals who
2	have benefitted from, and outcomes of, the
3	provision of training and technical assist-
4	ance under this section;
5	"(C) providing assurances that training,
6	technical assistance, dissemination of informa-
7	tion, and services under this section will—
8	"(i) be consistent with the goals of
9	this Act, the Americans with Disabilities
10	Act of 1990, the Individuals with Disabil-
11	ities Education Act, and the Elementary
12	and Secondary Education Act of 1965;
13	"(ii) supplement, and not supplant,
14	activities funded under this subtitle (other
15	than this section);
16	"(iii) be planned and designed with
17	the participation of individuals on the au-
18	tism spectrum and the families of such in-
19	dividuals; and
20	"(iv) be conducted in coordination
21	with relevant State agencies, institutions of
22	higher education, and service providers;
23	and
24	"(D) containing such other information
25	and assurances as the Secretary may require.

1	"(4) Amount of grants.—The amount of a
2	grant to a University Center for Excellence in Devel-
3	opmental Disabilities Education, Research, and
4	Service for a fiscal year under this section shall be
5	not less than \$250,000.
6	"(b) Technical Assistance.—The Secretary may
7	reserve not more than 2 percent of the amount appro-
8	priated to carry out this section for a fiscal year to make
9	a grant to a national organization with demonstrated ca-
10	pacity for providing training and technical assistance to—
11	"(1) assist in national dissemination of specific
12	information, including evidence-based best practices
13	from interdisciplinary training programs, and when
14	appropriate, other entities whose findings would in-
15	form the work performed by University Centers for
16	Excellence in Developmental Disabilities Education
17	Research, and Service awarded grants under this
18	section;
19	"(2) compile and disseminate strategies and
20	materials that prove to be effective in the provision
21	of training and technical assistance so that the en-
22	tire network can benefit from the models, materials,
23	and practices developed in individual centers;
24	"(3) assist in the coordination of activities of
25	grantees under this section;

- "(4) develop a (or enhance an existing) Web portal that will provide linkages to each of the individual training initiatives and provide access to training modules, promising training, and technical assistance practices and other materials developed by grantees;
 - "(5) serve as a research-based resource for Federal and State policymakers on information concerning the provision of training and technical assistance for the assessment, and provision of supports and services for, children and adults on the autism spectrum;
 - "(6) convene experts from multiple interdisciplinary training programs, individuals on the autism spectrum, and the families of such individuals to discuss and make recommendations with regard to training issues related to assessment, interventions, services, treatment, and supports for children and adults on the autism spectrum; and
- 20 "(7) undertake any other functions that the 21 Secretary determines to be appropriate.
- "(c) AUTHORIZATION OF APPROPRIATIONS.—To 23 carry out this section, there are authorized to be appro-24 priated \$17,000,000 for each of the fiscal years 2012 25 through 2016.

1 "SEC. 158. CAPACITY BUILDING GRANTS.

2	"(a) Grants.—The Secretary shall award multiyear
3	grants to not more than 4 University Centers for Excel-
4	lence in Developmental Disabilities Education, Research,
5	and Service described in paragraph (1) of section 157(a)
6	to—
7	"(1) collaborate with minority institutions to—
8	"(A) provide services described in such sec-
9	tion to individuals on the autism spectrum who
10	are from racial and ethnic minority populations
11	and to their families; and
12	"(B) conduct research and education fo-
13	cused on racial and ethnic minority populations;
14	and
15	"(2) build capacity within such institutions to
16	enable such institutions to apply to become Univer-
17	sity Centers for Excellence in Developmental Dis-

19	providing such services, research, and education.
20	"(b) Applicable Provisions.—The provisions of
21	paragraphs (2) and (3) of section 157(a) shall apply with
22	respect to grants under this section to the same extent
23	and in the same manner as such provisions apply with re-
24	spect to grants under section 157.
25	"(c) Prioritization.—In awarding grants under
26	this section, the Secretary shall give priority to applicants

that demonstrate collaboration with minority institutions 2 that— 3 "(1) have demonstrated capacity to meet the requirements of this section and provide services to in-5 dividuals on the autism spectrum and their families; 6 or"(2) are located in a State with one or more 7 8 underserved populations. 9 AUTHORIZATION OF APPROPRIATIONS.—To carry out this section, there is authorized to be appro-10 priated \$1,000,000 for each of the fiscal years 2012 12 through 2016. 13 "SEC. 159. DEFINITIONS. 14 "In this part: 15 "(1) The term 'interventions' means educational methods and positive behavioral support 16 17 strategies designed to improve or ameliorate symp-18 toms associated with autism spectrum disorder. 19 "(2) The term 'minority institution' has the 20 meaning given to such term in section 365 of the 21 Higher Education Act of 1965. 22 "(3) The term 'services' means services to as-23 sist individuals on the autism spectrum to live more

independently in their communities.
