To designate the Federal building located at 6401 Security Boulevard in Baltimore, Maryland, as the “Robert M. Ball Federal Building”.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. DESIGNATION.**

4        The Federal building located at 6401 Security Boule-  
5 vard in Baltimore, Maryland, shall be known and des-  
6 igned as the “Robert M. Ball Federal Building”.

7 **SEC. 2. REFERENCES.**

8        Any reference in a law, map, regulation, document,  
9 paper, or other record of the United States to the Federal  
10 building referred to in section 1 shall be deemed to be  
11 a reference to the “Robert M. Ball Federal Building”.

12 **SECTION 1. DESIGNATION.**

13        *The Federal building located at 6401 Security Boule-*  
14 *vard in Baltimore, Maryland, commonly known as the So-*  
15 *cial Security Administration Operations Building, shall be*  
16 *known and designated as the “Robert M. Ball Federal*  
17 *Building”.*

18 **SEC. 2. REFERENCES.**

19        *Any reference in a law, map, regulation, document,*  
20 *paper, or other record of the United States to the Federal*  
21 *building referred to in section 1 shall be deemed to be a*  
22 *reference to the “Robert M. Ball Federal Building”.*

Amend the title so as to read: “A bill to designate the Federal building located at 6401 Security Boulevard in Baltimore, Maryland, commonly known as the Social

Security Administration Operations Building, as the  
'Robert M. Ball Federal Building'.".
