Mr. OBERSTAR introduced the following bill; which was referred to the

A BILL

To make technical corrections to provisions of law enacted
by the Coast Guard Authorization Act of 2010.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TECHNICAL CORRECTIONS.**

4 Effective with the enactment of the Coast Guard Au-
5 thorization Act of 2010 (Public Law 111–281), such Act
6 is amended as follows:

7 (1) Section 208(e) is amended by striking
8 “such chapter” and inserting “chapter 5 of title 14,
9 United States Code,”.

1 (2) Section 221(a)(6)(B) is amended by insert-
2 ing open quotation marks before “(1) In such
3 amounts”.

4 (3) Section 401(d)(1) is amended by striking
5 “part” and inserting “section”.

6 (4) Section 402(a) is amended by striking
7 “Coast Guard Authorization Act for Fiscal Years
8 2010 and 2011” each place it appears and inserting
9 “Coast Guard Authorization Act of 2010”.

10 (5) Section 511(a) is amended—

11 (A) in the matter preceding the quoted
12 material, by striking “of such title” and insert-
13 ing “of title 14, United States Code,”; and

14 (B) in the quoted material, in section
15 50(a)(3)(B), by striking “stewrdship” and in-
16 serting “stewardship”.

17 (6) Section 524(a) is amended—

18 (A) in subsection (a), in the quoted matter,
19 by redesignating section 102 as section 101;
20 and

21 (B) in subsection (b), by striking the mat-
22 ter that is inside the quotation marks and in-
23 serting the following:

“101. Appeals and waivers.”.

24 (7) Section 525 is amended—

25 (A) in subsection (a)—

1 (i) in the matter preceding the quoted
2 material, by striking “further”; and

3 (ii) in the quoted material, by redesignig-
4 nating section 200 as section 199; and

5 (B) in subsection (b), by striking the mat-
6 ter that is inside the quotation marks and in-
7 serting the following:

“199. Marine Safety curriculum.”.

8 (8) Section 617(f)(3)(C) is amended by striking
9 “402(e)” and inserting “11.402(e)”.

10 (9) Section 618 is amended by striking “Great
11 Lake” and inserting “Great Lakes”.

12 (10) Section 702(a) is amended by inserting “of
13 the department in which the Coast Guard is oper-
14 ating” after “Secretary”.

15 (11) Section 703(a) is amended by inserting “of
16 the department in which the Coast Guard is oper-
17 ating” after “Secretary”.

18 (12) Section 806(c)(2)(A)(i) is amended—

19 (A) by striking “**OR FACILITIES**” and in-
20 serting “**or facilities**”; and

21 (B) by striking “**PORTS**” and inserting
22 “**ports**”.

23 (13) Section 819 is amended in the quoted mat-
24 ter by striking “(6)” and inserting “(3)”.

1 (14) Section 821(a) is amended in the quoted
2 matter in section 70125(d) by striking “[46 U.S.C.
3 70101 note]” and inserting “(46 U.S.C. 70101
4 note)”.

5 (15) Section 821(b) is amended by striking “is
6 repealed” and inserting “, and the item relating to
7 such section in the table of contents in section 1(b)
8 of such Act, are repealed”.

9 (16) Section 828(a) is amended—

10 (A) by striking “Section 701” and insert-
11 ing “Chapter 701”; and

12 (B) by striking “is amended” and inserting
13 “is further amended”.

14 (17) Section 828(c) is amended—

15 (A) in paragraph (1) by striking “is
16 amended” and inserting “is further amended”;

17 (B) in paragraph (2) by striking “is
18 amended” and inserting “is further amended”;

19 (C) by redesignating paragraphs (3) and
20 (4) as subparagraphs (A) and (B) of paragraph
21 (2), and moving such subparagraphs 2 ems to
22 the right; and

23 (D) in subparagraph (A) of paragraph (2),
24 as so redesignated, by striking the matter that

1 is inside the quotation marks and inserting the
2 following:

“Subchapter I—General”.

3 (18) Section 901(a) is amended by inserting
4 “and 12132” after “12112”.

5 (19) Section 1011(9)(B) is amended by striking
6 “3(b)(2)” and inserting “1012(b)(2)”.

7 (20) Section 1043 is amended by striking “sec-
8 tion 18,” and inserting “title 18,”.
