The previous question shall be considered as ordered on the bill and on any 8 amendment thereto to final passage without intervening motion except: (1) one hour of debate equally divided and 10 controlled by the chair and ranking minority member of the Committee on Natural Resources; (2) the amendment in the nature of a substitute printed in part A of the re-12 port of the Committee on Rules accompanying this resolution, if offered by Representative Abercrombie of Hawaii 14 15 or his designee, which shall be in order without intervention of any point of order except those arising under clause 16 9 or 10 of rule XXI, shall be considered as read, and shall 18 be separately debatable for 30 minutes equally divided and 19 controlled by the proponent and an opponent; (3) the 20 amendments to the amendment in the nature of a sub-21 stitute printed in part B of the report of the Committee 22 on Rules, each of which may be offered only by a Member 23 designed in the report, shall be in order without intervention of any point of order except those arising under clause 10 of rule XXI, shall be considered as read, and shall be

- 2 controlled by the proponent and an opponent; and (4) one
- 3 motion to recommit with or without instructions.
