Ms. MATSUI, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5019) to provide for the establishment of the Home Star Retrofit Rebate Program, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 5019) to provide for the establish-
6 ment of the Home Star Retrofit Rebate Program, and for
7 other purposes. The first reading of the bill shall be dis-

1 pensed with. All points of order against consideration of
2 the bill are waived except those arising under clause 9 or
3 10 of rule XXI. General debate shall be confined to the
4 bill and shall not exceed one hour equally divided and con-
5 trolled by the chair and ranking minority member of the
6 Committee on Energy and Commerce. After general de-
7 bate the bill shall be considered for amendment under the
8 five-minute rule. It shall be in order to consider as an
9 original bill for the purpose of amendment under the five-
10 minute rule the amendment in the nature of a substitute
11 recommended by the Committee on Energy and Commerce
12 now printed in the bill. The committee amendment in the
13 nature of a substitute shall be considered as read. All
14 points of order against the committee amendment in the
15 nature of a substitute are waived except those arising
16 under clause 10 of rule XXI. Notwithstanding clause 11
17 of rule XVIII, no amendment to the committee amend-
18 ment in the nature of a substitute shall be in order except
19 those printed in the report of the Committee on Rules ac-
20 companying this resolution. Each such amendment may
21 be offered only in the order printed in the report, may
22 be offered only by a Member designated in the report,
23 shall be considered as read, shall be debatable for the time
24 specified in the report equally divided and controlled by
25 the proponent and an opponent, shall not be subject to

1 amendment, and shall not be subject to a demand for divi-
2 sion of the question. All points of order against such
3 amendments are waived except those arising under clause
4 9 or 10 of rule XXI. At the conclusion of consideration
5 of the bill for amendment the Committee shall rise and
6 report the bill to the House with such amendments as may
7 have been adopted. The previous question shall be consid-
8 ered as ordered on the bill and amendments thereto to
9 final passage without intervening motion except one mo-
10 tion to recommit with or without instructions.

11 SEC. 2. The Chair may entertain a motion that the
12 Committee rise only if offered by the chair of the Com-
13 mittee on Energy and Commerce or his designee. The
14 Chair may not entertain a motion to strike out the enact-
15 ing words of the bill (as described in clause 9 of rule
16 XVIII).
