## RESOLUTION

Directing the Secretary of Homeland Security to transmit to the House of Representatives, not later than 14 days after the date of the adoption of this resolution, copies of documents relating to the Department of Homeland Security Intelligence Assessment titled, “Rightwing Extremism: Current Economic and Political Climate Fueling Resurgence in Radicalization and Recruitment”.

- 1 *Resolved*, That the Secretary of Homeland Security
- 2 is directed to transmit to the House of Representatives,

2 this resolution, copies of all documents relating to the De-  
3 partment of Homeland Security Intelligence Assessment  
4 titled, “Rightwing Extremism: Current Economic and Po-  
5 litical Climate Fueling Resurgence in Radicalization and  
6 Recruitment”, including—

7           (1) all records setting forth or discussing pri-  
8 vacy, civil rights, or civil liberties concerns with the  
9 Assessment;

10           (2) all records setting forth or discussing proce-  
11 dures for approval of the Assessment;

12           (3) all records setting forth or discussing poli-  
13 cies, procedures, or guidelines for disseminating the  
14 Assessment to stakeholders outside of the Depart-  
15 ment of Homeland Security, including a list of the  
16 recipients of the Assessment;

17           (4) all records indicating or discussing the dis-  
18 semination of the Assessment without final concur-  
19 rence or approval by the Office of Civil Rights and  
20 Civil Liberties of the Department of Homeland Se-  
21 curity;

22           (5) all records of communication between the  
23 Department of Homeland Security and nongovern-  
24 mental organizations regarding the Assessment; and

1           (6) all records indicating whether and how the  
2 matters referred to this resolution were commu-  
3 nicated to the Acting Under Secretary of Intelligence  
4 and Analysis of the Department of Homeland Secu-  
5 rity and the Secretary of Homeland Security, before,  
6 during, and after dissemination of the Assessment.
