## RESOLUTION

Requesting that the President transmit to the House of Representatives all information in his possession relating to specific communications with Chrysler LLC (“Chrysler”).

- 1 *Resolved*, That the House of Representatives requests
- 2 the President to transmit to the House of Representatives,

1 not later than 14 days after the date of the adoption of  
2 this resolution, copies of any portions of all documents,  
3 records, and communications in his possession referring  
4 or relating to scheduled plant closings of Chrysler LLC  
5 (hereafter in this resolution referred to as “Chrysler”)—

6 (1) that were discussed as part of the required  
7 February 17, 2009, Chrysler viability determination  
8 filing;

9 (2) that were identified in the March 30, 2009,  
10 announcement by the Administration;

11 (3) that were prepared for the 11:30 a.m. con-  
12 ference call on April 30, 2009, between members of  
13 the President’s Auto Task Force (hereafter in this  
14 resolution referred to as the “Task Force”) and  
15 Members of Congress, including transcripts;

16 (4) revealing the President’s knowledge regard-  
17 ing such plant closings prior to March 30, 2009;

18 (5) included in Chrysler’s April 30, 2009, bank-  
19 ruptcy filing in New York;

20 (6) that identifies who was aware of such plant  
21 closings that would be announced prior to April 30,  
22 2009, among the Administration, Chrysler, the Task  
23 Force, and the International Union, United Auto-  
24 mobile, Aerospace and Agricultural Implement

1 Workers of America (also referred to as the  
2 “UAW”); and

3 (7) the interaction and procedures for identi-  
4 fying the 789 Chrysler dealerships in the United  
5 States scheduled for closure, as announced on May  
6 14, 2009.
