RESOLUTION

Directing the Secretary of Defense to transmit to the House of Representatives the fiscal year 2010 30-year shipbuilding plan relating to the long-term shipbuilding strategy of the Department of Defense, as required by section 231 of title 10, United States Code.

1 *Resolved*, That the Secretary of Defense is directed
 2 to transmit to the House of Representatives, not later
 3 than 14 days after the date of the adoption of this resolu-
 4 tion, all documents, including telephone and electronic
 5 mail records, logs and calendars, and records of internal
 6 discussions in the possession of the Secretary and pro-
 7 duced by the Secretary of the Navy or the Director of the
 8 Office of Management and Budget relating to the fol-
 9 lowing:

10 (1) The fiscal year 2010 30-year shipbuilding
 11 plan relating to the long-term shipbuilding strategy
 12 of the Department of Defense, as required by section
 13 231 of title 10, United States Code.

14 (2) The certification statement of the Secretary
 15 required in the plan that both the budget for this
 16 fiscal year and the future-years defense program re-
 17 lating to the construction of naval vessels are at a
 18 level that is sufficient for the procurement as de-
 19 scribed in the 30-year shipbuilding plan.

20 *That the Secretary of Defense is directed to transmit to the*
 21 *House of Representatives, not later than September 15,*
 22 *2009—*

23 (1) *the fiscal year 2010 30-year shipbuilding*
 24 *plan relating to the long-term shipbuilding strategy of*
