## **RESOLUTION**

Providing for consideration of the bill (H.R. 3170) making appropriations for financial services and general government for the fiscal year ending September 30, 2010, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 3170) making appropriations for

- 1 financial services and general government for the fiscal
- 2 year ending September 30, 2010, and for other purposes.
- 3 The first reading of the bill shall be dispensed with. All
- 4 points of order against consideration of the bill are waived
- 5 except those arising under clause 9 or 10 of rule XXI.
- 6 General debate shall be confined to the bill and shall not
- 7 exceed one hour equally divided and controlled by the chair
- 8 and ranking minority member of the Committee on Appro-
- 9 priations. After general debate the bill shall be considered
- 10 for amendment under the five-minute rule. The bill shall
- 11 be considered as read through page 145, line 11. Points
- 12 of order against provisions in the bill for failure to comply
- 13 with clause 2 of rule XXI are waived. Notwithstanding
- 14 clause 11 of rule XVIII, except as provided in section 2,
- 15 no amendment shall be in order except the amendments
- 16 printed in the report of the Committee on Rules accom-
- 17 panying this resolution. Each such amendment may be of-
- 18 fered only in the order printed in the report, may be of-
- 19 fered only by a Member designated in the report, shall
- 20 be considered as read, shall be debatable for 10 minutes
- 21 equally divided and controlled by the proponent and an
- 22 opponent, and shall not be subject to a demand for divi-
- 23 sion of the question in the House or in the Committee
- 24 of the Whole. All points of order against such amendments
- 25 are waived except those arising under clause 9 or 10 of

- 1 rule XXI. At the conclusion of consideration of the bill
- 2 for amendment the Committee shall rise and report the
- 3 bill to the House with such amendments as may have been
- 4 adopted. In the case of sundry amendments reported from
- 5 the Committee, the question of their adoption shall be put
- 6 to the House en gros and without division of the question.
- 7 The previous question shall be considered as ordered on
- 8 the bill and amendments thereto to final passage without
- 9 intervening motion except one motion to recommit with
- 10 or without instructions.
- 11 Sec. 2. After disposition of the amendments specified
- 12 in the first section of this resolution, the chair and ranking
- 13 minority member of the Committee on Appropriations or
- 14 their designees each may offer one pro forma amendment
- 15 to the bill for the purpose of debate, which shall be con-
- 16 trolled by the proponent.
- 17 Sec. 3. The Chair may entertain a motion that the
- 18 Committee rise only if offered by the chair of the Com-
- 19 mittee on Appropriations or his designee. The Chair may
- 20 not entertain a motion to strike out the enacting words
- 21 of the bill (as described in clause 9 of rule XVIII).
- Sec. 4. During consideration of H.R. 3170, the Chair
- 23 may reduce to two minutes the minimum time for elec-
- 24 tronic voting under clause 6 of rule XVIII and clauses 8
- 25 and 9 of rule XX.
