Requesting the President, and directing the Secretary of Health and Human Services, to transmit to the House of Representatives copies of documents, records, and communications in their possession relating to certain agreements regarding health care reform.

- 1 *Resolved*, That the House of Representatives requests
- 2 the President, and directs the Secretary of Health and
- 3 Human Services, to transmit to the House of Representa-

1 tives, not later than 14 days after the date of the adoption
2 of this resolution, copies of each portion of any document,
3 record, or communication (including telephone and elec-
4 tronic mail records, logs and calendars, and records of in-
5 ternal discussions) in the possession of the President or
6 Secretary, respectively, referring or relating to—

7 (1) any written or verbal agreement that—

8 (A) relates to any of the following bills in
9 the 111th Congress (or any proposed change
10 thereto): H.R. 3200, H.R. 3590, H.R. 3961,
11 H.R. 3962 , S. 1679, or S. 1796; and

12 (B) is entered into on or after January 20,
13 2009, between an individual serving in an office
14 or position in the White House or the Depart-
15 ment of Health and Human Services and any
16 other person;

17 (2) negotiations relating to an agreement de-
18 scribed in paragraph (1), the name or title of any
19 individual described in paragraph (1)(B) who par-
20 ticipated in decisionmaking during such negotia-
21 tions, the date of any meeting held as part of such
22 negotiations, or the identity of any participant in
23 any such meeting;

24 (3) any such negotiations with the Advanced
25 Medical Technology Association, the American Med-

1 ical Association, America's Health Insurance Plans,
2 the Pharmaceutical Research and Manufacturers of
3 America, the American Hospital Association, or the
4 Service Employees International Union regarding
5 decreasing by 1.5 percentage points the annual
6 health care spending growth rate or policy proposals
7 to accomplish this goal; or

8 (4) implementation of an agreement described
9 in paragraph (1).
