A BILL

To authorize National Mall Liberty Fund D.C. to establish a memorial on Federal land in the District of Columbia to honor free persons and slaves who fought for independence, liberty, and justice for all during the American Revolution.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “National Liberty Me-
3 morial Act”.

4 **SEC. 2. FINDING.**

5 **SECTION 1. FINDING.**

6 Congress finds that the contributions of free persons
7 and slaves who fought during the American Revolution
8 were of preeminent historical and lasting significance to
9 the United States, as required by section 8908(b)(1) of
10 title 40, United States Code.

11 **SEC. 3 2. DEFINITIONS.**

12 In this Act:

13 (1) FEDERAL LAND.—

14 (A) IN GENERAL.—The term “Federal
15 land” means the parcel of land—

16 (i) identified as “Area I”; and

17 (ii) depicted on the map numbered
18 ~~869/86501 and dated May 1, 1986.~~ *869/*
19 *86501B and dated June 24, 2003.*

20 (B) EXCLUSION.—The term “Federal
21 land” does not include the Reserve (as defined
22 in section 8902(a) of title 40, United States
23 Code).

24 (2) MEMORIAL.—The term “memorial” means
25 the memorial authorized to be established under sec-
26 tion ~~4(a)~~3(a).

1 **SEC. 4. THE NATIONAL LIBERTY MEMORIAL.**

2 **SEC. 3. MEMORIAL AUTHORIZATION.**

3 (a) AUTHORIZATION.—In accordance with sub-
4 sections (b) and (c), National Mall Liberty Fund D.C.
5 may establish a memorial on Federal land in the District
6 of Columbia to honor the more than 5,000 courageous
7 slaves and free Black persons who served as soldiers and
8 sailors or provided civilian assistance during the American
9 Revolution.

10 (b) PROHIBITION ON USE OF FEDERAL FUNDS.—
11 National Mall Liberty Fund D.C. may not use Federal
12 funds to establish the memorial.

13 (c) APPLICABLE LAW.—National Mall Liberty Fund
14 D.C. shall establish the memorial in accordance with chap-
15 ter 89 of title 40, United States Code.

16 **SEC. 5 4. REPEAL OF JOINT RESOLUTIONS.**

17 Public Law 99–558 (110 Stat. 3144) and Public Law
18 100–265 (102 Stat. 39) are repealed.
