A BILL

To amend title 49, United States Code, to authorize appropriations for the National Transportation Safety Board for fiscal years 2010 through 2014, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “National Transpor-
3 tation Safety Board Reauthorization Act of 2009”.

4 **SEC. 2. AUTHORIZATION OF APPROPRIATIONS.**

5 (a) **IN GENERAL.**—Section 1118(a) of title 49,
6 United States Code, is amended to read as follows:

7 “(a) **IN GENERAL.**—There are authorized to be ap-
8 propriated for the purposes of this chapter \$100,000,000
9 for fiscal year 2010, \$105,000,000 for fiscal year 2011,
10 \$112,000,000 for fiscal year 2012, \$118,000,000 for fis-
11 cal year 2013, and \$124,000,000 for fiscal year 2014.
12 Such sums shall remain available until expended.”.

13 (b) **FEES, REFUNDS, REIMBURSEMENTS, AND AD-
14 VANCES.**—Section 1118(e) of such title is amended to read
15 as follows:

16 “(c) **FEES, REFUNDS, REIMBURSEMENTS, AND AD-
17 VANCES.**—

18 “(1) **IN GENERAL.**—The Board may impose
19 and collect such fees, refunds, reimbursements, and
20 advancees as it determines to be appropriate for ac-
21 tivities, services, and facilities provided by or
22 through the Board.

23 “(2) **RECEIPTS CREDITED AS OFFSETTING COL-
24LECTIONS.**—Notwithstanding section 3302 of title
25 31, any fee, refund, reimbursement, or advancee col-
26 lected under this subsection—

1 “(A) shall be credited as offsetting collec-
2 tions to the account that finances the activities,
3 services, or facilities for which the fee, refund,
4 reimbursement, or advance is associated;

5 “(B) shall be available for expenditure only
6 to pay the costs of activities, services, or facili-
7 ties for which the fee, refund, reimbursement,
8 or advance is associated; and

9 “(C) shall remain available until expended.

10 “(3) RECORD.—The Board shall maintain an
11 annual record of collections received under para-
12 graph (2).

13 “(4) REFUNDS.—The Board may refund any
14 fee or advance paid by mistake or any amount paid
15 in excess of that required.”.

25 Board, may publicly disclose records related to an ongoing

1 Board investigation, and such records shall be exempt
2 from disclosure under section 552(b)(3) of title 5. Not-
3 withstanding the preceding sentence, the Board may make
4 public specific records relevant to the investigation, release
5 of which in the Board's judgment is necessary to promote
6 transportation safety—

7 “(A) if the Board holds a public hearing on the
8 accident or incident, at the time of the hearing;

9 “(B) if the Board does not hold a public hear-
10 ing, at the time the Board determines that substan-
11 tial portions of the underlying factual reports on the
12 accident or incident, and supporting evidence, will be
13 placed in the public docket; or

14 “(C) if the Board determines during an ongoing
15 investigation or study that circumstances warrant
16 disclosure of specific factual material and that such
17 material need be placed in the public docket to facili-
18 tate dialogue with other agencies or instrumental-
19 ies, regulatory bodies, industry or industry groups,
20 or Congress.

21 “(2) This subsection does not prevent the Board from
22 referring at any time to evidence from an ongoing inves-
23 tigation in making safety recommendations.

24 “(3) In this subsection, the term 'ongoing investiga-
25 tion' means that period beginning at the time the Board

1 is notified of an accident or incident and ending when the
2 Board issues a final report or brief, or determines to close
3 an investigation without issuing a report or brief.”.
