A BILL

To reauthorize the Coral Reef Conservation Act of 2000, and for other purposes.

SEC. 2. AMENDMENT OF CORAL REEF CONSERVATION ACT

- 3 Except as otherwise expressly provided, whenever in
- 4 this Act an amendment or repeal is expressed in terms
- 5 of an amendment to or repeal of a section or other provi-
- 6 sion, the reference shall be considered to be made to a
- 7 section or other provision of the Coral Reef Conservation
- 8 Act of 2000 (16 U.S.C. 6401 et seq.).
- 9 SEC. 3. PURPOSES.
- Section 202 (16 U.S.C. 6401) is amended to read as
- 11 follows:
- 12 "SEC. 202. PURPOSES.
- "The purposes of this Act are—
- 14 "(1) to preserve, sustain, and restore the condi-
- tion of coral reef ecosystems;

1	"(2) to promote the wise management and sus-
2	tainable use of coral reef ecosystems to benefit local
3	communities, the Nation, and the world;
4	"(3) to develop sound scientific information on
5	the condition of coral reef ecosystems and the
6	threats to such ecosystems;
7	"(4) to assist in the preservation of coral reef
8	ecosystems by supporting conservation programs, in-
9	cluding projects that involve affected local commu-
10	nities and nongovernmental organizations;
11	"(5) to provide financial resources for those
12	programs and projects;
13	"(6) to establish a formal mechanism for col-
14	lecting and allocating monetary donations from the
15	private sector to be used for coral reef conservation
16	projects; and
17	"(7) to provide mechanisms to prevent and
18	minimize damage to coral reefs.".
19	SEC. 4. NATIONAL CORAL REEF ACTION STRATEGY.
20	Section 203 (16 U.S.C. 6402) is amended to read as
21	follows:
22	"(a) In General.—Not later than 180 days after
23	the date of the enactment of the Coral Reef Conservation
24	Amendments Act of 2009, the Secretary shall submit to

25 the Senate Committee on Commerce, Science, and Trans-

- portation and to the House of Representatives Committee on Natural Resources and publish in the Federal Register 3 a national coral reef ecosystem action strategy, consistent 4 with the purposes of this title. The Secretary shall periodi-5 cally review and revise the strategy as necessary. In devel-6 oping this national strategy, the Secretary may consult the 7 Coral Reef Task Force established under Executive Order 8 13089 (June 11, 1998). 9 "(b) Goals and Objectives.—The action strategy shall include a statement of goals and objectives as well 10 11 as an implementation plan, including a description of the 12 funds obligated each fiscal year to advance coral reef conservation. The action strategy and implementation plan shall include discussion of— 14 "(1) coastal uses and management, including 15 16 land-based sources of pollution; 17 "(2) climate change; 18 "(3) water and air quality; 19 "(4) mapping and information management; "(5) research, monitoring, and assessment; 20 21 "(6) international and regional issues;
- 23 "(8) local strategies developed by the States or

"(7) outreach and education;

- 24 Federal agencies, including regional fishery manage-
- 25 ment councils; and

1	"(9) conservation.".
2	SEC. 5. CORAL REEF CONSERVATION PROGRAM.
3	(a) In General.—Section 204 (16 U.S.C. 6403) is
4	amended—
5	(1) by striking "Secretary, through the Admin-
6	istrator and" in subsection (a) and inserting "Sec-
7	retary,";
8	(2) by striking subsection (c) and inserting the
9	following:
10	"(c) Eligibility.—Any natural resource manage-
11	ment authority of a State or other government authority
12	with jurisdiction over coral reef ecosystems, or whose ac-
13	tivities directly or indirectly affect coral reef ecosystems,

11	not approve a project proposal under this section unless
12	the project is consistent with the coral reef action strategy
13	under section 203 and will enhance the conservation of

16	which promote sustainable development and ensure
17	effective, long-term conservation of coral reef eco-
18	systems and biodiversity;
19	"(2) addressing the conflicts arising from the

21	from the use of corals, species associated with coral
22	reef ecosystems, and coral products;
23	"(3) enhancing compliance with laws that pro-
24	hibit or regulate the taking of coral products or spe-

3	"(4) developing sound scientific information on
4	the condition of coral reef ecosystems or the threats
5	to such ecosystems and their biodiversity, including
6	factors that cause coral disease, ocean acidification
7	and bleaching;
8	"(5) promoting and assisting the implementa-
9	tion of cooperative coral reef ecosystem conservation
10	projects that involve affected local communities, non-
11	governmental organizations, or others in the private
12	sector;
13	"(6) increasing public knowledge and awareness
14	of coral reef ecosystems and issues regarding their
15	long-term conservation, including how they function
16	to protect coastal communities;
17	"(7) mapping the location, distribution, and
18	biodiversity of coral reef ecosystems;
19	"(8) developing and implementing techniques to
20	monitor and assess the status and condition of coral
21	reef ecosystems and biodiversity;
22	"(9) developing and implementing cost-effective

methods to restore degraded coral reef ecosystems

and biodiversity;

1 "(10) responding to, or taking action to help 2 mitigate the effects of, coral disease, ocean acidifica-3 tion, and bleaching events; "(11) promoting activities designed to prevent 4 5 or minimize damage to coral reef ecosystems, includ-6 ing the promotion of ecologically sound navigation 7 and anchorages; or "(12) promoting and assisting entities to work 8 9 with local communities, and all appropriate govern-10 mental and nongovernmental organizations, to sup-11 port community-based planning and management 12 initiatives for the protection of coral reef systems."; 13 and 14 (6) by striking "coral reefs" in subsection (j) and inserting "coral reef ecosystems". 15 16 (b) Conforming Amendments.—Subsections (b), 17 (d), (e), (f), (h), (i), and (j) of section 204 (16 U.S.C. 6403) are each amended by striking "Administrator" each 18 place it appears and inserting "Secretary". 19 20 SEC. 6. 10	"(b) Cooperative Agreements.—In addition to
11	the general authority provided by subsection (a), the Sec-

"(3) conduct public education and awareness 1 2 programs for policy makers, resource managers, and the general public on coral reef ecosystems, best 3 4 practices for coral reef and ecosystem management 5 and conservation, their value, and threats to their 6 sustainability. "(c) Use of Other Agencies' Resources.—For 7 8 purposes related to the conservation, preservation, protection, restoration, or replacement of coral reefs or coral reef 10 ecosystems and the enforcement of this title, the Secretary is authorized to use, with their consent and with or with-12 out reimbursement, the land, services, equipment, personnel, and facilities of any Department, agency, or in-13 14 strumentality of the United States, or of any State, local 15 government, tribal government, Territory or possession, or of any political subdivision thereof, or of any foreign gov-16 17 ernment or international organization.

18 "(d) Authority To Utilize Grant Funds.—

- "(1) Except as provided in paragraph (2), the Secretary may apply for, accept, and obligate research grant funding from any Federal source operating competitive grant programs where such funding furthers the purpose of this title.
- 24 "(2) The Secretary may not apply for, accept, 25 or obligate any grant funding under paragraph (1)

- for which the granting agency lacks authority to
- 2 grant funds to Federal agencies, or for any purpose
- or subject to conditions that are prohibited by law
- 4 or regulation.
- 5 "(3) Appropriated funds may be used to satisfy
- 6 a requirement to match grant funds with recipient
- agency funds, except that no grant may be accepted
- 8 that requires a commitment in advance of appropria-
- 9 tions.
- 10 "(4) Funds received from grants shall be depos-
- 11 ited in the National Oceanic and Atmospheric Ad-
- ministration account for the purpose for which the
- grant was awarded.
- 14 "(e) Transfer of Funds.—Under an agreement
- 15 entered into pursuant to subsection (a), and subject to the
- 16 availability of funds, the Secretary may transfer funds to,
- 17 and may accept transfers of funds from, Federal agencies,
- 18 instrumentalities and laboratories, State and local govern-
- 19 ments, Indian tribes (as defined in section 4 of the Indian
- 20 Self-Determination and Educational Assistance Act (25
- 21 U.S.C. 450(b)), organizations and associations rep-
- 22 resenting Native Americans, native Hawaiians, and Native
- 23 Pacific Islanders, educational institutions, nonprofit orga-
- 24 nizations, commercial organizations, and other public and
- 25 private persons or entities, except that no more than 5

4 SEC. 8. EMERGENCY ASSISTANCE.

- 5 Section 207 (formerly 16 U.S.C. 6405), as redesig-
- 6 nated by section 7 of this Act, is amended to read as fol-
- 7 lows:

8 "SEC. 207. EMERGENCY ASSISTANCE.

- 9 "The Secretary, in cooperation with the Federal
- 10 Emergency Management Agency, as appropriate, may pro-
- 11 vide assistance to any State, local, or territorial govern-
- 12 ment agency with jurisdiction over coral reef ecosystems
- 13 to address any unforeseen or disaster-related circumstance
- 14 pertaining to coral reef ecosystems.".

15 SEC. 9. NATIONAL PROGRAM.

- Section 208 (formerly 16 U.S.C. 6406), as redesig-
- 17 nated by section 7 of this Act, is amended to read as fol-
- 18 lows:

19 "SEC. 208. NATIONAL PROGRAM.

- 20 "(a) In General.—Subject to the availability of ap-
- 21 propriations, the Secretary may conduct activities, includ-
- 22 ing with local, State, regional, or international programs
- 23 and partners, as appropriate, to conserve coral reef eco-
- 24 systems, that are consistent with this title, the National
- 25 Marine Sanctuaries Act, the Coastal Zone Management

1	Act of 1972, the Magnuson-Stevens Fishery Conservation
2	and Management Act, the Endangered Species Act of
3	1973, and the Marine Mammal Protection Act of 1972.
4	"(b) Authorized Activities.—Activities author-
5	ized under subsection (a) include—
6	"(1) mapping, monitoring, assessment, restora-
7	tion, socioeconomic and scientific research that ben-
8	efit the understanding, sustainable use, biodiversity,
9	and long-term conservation of coral reef ecosystems;
10	"(2) enhancing public awareness, education, un-
11	derstanding, and appreciation of coral reef eco-
12	systems;
13	"(3) removing, and providing assistance to
14	States in removing, abandoned fishing gear, marine
15	debris, and abandoned vessels from coral reef eco-
16	systems to conserve living marine resources;
17	"(4) responding to incidents and events that
18	threaten and damage coral reef ecosystems;
19	"(5) conservation and management of coral reef
20	ecosystems;
21	"(6) centrally archiving, managing, and distrib-
22	uting data sets and providing coral reef ecosystem
23	assessments and services to the general public with
24	local, regional, or international programs and part-

ners; and

1	"(7) activities designed to prevent or minimize
2	damage to coral reef ecosystems, including those ac-
3	tivities described in section 212 of this title.
4	"(c) Data Archive, Access, and Availability.—
5	The Secretary, in coordination with similar efforts at other
6	Departments and agencies shall provide for the long-term
7	stewardship of environmental data, products, and informa-
8	tion via data processing, storage, and archive facilities
9	pursuant to this title. The Secretary may—
10	"(1) archive environmental data collected by
11	Federal, State, local agencies, and tribal organiza-
12	tions and federally funded research;
13	"(2) promote widespread availability and dis-
14	semination of environmental data and information
15	through full and open access and exchange to the
16	greatest extent possible, including in electronic for-
17	mat on the Internet;
18	"(3) develop standards, protocols, and proce-
19	dures for sharing Federal data with State and local
20	government programs and the private sector or aca-
21	demia; and
22	"(4) develop metadata standards for coral reef
23	ecosystems in accordance with Federal Geographic
24	Data Committee guidelines

1 "(d) Emergency Response, Stabilization, and 2 Restoration.—

3 "(1) Establishment of account.—The Sec-4 retary shall establish an account (to be called the 5 Emergency Response, Stabilization, and Restoration 6 Account) in the Damage Assessment Restoration 7 Revolving Fund established by the Department of 8 Commerce Appropriations Act, 1991 (33 U.S.C. 9 2706 note), for implementation of this subsection for 10 emergency actions. Amounts appropriated for the 11 Account under section 219, and funds authorized by 12 sections 213(d)(1)(C)(ii) and 214(f)(3)(B), shall be 13 deposited into the Account and made available for 14 use by the Secretary as specified in sections 213 and 15 214.

"(2) Deposit and investment of certain funds.— Any amounts received by the United States pursuant to sections 213(d)(1)(C)(ii) and 212(f)(3)(B) shall be deposited into the Emergency Response, Stabilization and Restoration Account established under paragraph (1). The Secretary of Commerce may request the Secretary of the Treasury to invest such portion of the Damage Assessment Restoration Revolving Fund as is not, in the judgment of the Secretary of Commerce, required to

1 meet the current needs of the fund. Such invest-2 ments shall be made by the Secretary of the Treas-3 ury in public debt securities, with maturities suitable to the needs of the fund, as determined by the Sec-5 retary of Commerce and bearing interest at rates de-6 termined by the Secretary of the Treasury, taking 7 into consideration current market yields on out-8 standing marketable obligations of the United States 9 of comparable maturity. Interest earned by such in-10 vestments shall be available for use by the Secretary 11 without further appropriation and remain available 12 until expended.".

13 SEC. 10. STUDY OF TRADE IN CORALS.

- 14 (a) IN GENERAL.—The Secretary of Commerce, in 15 consultation with the Secretary of the Interior, shall con-16 duct a study on the economic, social, and environmental 17 values and impacts of the United States market in corals 18 and coral products.
- 19 (b) Contents.—The study shall—
- 20 (1) assess the economic and other values of the 21 United States market in coral and coral products, 22 including import and export trade;
- 23 (2) identify primary coral species used in the 24 coral and coral product trade and locations of wild 25 harvest;

1	(3) assess the environmental impacts associated
2	with wild harvest of coral;
3	(4) assess the effectiveness of current public
4	and private programs aimed at promoting conserva-
5	tion in the coral and coral product trade;
6	(5) identify economic and other incentives for
7	coral reef conservation as part of the coral and cora
8	product trade; and
9	(6) identify additional actions, if necessary, to
10	ensure that the United States market in coral and
11	coral products does not contribute to the degrada-
12	tion of coral reef ecosystems.
13	(c) Report.—Not later than 30 months after the
14	date of enactment of this Act, the Secretary shall submit
15	to the Senate Committee on Commerce, Science, and
16	Transportation and the House of Representatives Com-
17	mittee on Natural Resources a report of the study.
18	(d) Authorization of Appropriations.—There
19	are authorized to be appropriated to the Secretary to carry
20	out this section \$100,000.
21	SEC. 11. INTERNATIONAL CORAL REEF CONSERVATION AC

The Secretary shall periodically review and revise this strategy as necessary.

- "(2) CONTENTS.—The strategy developed by the Secretary under paragraph (1) shall—
 - "(A) identify coral reef ecosystems throughout the world that are of high value for United States marine resources, that support high-seas resources of importance to the United States such as fisheries, or that support other interests of the United States;
 - "(B) summarize existing activities by Federal agencies and entities described in subsection (a)(2) to address the conservation of coral reef ecosystems identified pursuant to subparagraph (A);

1	"(C) establish goals, objectives, and spe-
2	cific targets for conservation of priority inter-
3	national coral reef ecosystems;
4	"(D) describe appropriate activities to
5	achieve the goals and targets for international
6	coral reef conservation, in particular those that
7	leverage activities already conducted under this
8	Act;
9	"(E) develop a plan to coordinate imple-
10	mentation of the strategy with entities de-
11	scribed in subsection (a)(2) in order to leverage
12	current activities under this Act and other con-
13	servation efforts globally;
14	"(F) identify appropriate partnerships
15	grants, or other funding and technical assist-
16	ance mechanisms to carry out the strategy; and
17	"(G) develop criteria for prioritizing part-
18	nerships under subsection (c).
19	"(c) International Coral Reef Ecosystem
20	Partnerships.—
21	"(1) IN GENERAL.—The Secretary shall estab-
22	lish an international coral reef ecosystem partner-
23	ship program to provide support, including funding
24	and technical assistance, for activities that imple-

- 1 ment the strategy developed pursuant to subsection 2 (b).
- "(2) MECHANISMS.—The Secretary shall provide such support through existing authorities, working in collaboration with the entities described in subsection (a)(2).
 - "(3) AGREEMENTS.—The Secretary may execute and perform such contracts, leases, grants, cooperative agreements, or other transactions as may be necessary to carry out the purposes of this section.
 - "(4) Transfer of funds.—To implement this section and subject to the availability of funds, the Secretary may transfer funds to a foreign government or international organization, and may accept transfers of funds from such entities, except that no more than 5 percent of funds appropriated to carry out this section may be transferred.
 - "(5) CRITERIA FOR APPROVAL.—The Secretary may not approve a partnership proposal under this section unless the partnership is consistent with the international coral reef conservation strategy developed pursuant to subsection (b), and meets the criteria specified in that strategy.".

In assessing such penalty, the Secretary may also consider information related to the ability of the violator to pay.

"(2) Permit sanctions.—For any person subject to the jurisdiction of the United States who has been issued or has applied for a permit under this title, and who violates this title or any regulation or permit issued under this title, the Secretary may deny, suspend, amend, or revoke in whole or in part any such permit. For any person who has failed to pay or defaulted on a payment agreement of any civil penalty or criminal fine or liability assessed pursuant to any natural resource law administered by the Secretary, the Secretary may deny, suspend,

amend or revoke in whole or in part any permit issued or applied for under this title.

> "(3) Imposition of civil judicial pen-ALTIES.—Any person who violates any provision of this title, any regulation promulgated or permit issued thereunder, shall be subject to a civil judicial penalty not to exceed \$250,000 for each such violation. Each day of a continuing violation shall constitute a separate violation. The Attorney General, upon the request of the Secretary, may commence a civil action in an appropriate district court of the United States, and such court shall have jurisdiction to award civil penalties and such other relief as justice may require. In determining the amount of a civil penalty, the court shall take into account the nature, circumstances, extent, and gravity of the prohibited acts committed and, with respect to the violator, the degree of culpability, any history of prior violations, and such other matters as justice may require. In imposing such penalty, the district court may also consider information related to the ability of the violator to pay.

"(4) Notice.—No penalty or permit sanction shall be assessed under this subsection until after

the person charged has been given notice and an opportunity for a hearing.

"(5) IN REM JURISDICTION.—A vessel used in violating this title, any regulation promulgated under this title, or any permit issued under this title, shall be liable in rem for any civil penalty assessed for such violation. Such penalty shall constitute a maritime lien on the vessel and may be recovered in an action in rem in the district court of the United States having jurisdiction over the vessel.

"(6) Collection of Penalties.—If any person fails to pay an assessment of a civil penalty under this section after it has become a final and unappealable order, or after the appropriate court has entered final judgment in favor of the Secretary, the Secretary shall refer the matter to the Attorney General, who shall recover the amount assessed in any appropriate district court of the United States (plus interest at current prevailing rates from the date of the final order). In such action, the validity and appropriateness of the final order imposing the civil penalty shall not be subject to review. Any person who fails to pay, on a timely basis, the amount of an assessment of a civil penalty shall be required to pay, in addition to such amount and interest, at-

torney's fees and costs for collection proceedings and a quarterly nonpayment penalty for each quarter during which such failure to pay persists. Such nonpayment penalty shall be in an amount equal to 20 percent of the aggregate amount of such person's penalties and nonpayment penalties that are unpaid as of the beginning of such quarter.

"(7) Compromise or other action by Sec-Retary.—The Secretary may compromise, modify, or remit, with or without conditions, any civil administrative penalty or permit sanction which is or may be imposed under this section and that has not been referred to the Attorney General for further enforcement action.

"(8) Jurisidiction.—The several district courts of the United States shall have jurisdiction over any actions brought by the United States arising under this section. For the purpose of this section, American Samoa shall be included within the judicial district of the District Court of the United States for the District of Hawaii. Each violation shall be a separate offense and the offense shall be deemed to have been committed not only in the district where the violation first occurred, but also in any other district as authorized by law.

"(B) Any property, real or personal, used or intended to be used, in any manner, to commit or facilitate the commission of a violation of this title, including, without limitation, any vessel (including the vessel's equipment, stores, catch and cargo), vehicle, aircraft, or other means of transportation.

"(3) APPLICATION OF THE CUSTOMS LAWS.—
All provisions of law relating to seizure, summary
judgment, and judicial forfeiture and condemnation
for violation of the customs laws, the disposition of
the property forfeited or condemned or the proceeds
from the sale thereof, the remission or mitigation of
such forfeitures, and the compromise of claims shall
apply to seizures and forfeitures incurred, or alleged
to have been incurred, under the provisions of this

1 title, insofar as applicable and not inconsistent with 2 the provisions hereof. 14	enforcement activities;
15	"(D) be used to conduct research on tech-
16	niques to stabilize and restore coral reefs;
17	"(E) be used to conduct activities that pre-
18	vent or reduce the likelihood of future damage
19	to coral reefs;
20	"(F) be used to stabilize, restore or other-
21	wise manage any other coral reef; or
22	"(G) be used to pay a reward to any per-
23	son who furnishes information leading to an as-
24	sessment of a civil penalty, or to a forfeiture of

property, for a violation of this title or any regulation promulgated under this title.

"(g) Criminal Enforcement.—

- "(1) Any person (other than a foreign government or any entity of such government) who knowingly commits any act prohibited by section 212(c) of this title shall be imprisoned for not more than 5 years and shall be fined not more than \$500,000 for individuals or \$1,000,000 for an organization; except that if in the commission of any such offense the individual uses a dangerous weapon, engages in conduct that causes bodily injury to any officer authorized to enforce the provisions of this title, or places any such officer in fear of imminent bodily injury, the maximum term of imprisonment is not more than 10 years.
- "(2) Any person (other than a foreign government or any entity of such government) who knowingly violates subsection (b), (d), or (e) of section 212 shall be fined under title 18, United States Code, or imprisoned not more than 5 years or both.
- "(3) Any person (other than a foreign government or any entity of such government) who violates subsection (b), (d), or (e) of section 212, and who, in the exercise of due care should know that such

1 person's conduct violates subsection (b), (d), or (e)

of section 212, shall be fined under title 18, United

3 States Code, or imprisoned not more than 1 year, or

4 both.

"(4) The several district courts of the United States shall have jurisdiction over any actions brought by the United States arising under this subsection. For the purpose of this subsection, American Samoa shall be included within the judicial district of the District Court of the United States for the District of Hawaii. Each violation shall be a separate offense and the offense shall be deemed to have been committed not only in the district where the violation first occurred, but also in any other district as authorized by law. Any offenses not committed in any district are subject to the venue provisions of section 3238 of title 18, United States Code.

 - "(6) CORAL REEF ECOSYSTEM.—The term 'coral reef ecosystem' means the system of coral reefs and geographically associated species, habitats, and environment, including any adjacent or associated mangroves and seagrass habitats, and the processes that control its dynamics.
