3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Broadband Oppor-5 tunity and Affordability Act".

6 SEC. 2. FINDINGS.

7 The Congress finds the following:

1	(1) The adoption of broadband service results
2	in enhanced economic development and public safety
3	for communities across the Nation, improved health
4	care and educational opportunities, and a better
5	quality of life for all Americans.
6	(2) Continued progress in the adoption of
7	broadband service is vital to ensuring that the
8	United States remains competitive and continues to
9	create business opportunities and job growth.
10	(3) The price of broadband service is a barrier
11	to adoption for low-income households and can be an
12	impediment to full participation in the emerging
13	broadband economy.

1	"(A) whether State matching funds must
2	be provided as a condition of eligibility for low-
3	income households within a State;
4	"(B) the prevailing market rate for
5	broadband service and the prevailing speed of
6	broadband service adopted by households, using
7	information that the Commission routinely col-
8	lects or that is publicly available; and
9	"(C) how to ensure that the program is
10	neutral as to the types of technology used to
11	provide broadband service in order to promote
12	competition from broadband service providers to
13	qualify for participation in the pilot program.
14	"(4) STATUS REPORT.—After the pilot program
15	has been operational for 18 months, the Commission
16	shall submit a report to the Senate Committee on
17	Commerce, Science, and Transportation and the
18	House of Representatives Committee on Energy and
19	Commerce on the status of the pilot program.
20	"(5) LIFELINE PROGRAM DEFINED.—In this
21	subsection, the term 'Lifeline program' means the
22	service described in section 54.401(a) of the Com-
23	mission's regulations (47 C.F.R. 54.401(a)).".

1 SEC. 4. EXPANSION OF LINK UP PROGRAM REPORT.

2 (a) IN GENERAL.—Within 180 days after the date
3 of enactment of this Act, the Federal Communications
4 Commission shall initiate a notice of inquiry with public
5 notice and opportunity for comment, to determine—

6 (1) whether the Link Up program could be ex7 panded to reduce the cost of initiating broadband
8 service through providing support for computer own9 ership;

10 (2) what equipment would be supported by such11 an expansion;

12 (3) how much support would be available with13 such an expansion; and

14 (4) the eligibility criteria for consumers to qual-15 ify for such an expansion.

16 (b) REPORT.—The Commission shall submit a report 17 to the Senate Committee on Commerce, Science, and 18 Transportation and the House of Representatives Com-19 mittee on Energy and Commerce containing the Commis-20 sion's findings, conclusions, and recommendations from 21 the inquiry.

(c) LINK UP PROGRAM DEFINED.—In this section,
the term "Link Up program" means the service described
in section 54.411(a) of the Commission's regulations (47
U.S.C. 54.411(a)).
