## A BILL

To amend titles 18 and 28 of the United States Code to provide assistance to the Federal law enforcement agencies in investigating offenses involving child victims.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Arresting Child Preda-  
5 tors Act of 2010”.

6 **SEC. 2. SUBPOENA AUTHORITY.**

7 (a) ADMINISTRATIVE SUBPOENAS.—Section 3486 of  
8 title 18, United States Code, is amended—

9 (1) in subsection (a)—

- 1 (A) in paragraph (1)—
- 2 (i) in subparagraph (A)—
- 3 (I) by redesignating clause (ii) as
- 4 clause (iii);
- 5 (II) by striking clause (i) and in-
- 6 serting the following:
- 7 “(i) a Federal health care offense, the Attorney
- 8 General;
- 9 “(ii) a Federal offense involving the sexual ex-
- 10 ploitation or abuse of children, the Attorney General,
- 11 the Secretary of Homeland Security, or the Post-
- 12 master General; or”; and
- 13 (III) in clause (iii), as so redesign-
- 14 ated, by striking “Secretary of the
- 15 Treasury” and inserting “Secretary of
- 16 Homeland Security”; and
- 17 (ii) in subparagraph (D), by inserting
- 18 “, 2250” after “2243”;
- 19 (B) in paragraph (6)(A), by striking
- 20 “United State” and inserting “United States”;
- 21 (C) in paragraph (9), by striking “para-
- 22 graph (1)(A)(i)(II) or (1)(A)(ii)” and inserting
- 23 “paragraph (1)(A)(ii) or (1)(A)(iii)”; and
- 24 (D) in paragraph (10), by striking “para-
- 25 graph (1)(A)(ii), the Secretary of the Treasury”

1 and inserting “paragraph (1)(A)(iii), the Sec-  
2 retary of Homeland Security”; and

3 (2) in subsection (c)—

4 (A) in the first sentence, by inserting “, in  
5 coordination with the Secretary of Homeland  
6 Security or the Postmaster General, as appro-  
7 priate,” after “the Attorney General”; and

8 (B) in the second sentence, by striking  
9 “appear before the Attorney General” and in-  
10 serting “appear before the Government officer  
11 that issued the subpoena”.

12 (b) UNITED STATES MARSHALS SERVICE.—Section  
13 566(e)(1) of title 28, United States Code, is amended—

14 (1) in subparagraph (A), by striking “and” at  
15 the end;

16 (2) in subparagraph (B), by striking the period  
17 at the end and inserting “; and”; and

18 (3) by adding at the end the following:

19 “(C) issue administrative subpoenas in accord-  
20 ance with section 3486 of title 18.”.
