## A BILL

To establish the Office of the National Alzheimer's Project.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “National Alzheimer’s  
3 Project Act”.

4 **SEC. 2. OFFICE OF THE NATIONAL ALZHEIMER’S PROJECT.**

5 (a) **ESTABLISHMENT OF OFFICE.**—There is estab-  
6 lished in the Office of the Secretary of Health and Human  
7 Services the Office of the National Alzheimer’s Project  
8 (referred to in this Act as the “Office”).

9 (b) **PURPOSE OF THE OFFICE.**—The Office shall—

10 (1) accelerate the development of treatments  
11 that would prevent, halt, or reverse the course of  
12 Alzheimer’s;

13 (2) be responsible for the creation and mainte-  
14 nance of an integrated national plan to overcome  
15 Alzheimer’s;

16 (3) help to coordinate the health care and treat-  
17 ment of citizens with Alzheimer’s;

18 (4) ensure the inclusion of ethnic and racial  
19 populations at higher risk for Alzheimer’s or least  
20 likely to receive care, in clinical, research, and serv-  
21 ice efforts with the purpose of decreasing health dis-  
22 parities in Alzheimer’s;

23 (5) coordinate with international bodies to inte-  
24 grate and inform the fight against Alzheimer’s glob-  
25 ally; and

1           (6) provide information and coordination of Alz-  
2           heimer's research and services across all Federal  
3           agencies.

4           (c) DIRECTOR OF THE OFFICE.—

5           (1) APPOINTMENT.—The President shall ap-  
6           point a Director of the Office.

7           (2) DUTIES OF THE DIRECTOR.—

8           (A) IN GENERAL.—The Director of the Of-  
9           fice shall—

10                   (i) oversee the creation and updating  
11                   of the national plan described in subpara-  
12                   graph (B);

13                   (ii) use discretionary authority to  
14                   evaluate all Federal programs around Alz-  
15                   heimer's, including budget requests and  
16                   approvals; and

17                   (iii) prepare and submit to the Presi-  
18                   dent the annual budget estimate for the  
19                   Office.

20           (B) NATIONAL PLAN.—The Director of the  
21           Office shall carry out an annual assessment of  
22           the Nation's progress in preparing for the esca-  
23           lating burden of Alzheimer's, including both im-  
24           plementation steps and recommendations for  
25           priority actions based on the assessment.

1           (3) SERVICE BY DIRECTOR.—The Director of  
 2 the Office shall serve on the advisory board of the  
 3 Office of Science and Technology to promote re-  
 4 search efforts into mechanisms to slow and stop the  
 5 development of Alzheimer’s for those at risk of de-  
 6 veloping the disease.

7           (d) ADVISORY COUNCIL.—

8           (1) IN GENERAL.—There is established in the  
 9 Office an Advisory Council on Alzheimer’s Research  
 10 and Treatment (referred to in this Act as the “Advi-  
 11 sory Council”).

12           (2) MEMBERSHIP.—

13           (A) FEDERAL MEMBERS.—The Advisory  
 14 Council shall be comprised of the following ex-  
 15 perts:

16                   (i) A designee of the Centers for Dis-  
 17 ease Control and Prevention.

18                   (ii) A designee of the Administration  
 19 on Aging.

20                   (iii) A designee of the Centers for  
 21 Medicare & Medicaid Services.

22                   (iv) A designee of the Indian Health  
 23 Service.

24                   (v) A designee of the Office of the Di-  
 25 rector of the National Institutes of Health.

1 (vi) The Surgeon General.

2 (vii) A designee of the National  
3 Science Foundation.

4 (viii) A designee of the Department of  
5 Veterans Affairs.

6 (B) ~~NON-FEDERAL MEMBERS.~~—In addi-  
7 tion to the members outlined in subparagraph  
8 (A), the Advisory Council shall include 12 ex-  
9 pert members from outside the Federal Govern-  
10 ment, which shall include—

11 (i) 2 Alzheimer patient advocates;

12 (ii) 2 Alzheimer caregivers;

13 (iii) 2 health care providers;

14 (iv) 2 representatives of State health  
15 departments;

16 (v) 2 researchers with Alzheimer-re-  
17 lated expertise in basic, translational, clin-  
18 ical, or drug development science; and

19 (vi) 2 voluntary health association  
20 representatives, including a national Alz-  
21 heimer's disease organization that funds  
22 research and has demonstrated experience  
23 in care and patient services, and a State-  
24 based advocacy organization that provides  
25 services to families and professionals, in-

1 including information and referral, support  
 2 groups, care consultation, education, and  
 3 safety services.

4 ~~(3)~~ MEETINGS.—The Advisory Council shall  
 5 meet quarterly and such meetings shall be open to  
 6 the public.

7 ~~(4)~~ ADVICE.—The Advisory Council shall advise  
 8 the Director of the Office.

9 ~~(5)~~ ANNUAL REPORT.—The Advisory Council  
 10 shall provide to the Director of the Office—

11 (A) recommendations for information to be  
 12 included in the annual report to Congress by  
 13 the Office; and

14 (B) an annually updated national plan.

15 ~~(c)~~ ANNUAL REPORT.—The Director of the Office  
 16 shall submit to Congress—

17 ~~(1)~~ an annual report that includes an evalua-  
 18 tion of all nationally and federally funded efforts in  
 19 Alzheimer’s research, clinical care, institutional, and  
 20 home- and community-based programs and their  
 21 outcomes; and

22 ~~(2)~~ an annually updated national plan.

23 ~~(f)~~ SUNSET.—The Office shall expire on December  
 24 31, 2025.

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “National Alzheimer’s*  
3 *Project Act”.*

4 **SEC. 2. THE NATIONAL ALZHEIMER’S PROJECT.**

5 (a) *DEFINITION OF ALZHEIMER’S.—In this Act, the*  
6 *term “Alzheimer’s” means Alzheimer’s disease and related*  
7 *dementias.*

8 (b) *ESTABLISHMENT.—There is established in the Of-*  
9 *fice of the Secretary of Health and Human Services the Na-*  
10 *tional Alzheimer’s Project (referred to in this Act as the*  
11 *“Project”).*

12 (c) *PURPOSE OF THE PROJECT.—The Secretary of*  
13 *Health and Human Services, or the Secretary’s designee,*  
14 *shall—*

15 (1) *be responsible for the creation and mainte-*  
16 *nance of an integrated national plan to overcome Alz-*  
17 *heimer’s;*

18 (2) *provide information and coordination of Alz-*  
19 *heimer’s research and services across all Federal agen-*  
20 *cies;*

21 (3) *accelerate the development of treatments that*  
22 *would prevent, halt, or reverse the course of Alz-*  
23 *heimer’s;*

24 (4) *improve the—*

25 (A) *early diagnosis of Alzheimer’s disease;*

26 *and*

1                   (B) coordination of the care and treatment  
2                   of citizens with Alzheimer's;

3                   (5) ensure the inclusion of ethnic and racial pop-  
4                   ulations at higher risk for Alzheimer's or least likely  
5                   to receive care, in clinical, research, and service ef-  
6                   forts with the purpose of decreasing health disparities  
7                   in Alzheimer's; and

8                   (6) coordinate with international bodies to inte-  
9                   grate and inform the fight against Alzheimer's glob-  
10                  ally.

11                (d) DUTIES OF THE SECRETARY.—

12                   (1) IN GENERAL.—The Secretary of Health and  
13                   Human Services, or the Secretary's designee, shall—

14                   (A) oversee the creation and updating of the  
15                   national plan described in paragraph (2); and

16                   (B) use discretionary authority to evaluate  
17                   all Federal programs around Alzheimer's, in-  
18                   cluding budget requests and approvals.

19                   (2) NATIONAL PLAN.—The Secretary of Health  
20                   and Human Services, or the Secretary's designee,  
21                   shall carry out an annual assessment of the Nation's  
22                   progress in preparing for the escalating burden of  
23                   Alzheimer's, including both implementation steps and  
24                   recommendations for priority actions based on the as-  
25                   sessment.



1       (e) *ADVISORY COUNCIL.*—

2               (1) *IN GENERAL.*—*There is established an Advisory*  
3 *Council on Alzheimer’s Research, Care, and*  
4 *Services (referred to in this Act as the “Advisory*  
5 *Council”).*

6               (2) *MEMBERSHIP.*—

7                       (A) *FEDERAL MEMBERS.*—*The Advisory*  
8 *Council shall be comprised of the following ex-*  
9 *perts:*

10                               (i) *A designee of the Centers for Dis-*  
11 *ease Control and Prevention.*

12                               (ii) *A designee of the Administration*  
13 *on Aging.*

14                               (iii) *A designee of the Centers for*  
15 *Medicare & Medicaid Services.*

16                               (iv) *A designee of the Indian Health*  
17 *Service.*

18                               (v) *A designee of the Office of the Di-*  
19 *rector of the National Institutes of Health.*

20                               (vi) *The Surgeon General.*

21                               (vii) *A designee of the National Science*  
22 *Foundation.*

23                               (viii) *A designee of the Department of*  
24 *Veterans Affairs.*

1                   *(ix) A designee of the Food and Drug*  
2                   *Administration.*

3                   *(x) A designee of the Agency for*  
4                   *Healthcare Research and Quality.*

5                   *(B) NON-FEDERAL MEMBERS.—In addition*  
6                   *to the members outlined in subparagraph (A),*  
7                   *the Advisory Council shall include 12 expert*  
8                   *members from outside the Federal Government,*  
9                   *which shall include—*

10                   *(i) 2 Alzheimer’s patient advocates;*

11                   *(ii) 2 Alzheimer’s caregivers;*

12                   *(iii) 2 health care providers;*

13                   *(iv) 2 representatives of State health*  
14                   *departments;*

15                   *(v) 2 researchers with Alzheimer’s-re-*  
16                   *lated expertise in basic, translational, clin-*  
17                   *ical, or drug development science; and*

18                   *(vi) 2 voluntary health association rep-*  
19                   *resentatives, including a national Alz-*  
20                   *heimer’s disease organization that has dem-*  
21                   *onstrated experience in research, care, and*  
22                   *patient services, and a State-based advocacy*  
23                   *organization that provides services to fami-*  
24                   *lies and professionals, including informa-*

1                    *tion and referral, support groups, care con-*  
 2                    *sultation, education, and safety services.*

3                    (3) *MEETINGS.*—*The Advisory Council shall*  
 4                    *meet quarterly and such meetings shall be open to the*  
 5                    *public.*

6                    (4) *ADVICE.*—*The Advisory Council shall advise*  
 7                    *the Secretary of Health and Human Services, or the*  
 8                    *Secretary's designee.*

9                    (5) *ANNUAL REPORT.*—*The Advisory Council*  
 10                    *shall provide to the Secretary of Health and Human*  
 11                    *Services, or the Secretary's designee and Congress—*

12                    (A) *an initial evaluation of all federally*  
 13                    *funded efforts in Alzheimer's research, clinical*  
 14                    *care, and institutional-, home-, and community-*  
 15                    *based programs and their outcomes;*

16                    (B) *initial recommendations for priority*  
 17                    *actions to expand, eliminate, coordinate, or con-*  
 18                    *dense programs based on the program's perform-*  
 19                    *ance, mission, and purpose;*

20                    (C) *initial recommendations to—*

21                    (i) *reduce the financial impact of Alz-*  
 22                    *heimer's on—*

23                    (I) *Medicare and other federally*  
 24                    *funded programs; and*

1                   (ii) families living with Alz-  
2                   heimer's disease; and

3                   (ii) improve health outcomes; and

4                   (D) annually thereafter, an evaluation of  
5                   the implementation, including outcomes, of the  
6                   recommendations, including priorities if nec-  
7                   essary, through an updated national plan under  
8                   subsection (d)(2).

9                   (6) *TERMINATION.*—The Advisory Council shall  
10                  terminate on December 31, 2025.

11                  (f) *DATA SHARING.*—Agencies both within the Depart-  
12                  ment of Health and Human Services and outside of the De-  
13                  partment that have data relating to Alzheimer's shall share  
14                  such data with the Secretary of Health and Human Serv-  
15                  ices, or the Secretary's designee, to enable the Secretary, or  
16                  the Secretary's designee, to complete the report described in  
17                  subsection (g).

18                  (g) *ANNUAL REPORT.*—The Secretary of Health and  
19                  Human Services, or the Secretary's designee, shall submit  
20                  to Congress—

21                         (1) an annual report that includes an evaluation  
22                         of all federally funded efforts in Alzheimer's research,  
23                         clinical care, and institutional-, home-, and commu-  
24                         nity-based programs and their outcomes;

1           (2) *an evaluation of all federally funded pro-*  
2           *grams based on program performance, mission, and*  
3           *purpose related to Alzheimer’s disease;*

4           (3) *recommendations for—*

5                 (A) *priority actions based on the evaluation*  
6                 *conducted by the Secretary and the Advisory*  
7                 *Council to—*

8                         (i) *reduce the financial impact of Alz-*  
9                         *heimer’s on—*

10                                 (I) *Medicare and other federally*  
11                                 *funded programs; and*

12                                 (II) *families living with Alz-*  
13                                 *heimer’s disease; and*

14                                 (ii) *improve health outcomes;*

15                         (B) *implementation steps; and*

16                         (C) *priority actions to improve the preven-*  
17                         *tion, diagnosis, treatment, care, institutional-,*  
18                         *home-, and community-based programs of Alz-*  
19                         *heimer’s disease for individuals with Alzheimer’s*  
20                         *disease and their caregivers; and*

21           (4) *an annually updated national plan.*

22           (h) *SUNSET.—The Project shall expire on December*  
23           *31, 2025.*
