1 **SECTION 1. DESIGNATION OF THE STEWART LEE UDALL**
 2 **DEPARTMENT OF THE INTERIOR BUILDING.**

3 The Department of the Interior Building located at
 4 1849 C Street, Northwest, in Washington, District of Co-
 5 lumbia, shall be known and designated as the “Stewart
 6 Lee Udall Department of the Interior Building”.

7 **SEC. 2. REFERENCES TO THE BUILDING.**

8 Any reference in a law, map, regulation, document,
 9 record, or other paper of the United States to the building
 10 described in section 1 shall be considered to be a reference
 11 to the “Stewart Lee Udall Department of the Interior
 12 Building”.

13 **SECTION 1. DESIGNATION.**

14 *The United States Department of the Interior Build-*
 15 *ing located at 1849 C Street, Northwest, in Washington,*
 16 *District of Columbia, shall be known and designated as the*
 17 *“Stewart Lee Udall Department of the Interior Building”.*

18 **SEC. 2. REFERENCES.**

 21 *referred to in section 1 shall be considered to be a reference*
 22 *to the “Stewart Lee Udall Department of the Interior*
 23 *Building”.*
