- 3 SECTION 1. REDESIGNATION OF THE NORTH MISSISSIPPI
- 4 NATIONAL WILDLIFE REFUGES COMPLEX.
- 5 (a) In General.—The North Mississippi National
- 6 Wildlife Refuges Complex, located in the State of Mis-

- 1 sissippi and consisting of the Dahomey National Wildlife
- 2 Refuge, the Tallahatchie National Wildlife Refuge, the
- 3 Coldwater National Wildlife Refuge, and the Bear Lake
- 4 Unit, is redesignated as the "Sam D. Hamilton North
- 5 Mississippi National Wildlife Refuges Complex."
- 6 (b) BOUNDARY REVISION.—Nothing in this Act pre-
- 7 vents the Secretary of the Interior from making adjust-
- 8 ments to the boundaries of the Sam D. Hamilton North
- 9 Mississippi National Wildlife Refuges Complex (referred
- 10 to in this section as the "Refuges Complex"), as the Sec-
- 11 retary determines to be appropriate, to carry out the mis-
- 12 sion of the National Wildlife Refuge System in accordance
- 13 with the National Wildlife Refuge System Administration
- 14 Act of 1966 (16 U.S.C. 668dd et seq.) and any other ap-
- 15 plicable authority.
- 16 (c) Addition of Land.—Nothing in this Act pre-
- 17 vents the Secretary of the Interior from adding to the Ref-
- 18 uges Complex new land or parcels of the National Wildlife
- 19 Refuge System, as the Secretary determines to be appro-
- 20 priate, to carry out the mission of the National Wildlife
- 21 Refuge System in accordance with the National Wildlife
- 22 Refuge System Administration Act of 1966 (16 U.S.C.
- 23 668dd et seq.) and any other applicable authority.
- 24 (d) References.—Any reference in any statute,
- 25 rule, regulation, executive order, publication, map, paper,

- 1 or other document of the United States to the North Mis-
- 2 sissippi National Wildlife Refuges Complex is deemed to
- 3 refer to the Sam D. Hamilton North Mississippi National
- 4 Wildlife Refuges Complex.
