Mr. REED (for himself and Ms. STABENOW) introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

A BILL

To amend the Public Health Service Act to provide grants for community-based mental health infrastructure improvement.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Community-Based
5 Mental Health Infrastructure Improvements Act”.

1 **SEC. 2. COMMUNITY-BASED MENTAL HEALTH INFRASTRUC-**
 2 **TURE IMPROVEMENT.**

3 Title V of the Public Health Service Act (42 U.S.C.
 4 280g et seq.) is amended by adding at the end the fol-
 5 lowing:

6 **“PART H—COMMUNITY-BASED MENTAL HEALTH**
 7 **INFRASTRUCTURE IMPROVEMENTS**

8 **“SEC. 560. GRANTS FOR COMMUNITY-BASED MENTAL**
 9 **HEALTH INFRASTRUCTURE IMPROVEMENTS.**

10 “(a) GRANTS AUTHORIZED.—The Secretary may
 11 award grants to eligible entities to expend funds for the
 12 construction or modernization of facilities used to provide
 13 mental health and substance abuse services to individuals.

14 “(b) ELIGIBLE ENTITY.—In this section, the term
 15 ‘eligible entity’ means—

16 “(1) a State that is the recipient of a Commu-
 17 nity Mental Health Services Block Grant under sub-
 18 part I of part B of title XIX and a Substance Abuse
 19 Prevention and Treatment Block Grant under sub-
 20 part II of such part; or

21 “(2) an Indian tribe or a tribal organization (as
 22 such terms are defined in sections 4(b) and 4(c) of
 23 the Indian Self-Determination and Education Assist-
 24 ance Act).

1 “(c) APPLICATION.—A eligible entity desiring a grant
2 under this section shall submit to the Secretary an appli-
3 cation at such time, in such manner, and containing—

4 “(1) a plan for the construction or moderniza-
5 tion of facilities used to provide mental health and
6 substance abuse services to individuals that—

7 “(A) designates a single State or tribal
8 agency as the sole agency for the supervision
9 and administration of the grant;

10 “(B) contains satisfactory evidence that
11 such agency so designated will have the author-
12 ity to carry out the plan;

13 “(C) provides for the designation of an ad-
14 visory council, which shall include representa-
15 tives of nongovernmental organizations or
16 groups, and of the relevant State or tribal agen-
17 cies, that aided in the development of the plan
18 and that will implement and monitor any grant
19 awarded to the eligible entity under this section;

20 “(D) in the case of an eligible entity that
21 is a State, includes a copy of the State plan
22 under section 1912(b) and section 1932(b);

23 “(E)(i) includes a listing of the projects to
24 be funded by the grant; and

1 “(ii) in the case of an eligible entity that
2 is a State, explains how each listed project
3 helps the State in accomplishing its goals and
4 objectives under the Community Mental Health
5 Services Block Grant under subpart I of part B
6 of title XIX and the Substance Abuse Preven-
7 tion and Treatment Block Grant under subpart
8 II of such part;

9 “(F) includes assurances that the facilities
10 will be used for a period of not less than 10
11 years for the provision of community-based
12 mental health or substance abuse services for
13 those who cannot pay for such services, subject
14 to subsection (e); and

15 “(G) in the case of a facility that is not a
16 public facility, includes the name and executive
17 director of the entity who will provide services
18 in the facility; and

19 “(2) with respect to each construction or mod-
20 ernization project described in the application—

21 “(A) a description of the site for the
22 project;

23 “(B) plans and specifications for the
24 project and State or tribal approval for the
25 plans and specifications;

1 “(C) assurance that the title for the site is
2 or will be vested with either the public entity or
3 private nonprofit entity who will provide the
4 services in the facility;

5 “(D) assurance that adequate financial re-
6 sources will be available for the construction or
7 major rehabilitation of the project and for the
8 maintenance and operation of the facility;

9 “(E) estimates of the cost of the project;
10 and

11 “(F) the estimated length of time for com-
12 pletion of the project.

13 “(d) SUBGRANTS BY STATES.—

14 “(1) IN GENERAL.—A State that receives a
15 grant under this section may award a subgrant to
16 a qualified community program (as such term is
17 used in section 1913(b)(1)).

18 “(2) USE OF FUNDS.—Subgrants awarded pur-
19 suant to paragraph (1) may be used for activities
20 such as—

21 “(A) the construction, expansion, and mod-
22 ernization of facilities used to provide mental
23 health and substance abuse services to individ-
24 uals;

1 “(B) acquiring and leasing facilities and
2 equipment (including paying the costs of amor-
3 tizing the principal of, and paying the interest
4 on, loans for such facilities and equipment) to
5 support or further the operation of the sub-
6 grantee;

7 “(C) the construction and structural modi-
8 fication (including equipment acquisition) of fa-
9 cilities to permit the integrated delivery of be-
10 havioral health and primary care of specialty
11 medical services to individuals with co-occurring
12 mental illnesses and chronic medical or surgical
13 diseases at a single service site; and

14 “(D) acquiring information technology re-
15 quired to accommodate the clinical needs of pri-
16 mary and specialty care professionals.

17 “(3) LIMITATION.—Not to exceed 15 percent of
18 grant funds may be used for activities described in
19 paragraph (2)(D).

20 “(e) REQUEST TO TRANSFER OBLIGATION.—An eli-
21 gible entity that receives a grant under this section may
22 submit a request to the Secretary for permission to trans-
23 fer the 10-year obligation of facility use, as described in
24 subsection (c)(1)(F), to another facility.

1 “(f) AGREEMENT TO FEDERAL SHARE.—As a condi-
 2 tion of receipt of a grant under this section, an eligible
 3 entity shall agree, with respect to the costs to be incurred
 4 by the entity in carrying out the activities for which such
 5 grant is awarded, that the entity will make available non-
 6 Federal contributions (which may include State or local
 7 funds, or funds from the qualified community program)
 8 in an amount equal to not less than \$1 for every \$1 of
 9 Federal funds provided under the grant.

10 “(g) REPORTING.—

11 “(1) REPORTING BY STATES.—During the 10-
 12 year period referred to in subsection (c)(1)(F), the
 13 Secretary shall require that a State that receives a
 14 grant under this section submit, as part of the re-
 15 port of the State required under the Community
 16 Mental Health Services Block Grant under subpart
 17 I of part B of title XIX and the Substance Abuse
 18 Prevention and Treatment Block Grant under sub-
 19 part II of such part, a description of the progress
 20 on—

21 “(A) the projects carried out pursuant to
 22 the grant under this section; and

23 “(B) the assurances that the facilities in-
 24 volved continue to be used for the purpose for

1 which they were funded under such grant dur-
2 ing such 10-year period.

3 “(2) REPORTING BY INDIAN TRIBES AND TRIB-
4 AL ORGANIZATIONS.—The Secretary shall establish
5 reporting requirements for Indian tribes and tribal
6 organizations that receive a grant under this section.
7 Such reporting requirements shall include that such
8 Indian tribe or tribal organization provide a descrip-
9 tion of the progress on—

10 “(A) the projects carried out pursuant to
11 the grant under this section; and

12 “(B) the assurances that the facilities in-
13 volved continue to be used for the purpose for
14 which they were funded under such grant dur-
15 ing the 10-year period referred to in subsection
16 (c)(1)(F).

17 “(h) FAILURE TO MEET OBLIGATIONS.—

18 “(1) IN GENERAL.—If an eligible entity that re-
19 ceives a grant under this section fails to meet any
20 of the obligations of the entity required under this
21 section, the Secretary shall take appropriate steps,
22 which may include—

23 “(A) requiring that the entity return the
24 unused portion of the funds awarded under this
25 section for the projects that are incomplete; and

1 “(B) extending the length of time that the
2 entity must ensure that the facility involved is
3 used for the purposes for which it is intended,
4 as described in subsection (c)(1)(F).

5 “(2) HEARING.—Prior to requesting the return
6 of the funds under paragraph (1)(B), the Secretary
7 shall provide the entity notice and opportunity for a
8 hearing.

9 “(i) COLLABORATION.—The Secretary may establish
10 intergovernmental and interdepartmental memorandums
11 of agreement as necessary to carry out this section.

12 “(j) AUTHORIZATION OF APPROPRIATIONS.—There
13 is authorized to be appropriated to carry out this section
14 \$20,000,000 for fiscal year 2010 and such sums as may
15 be necessary for each of fiscal years 2011 through 2013.”.
