Mr. Schumer, from the Committee on Rules and Administration, reported the following original resolution; which was placed on the calendar

RESOLUTION

Authorizing expenditures by the Committee on Rules and Administration.

- 1 Resolved, That, in carrying out its powers, duties, and
- 2 functions under the Standing Rules of the Senate, in ac-
- 3 cordance with its jurisdiction under rule XXV of such
- 4 rules, including holding hearings, reporting such hearings,
- 5 and making investigations as authorized by paragraphs 1
- 6 and 8 of rule XXVI of the Standing Rules of the Senate,
- 7 the Committee on Rules and Administration is authorized
- 8 from March 1, 2009, through September 30, 2009; Octo-
- 9 ber 1, 2009, through September 30, 2010; and, Oct. 1,

- 1 2010, through February 28, 2011, in its discretion (1) to
- 2 make expenditures from the contingent fund of the Sen-
- 3 ate, (2) to employ personnel, and (3) with the prior con-
- 4 sent of the Government department or agency concerned
- 5 and the Committee on Rules and Administration, to use
- 6 on a reimbursable or non reimbursable basis the services
- 7 of personnel of any such department or agency.
- 8 Sec. 2. (a) The expenses of the committee for the
- 9 period March 1, 2009, through September 30, 2009,
- 10 under this resolution shall not exceed \$1,797,669, of
- 11 which amount (1) not to exceed \$30,000 may be expended
- 12 for the procurement of the services of individual consult-
- 13 ants, or organizations thereof (as authorized by section
- 14 202(i) of the Legislative Reorganization Act of 1946, as
- 15 amended), and (2) not to exceed \$6,000 may be expended
- 16 for the training of the professional staff of such committee
- 17 (under procedures specified by section 202(j) of the Legis-
- 18 lative Reorganization Act of 1946).
- 19 (b) For the period October 1, 2009, through Sep-
- 20 tember 30, 2010, expenses of the committee under this
- 21 resolution shall not exceed \$3,161,766, of which amount
- 22 (1) not to exceed \$50,000 may be expended for the pro-
- 23 curement of the services of individual consultants, or orga-
- 24 nizations thereof (as authorized by section 202(i) of the
- 25 Legislative Reorganization Act of 1946, as amended), and

- 1 (2) not to exceed \$10,000 may be expended for the train-
- 2 ing of the professional staff of such committee (under pro-
- 3 cedures specified by section 202(j) of the Legislative Reor-
- 4 ganization Act of 1946).
- 5 (c) For the period October 1, 2010, through Feb-
- 6 ruary 28, 2011, expenses of the committee under this res-
- 7 olution shall not exceed \$1,346,931, of which amount (1)
- 8 not to exceed \$21,000 may be expended for the procure-
- 9 ment of the services of individual consultants, or organiza-
- 10 tions thereof (as authorized by section 202(i) of the Legis-
- 11 lative Reorganization Act of 1946, as amended), and (2)
- 12 not to exceed \$4,200 may be expended for the training
- 13 of the professional staff of such committee (under proce-
- 14 dures specified by section 202(j) of the Legislative Reorga-
- 15 nization Act of 1946).
- 16 Sec. 3. The committee shall report its findings, to-
- 17 gether with such recommendations for legislation as it
- 18 deems advisable, to the Senate at the earliest practicable
- 19 date, but not later than February 28, 2011.
- 20 Sec. 4. Expenses of the committee under this resolu-
- 21 tion shall be paid from the contingent fund of the Senate
- 22 upon vouchers approved by the chairman of the com-
- 23 mittee, except that vouchers shall not be required (1) for
- 24 the disbursement of salaries of employees paid at an an-
- 25 nual rate, or (2) for the payment of telecommunications

- 1 provided by the Office of the Sergeant at Arms and Door-
- 2 keeper, United States Senate, or (3) for the payment of
- 3 stationery supplies purchased through the Keeper of the
- 4 Stationery, United States Senate, or (4) for payments to
- 5 the Postmaster, United States Senate, or (5) for the pay-
- 6 ment of metered charges on copying equipment provided
- 7 by the Office of the Sergeant at Arms and Doorkeeper,
- 8 United States Senate, or (6) for the payment of Senate
- 9 Recording and Photographic Services, or (7) for payment
- 10 of franked and mass mail costs by the Sergeant at Arms
- 11 and Doorkeeper, United States Senate.
- 12 Sec. 5. There are authorized such sums as may be
- 13 necessary for agency contributions related to the com-
- 14 pensation of employees of the committee from March 1,
- 15 2009, through September 30, 2009; October 1, 2009,
- 16 through September 30, 2010; and October 1, 2010,
- 17 through February 28, 2011, to be paid from the Appro-
- 18 priations account for "Expenses of Inquiries and Inves-
- 19 tigations".
