- 6 SEC. 2. APPLICATION OF REGULATIONS.
- 7 (a) In General.—For purposes of applying the
- 8 issued regulations as a body of regulations required by sec-

- 1 tion 304(a)(2)(B)(i) of the Congressional Accountability
- 2 Act of 1995 (2 U.S.C. 1384(a)(2)(B)(i)), the portions of
- 3 the issued regulations that are unclassified or classified
- 4 with an "S" designation shall apply to the Senate and em-
- 5 ployees of the Senate.
- 6 (b) Definition.—In this section, the term "em-
- 7 ployee of the Senate" has the meaning given the term in
- 8 section 101 of the Congressional Accountability Act of
- 9 1995 (2 U.S.C. 1301), except as limited by the regulations
- 10 (as corrected under section 3).

#### 17 SEC. 1.101. PURPOSE AND SCOPE.

- 18 (a) Section 4(c) of the VEOA. The Veterans Employ-
- 19 ment Opportunities Act (VEOA) applies the rights and
- 20 protections of sections 2108, 3309 through 3312, and sub-
- 21 chapter I of chapter 35 of title 5 U.S.C., to certain covered
- 22 employees within the Legislative branch.

- 1 (b) Purpose of regulations. The regulations set forth
- 2 herein are the substantive regulations that the Board of
- 3 Directors of the Office of Compliance has promulgated
- 4 pursuant to section 4(c)(4) of the VEOA, in accordance
- 5 with the rulemaking procedure set forth in section 304 of
- 6 the CAA (2 U.S.C. § 1384). The purpose of subparts B,
- 7 C and D of these regulations is to define veterans' pref-
- 8 erence and the administration of veterans' preference as
- 9 applicable to Federal employment in the Legislative
- 10 branch. (5 U.S.C. §2108, as applied by the VEOA). The
- 11 purpose of subpart E of these regulations is to ensure that
- 12 the principles of the veterans' preference laws are inte-
- 13 grated into the existing employment and retention policies
- 14 and processes of those employing offices with employees
- 15 covered by the VEOA, and to provide for transparency in
- 16 the application of veterans' preference in covered appoint-
- 17 ment and retention decisions. Provided, nothing in these
- 18 regulations shall be construed so as to require an employ-
- 19 ing office to reduce any existing veterans' preference
- 20 rights and protections that it may afford to preference eli-
- 21 gible individuals.

#### SEC. 1.102. DEFINITIONS.

- 2 Except as otherwise provided in these regulations, as
- 3 used in these regulations:
- 4 (a) Accredited physician means a doctor of medicine
- 5 or osteopathy who is authorized to practice medicine or
- 6 surgery (as appropriate) by the State in which the doctor
- 7 practices. The phrase "authorized to practice by the
- 8 State" as used in this section means that the provider
- 9 must be authorized to diagnose and treat physical or men-
- 10 tal health conditions without supervision by a doctor or
- 11 other health care provider.
- 12 (b) Act or CAA means the Congressional Account-
- 13 ability Act of 1995, as amended (Pub. L. 104–1, 109 Stat.
- 14 3, 2 U.S.C. §§ 1301–1438).
- 15 (c) Active duty or active military duty means full-time
- 16 duty with military pay and allowances in the armed forces,
- 17 except (1) for training or for determining physical fitness
- 18 and (2) for service in the Reserves or National Guard.
- 19 (d) Appointment means an individual's appointment
- 20 to employment in a covered position, but does not include
- 21 any personnel action that an employing office takes with
- 22 regard to an existing employee of the employing office.
- (e) Armed forces means the United States Army,
- 24 Navy, Air Force, Marine Corps, and Coast Guard.
- 25 (f) Board means the Board of Directors of the Office
- 26 of Compliance.

- 12 ability or is receiving compensation, disability retirement
- 13 benefits, or pensions because of a public statute adminis-
- 14 tered by the Department of Veterans Affairs or a military
- 15 department.
- 16 (j) Employee of the Office of the Architect of the
- 17 Capitol includes any employee of the Office of the Archi-
- 18 tect of the Capitol, the Botanic Gardens, or the Senate
- 19 Restaurants.
- 20 (k) Employee of the Capitol Police Board includes
- 21 any member or officer of the Capitol Police.
- 22 (l) Employee of the House of Representatives in-
- 23 cludes an individual occupying a position the pay of which
- 24 is disbursed by the Clerk of the House of Representatives,
- 25 or another official designated by the House of Representa-

- 1 tives, or any employment position in an entity that is paid
- 2 with funds derived from the clerk-hire allowance of the
- 3 House of Representatives but not any such individual em-
- 4 ployed by any entity listed in subparagraphs (3) through
- 5 (8) of paragraph (g) above nor any individual described
- 6 in subparagraphs (aa) through (dd) of paragraph (g)
- 7 above.
- 8 (m) Employee of the Senate includes any employee
- 9 whose pay is disbursed by the Secretary of the Senate,
- 10 but not any such individual employed by any entity listed
- 11 in subparagraphs (3) through (8) of paragraph (g) above
- 12 nor any individual described in subparagraphs (aa)
- 13 through (ee) of paragraph (g) above.
- 14 **H Regs:** (n) Employing office means: (1) the per-
- 15 sonal office of a Member of the House of Representa-
- 16 tives; (2) a committee of the House of Representatives or
- 17 a joint committee of the House of Representatives and
- 18 the Senate; or (3) any other office headed by a person
- 19 with the final authority to appoint, hire, discharge, and
- 20 set the terms, conditions, or privileges of the employment
- 21 of an employee of the House of Representatives or the
- 22 Senate.
- 23 **S Regs:** (n) Employing office means: (1) the per-
- 24 sonal office of a Senator; (2) a committee of the Senate
- 25 or a joint committee of the House of Representatives and

- 1 the Senate; or (3) any other office headed by a person
- 2 with the final authority to appoint, or be directed by a
- 3 Member of Congress to appoint, hire, discharge, and set
- 4 the terms, conditions, or privileges of the employment of
- 5 an employee of the House of Representatives or the Sen-
- 6 ate.
- 7 **C Reg:** (n) Employing office means: the Capitol
- 8 Guide Board, the Capitol Police Board, the Congressional
- 9 Budget Office, the Office of the Architect of the Capitol,
- 10 the Office of the Attending Physician, and the Office of
- 11 Compliance.
- 12 (o) Office means the Office of Compliance.
- 13 (p) Preference eligible means veterans, spouses, wid-
- 14 ows, widowers or mothers who meet the definition of
- 15 "preference eligible" in 5 U.S.C. § 2108(3)(A)–(G).
- 16 (q) Qualified applicant means an applicant for a cov-
- 17 ered position whom an employing office deems to satisfy
- 18 the requisite minimum job-related requirements of the po-
- 19 sition. Where the employing office uses an entrance exam-
- 20 ination or evaluation for a covered position that is numeri-
- 21 cally scored, the term "qualified applicant" shall mean
- 22 that the applicant has received a passing score on the ex-
- 23 amination or evaluation.
- (r) Separated under honorable conditions means ei-
- 25 ther an honorable or a general discharge from the armed

- 1 forces. The Department of Defense is responsible for ad-
- 2 ministering and defining military discharges.
- 3 (s) Uniformed services means the armed forces, the
- 4 commissioned corps of the Public Health Service, and the
- 5 commissioned corps of the National Oceanic and Atmos-
- 6 pheric Administration.
- 7 (t) VEOA means the Veterans Employment Opportu-
- 8 nities Act of 1998 (Pub. L. 105–339, 112 Stat. 3182).
- 9 (u) Veterans means persons as defined in 5 U.S.C.
- 10  $\S 2108(1)$ , or any superseding legislation.

#### 11 SEC. 1.103. ADOPTION OF REGULATIONS.

- 12 (a) Adoption of regulations. Section 4(c)(4)(A) of the
- 13 VEOA generally authorizes the Board to issue regulations
- 14 to implement section 4(c). In addition, section 4(c)(4)(B)
- 15 of the VEOA directs the Board to promulgate regulations
- 16 that are "the same as the most relevant substantive regu-
- 17 lations (applicable with respect to the Executive branch)
- 18 promulgated to implement the statutory provisions re-
- 19 ferred to in paragraph (2)" of section 4(c) of the VEOA.
- 20 Those statutory provisions are section 2108, sections 3309
- 21 through 3312, and subchapter I of chapter 35, of title 5,
- 22 United States Code. The regulations issued by the Board
- 23 herein are on all matters for which section 4(c)(4)(B) of
- 24 the VEOA requires a regulation to be issued. Specifically,
- 25 it is the Board's considered judgment based on the infor-

- 1 mation available to it at the time of promulgation of these
- 2 regulations, that, with the exception of the regulations
- 3 adopted and set forth herein, there are no other "sub-
- 4 stantive regulations (applicable with respect to the Execu-
- 5 tive branch) promulgated to implement the statutory pro-
- 6 visions referred to in paragraph (2)" of section 4(c) of
- 7 the VEOA that need be adopted.
- 8 (b) Modification of substantive regulations. As a
- 9 qualification to the statutory obligation to issue regula-
- 10 tions that are "the same as the most substantive regula-
- 11 tions (applicable with respect to the Executive branch)",
- 12 section 4(c)(4)(B) of the VEOA authorizes the Board to
- 13 "determine, for good cause shown and stated together
- 14 with the regulation, that a modification of such regula-
- 15 tions would be more effective for the implementation of
- 16 the rights and protections under" section 4(c) of the
- 17 VEOA.
- 18 (c) Rationale for Departure from the Most Relevant
- 19 Executive Branch Regulations. The Board concludes that
- 20 it must promulgate regulations accommodating the human
- 21 resource systems existing in the Legislative branch; and
- 22 that such regulations must take into account the fact that
- 23 the Board does not possess the statutory and Executive
- 24 Order based government-wide policy making authority un-
- 25 derlying OPM's counterpart VEOA regulations governing

- 1 the Executive branch. OPM's regulations are designed for
- 2 the competitive service (defined in 5 U.S.C. § 2102(a)(2)),
- 3 which does not exist in the employing offices subject to
- 4 this regulation. Therefore, to follow the OPM regulations
- 5 would create detailed and complex rules and procedures
- 6 for a workforce that does not exist in the Legislative
- 7 branch, while providing no VEOA protections to the cov-
- 8 ered Legislative branch employees. We have chosen to pro-
- 9 pose specially tailored regulations, rather than simply to
- 10 adopt those promulgated by OPM, so that we may effec-
- 11 tuate Congress' intent in extending the principles of the
- 12 veterans' preference laws to the Legislative branch
- 13 through the VEOA.
- 14 SEC. 1.104. COORDINATION WITH SECTION 225 OF THE CON-
- 15 GRESSIONAL ACCOUNTABILITY ACT.
- Statutory directive. Section 4(c)(4)(C) of the VEOA
- 17 requires that promulgated regulations must be consistent
- 18 with section 225 of the CAA. Among the relevant provi-
- 19 sions of section 225 are subsection (f)(1), which pre-
- 20 scribes as a rule of construction that definitions and ex-
- 21 emptions in the laws made applicable by the CAA shall
- 22 apply under the CAA, and subsection (f)(3), which states
- 23 that the CAA shall not be considered to authorize en-
- 24 forcement of the CAA by the Executive branch.

#### 1 SEC. 1.105. RESPONSIBILITY FOR ADMINISTRATION OF VET-

- 2 ERANS' PREFERENCE.
- 3 Subject to section 1.106, employing offices with cov-
- 4 ered employees or covered positions are responsible for
- 5 making all veterans' preference determinations, con-
- 6 sistent with the VEOA.

#### 7 SEC. 1.106. PROCEDURES FOR BRINGING CLAIMS UNDER

- 8 THE VEOA.
- 9 Applicants for appointment to a covered position and
- 10 covered employees may contest adverse veterans' pref-
- 11 erence determinations, including any determination that
- 12 a preference eligible applicant is not a qualified applicant,
- 13 pursuant to sections 401–416 of the CAA, 2 U.S.C.
- 14 §§ 1401–1416, and provisions of law referred to therein;
- 15 206a(3) of the CAA, 2 U.S.C. §§ 1401, 1316a(3); and
- 16 the Office's Procedural Rules.

- 1 tions as restricted covered positions) employing offices
- 2 shall restrict competition to preference eligible applicants
- 3 as long as qualified preference eligible applicants are
- 4 available. The provisions of sections 1.109 and 1.110
- 5 below shall apply to the appointment of a preference eli-
- 6 gible applicant to a restricted covered position. The provi-
- 7 sions of section 1.108 shall apply to the appointment of
- 8 a preference eligible applicant to a restricted covered po-
- 9 sition, in the event that there is more than one preference
- 10 eligible applicant for the position.
- 11 Custodian—One whose primary duty is the perform-
- 12 ance of cleaning or other ordinary routine maintenance
- 13 duties in or about a government building or a building
- 14 under Federal control, park, monument, or other Federal
- 15 reservation.
- 16 Elevator operator—One whose primary duty is the
- 17 running of freight or passenger elevators. The work in-
- 18 cludes opening and closing elevator gates and doors,
- 19 working elevator controls, loading and unloading the eleva-
- 20 tor, giving information and directions to passengers such
- 21 as on the location of offices, and reporting problems in
- 22 running the elevator.
- Guard—One whose primary duty is the assignment
- 24 to a station, beat, or patrol area in a Federal building
- 25 or a building under Federal control to prevent illegal

- 1 entry of persons or property; or required to stand watch
- 2 at or to patrol a Federal reservation, industrial area, or
- 3 other area designated by Federal authority, in order to
- 4 protect life and property; make observations for detection
- 5 of fire, trespass, unauthorized removal of public property
- 6 or hazards to Federal personnel or property. The term
- 7 guard does not include law enforcement officer positions
- 8 of the Capitol Police Board.
- 9 Messenger—One whose primary duty is the super-
- 10 vision or performance of general messenger work (such as
- 11 running errands, delivering messages, and answering call
- 12 bells).
- 13 SEC. 1.108. VETERANS' PREFERENCE IN APPOINTMENTS TO
- 14 NON-RESTRICTED COVERED POSITIONS.
- 15 (a) Where an employing office has duly adopted a pol-
- 16 icy requiring the numerical scoring or rating of applicants
- 17 for covered positions, the employing office shall add points

#### 3 SEC. 1.111. DEFINITIONS APPLICABLE IN REDUCTIONS IN

- 4 FORCE.
- 5 (a) Competing covered employees are the covered em-
- 6 ployees within a particular position or job classification,
- 7 at or within a particular competitive area, as those terms
- 8 are defined below.
- 9 (b) Competitive area is that portion of the employing
- 10 office's organizational structure, as determined by the em-
- 11 ploying office, in which covered employees compete for re-
- 12 tention. A competitive area must be defined solely in terms
- 13 of the employing office's organizational unit(s) and geo-
- 14 graphical location, and it must include all employees with-
- 15 in the competitive area so defined. A competitive area may
- 16 consist of all or part of an employing office. The minimum
- 17 competitive area is a department or subdivision of the em-
- 18 ploying office within the local commuting area.
- 19 (c) Position classifications or job classifications are
- 20 determined by the employing office, and shall refer to all
- 21 covered positions within a competitive area that are in the

#### 6 SEC. 1.116. ADOPTION OF VETERANS' PREFERENCE POLICY.

- 7 No later than 120 calendar days following Congres-
- 8 sional approval of this regulation, each employing office
- 9 that employs one or more covered employees or that
- 10 seeks applicants for a covered position shall adopt its
- 11 written policy specifying how it has integrated the vet-
- 12 erans' preference requirements of the Veterans Employ-
- 13 ment Opportunities Act of 1998 and these regulations
- 14 into its employment and retention processes. Upon timely
- 15 request and the demonstration of good cause, the Execu-
- 16 tive Director, in his/her discretion, may grant such an

- 14 SEC. 1.118. DISSEMINATION OF VETERANS' PREFERENCE

- 17 (a) An employing office shall state in any announce-
- 18 ments and advertisements it makes concerning vacancies
- 19 in covered positions that the staffing action is governed
- 20 by the VEOA.
- 21 (b) An employing office shall invite applicants for a
- 22 covered position to identify themselves as veterans' pref-
- 23 erence eligible applicants, provided that in doing so:
- 24 (1) the employing office shall state clearly on
- any written application or questionnaire used for

- 1 (3) the employing office shall state clearly that
  2 applicants may request information about the em3 ploying office's veterans' preference policies as they
  4 relate to appointments to covered positions, and
  5 shall describe the employing office's procedures for

- 7 (c) Upon written request by an applicant for a cov-8 ered position, an employing office shall provide the fol-9 lowing information in writing:
  - (1) the VEOA definition of veterans' "preference eligible" as set forth in 5 U.S.C. § 2108 or any superseding legislation, providing the actual, current definition in a manner designed to be understood by applicants, along with the statutory citation;

    - (3) the employing office may provide other information to applicants regarding its veterans' preference policies and practices, but is not required to do so by these regulations.

- 1 employees concerning employee rights generally or reduc-
- 2 tions in force more specifically, such as in a written em-
- 3 ployee policy, manual or handbook, such guidance must
- 4 include information concerning veterans' preference under
- 5 the VEOA, as set forth in subsection (b) of this regulation.
- 6 (b) Written guidances described in subsection (a)
  7 above shall include, at a minimum:
  - (1) the VEOA definition of veterans' "preference eligible" as set forth in 5 U.S.C. § 2108 or any superseding legislation, providing the actual, current definition along with the statutory citation;
    - (2) the employing office's veterans' preference policy or a summary description of the employing office's veterans' preference policy as it relates to reductions in force, including the procedures the employing office shall take to identify preference eligible employees.
    - (3) the employing office may provide other information in its guidances regarding its veterans' preference policies and practices, but is not required to do so by these regulations.
- (c) Employing offices are also expected to answer questions from covered employees that are relevant and non-confidential concerning the employing office's veterans' preference policies and practices.

3	(a) Except as provided under subsection (c), a cov-
4	ered employee may not be released due to a reduction in
5	force, unless the covered employee and the covered em-
6	ployee's exclusive representative for collective-bargaining
7	purposes (if any) are given written notice, in conformance
8	with the requirements of paragraph (b), at least 60 days
9	before the covered employee is so released.
10	(b) Any notice under paragraph (a) shall include—
11	(1) the personnel action to be taken with re-
12	spect to the covered employee involved;
13	(2) the effective date of the action;
14	(3) a description of the procedures applicable in
15	identifying employees for release;
16	(4) the covered employee's competitive area;
17	(5) the covered employee's eligibility for vet-
18	erans' preference in retention and how that pref-
19	erence eligibility was determined;
20	(6) the retention status and preference eligi-
21	bility of the other employees in the affected position
22	classifications or job classifications within the cov-
23	ered employee's competitive area, by providing:
24	(A) a list of all covered employee(s) in the
25	covered employee's position classification or job
26	classification and competitive area who will be

- retained by the employing office, identifying
  those employees by job title only and stating
  whether each such employee is preference eligible, and
  - (B) a list of all covered employee(s) in the covered employee's position classification or job classification and competitive area who will not be retained by the employing office, identifying those employees by job title only and stating whether each such employee is preference eligible.
- 12 (7) a description of any appeal or other rights 13 which may be available.
- 14 (c) The director of the employing office may, in writ-15 ing, shorten the period of advance notice required under 16 subsection (a), with respect to a particular reduction in 17 force, if necessary because of circumstances not reason-18 ably foreseeable.
- (d) No notice period may be shortened to less than30 days under this subsection.
