### Chamber Action

*Routine Proceedings, pages S8513–S8538*

**Measures Introduced:** One bill was introduced, as follows: S. 4009. **Page S8537**

**Measures Passed:**

*Arlington National Cemetery:* Committee on Veterans' Affairs was discharged from further consideration of S. 3860, to require reports on the management of Arlington National Cemetery, and the bill was then passed, after agreeing to the following amendment proposed thereto: **Pages S8535–36**

McCaskill Amendment No. 4734, in the nature of a substitute. **Pages S8535–36**

*Office of the Architect of the Capitol:* Committee on Rules and Administration was discharged from further consideration of H.R. 6399, to improve certain administrative operations of the Office of the Architect of the Capitol, and the bill was then passed. **Pages S8537–38**

**House Messages:**

*Airport and Airway Extension Act:* Senate resumed consideration of the amendment of the House of Representatives to the amendment of the Senate to H.R. 4853, to amend the Internal Revenue Code of 1986 to extend the funding and expenditure authority of the Airport and Airway Trust Fund, to amend title 49, United States Code, to extend authorizations for the airport improvement program, taking action on the following motions and amendments proposed thereto: **Pages S8514–30**

During consideration of this measure today, Senate also took the following action:

By 53 yeas to 36 nays (Vote No. 258), three-fifths of those Senators duly chosen and sworn, not having voted in the affirmative, Senate rejected the motion to close further debate on the Reid motion to concur in the amendment of the House to the amendment of the Senate to the bill, with Reid Amendment No. 4727 (to the House amendment to the Senate amendment) (listed above). **Page S8529**

By 53 yeas to 37 nays (Vote No. 259), three-fifths of those Senators duly chosen and sworn, not having voted in the affirmative, Senate rejected the motion to close further debate on the Reid Amendment No. 4728 (to Amendment No. 4727) (listed above).
