- 5 (a) Membership.—Section 49106(c)(1) of title 49,
- 6 United States Code, is amended—

- 1 (1) in the matter preceding subparagraph (A)
- 2 by striking "13 members" and inserting "17 mem-
- 3 bers"; and
- 4 (2) in subparagraph (A) by striking "5 mem-
- 5 bers" and inserting "9 members".
- 6 (b) Term.—Section 49106(c)(3) of such title is
- 7 amended by striking the second sentence and inserting the
- 8 following: "A member may not serve after the expiration
- 9 of the member's term.".
- 10 (c) Removal Authority.—Section 49106(c) of
- 11 such title is amended—
- (1) in paragraph (6) by striking subparagraph
- (C);
- 14 (2) by redesignating paragraph (7) as para-
- 15 graph (8); and
- 16 (3) by inserting after paragraph (6) the fol-
- lowing:
- 18 "(7)(A) A member of the board appointed under
- 19 paragraph (1)(A) shall serve at the pleasure of the Gov-
- 20 ernor of Virginia.
- 21 "(B) A member of the board appointed under para-
- 22 graph (1)(B) shall serve at the pleasure of the Mayor of
- 23 the District of Columbia.

- 1 "(C) A member of the board appointed under para-
- 2 graph (1)(C) shall serve at the pleasure of the Governor
- 3 of Maryland.
- 4 "(D) A member of the board appointed under para-
- 5 graph (1)(D) shall serve at the pleasure of the Presi-
- 6 dent.".
- 7 (d) Approval of Bond Issues and Annual Budg-
- 8 ET.—Section 49106(c)(8) (as redesignated by subsection
- 9 (c)(2) of this section) is amended by striking "Eight
- 10 votes" and inserting "Nine votes".
