AN ACT

To extend the Generalized System of Preferences, and for
other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. EXTENSION OF GENERALIZED SYSTEM OF**
2 **PREFERENCES.**

3 (a) EXTENSION.—Section 505 of the Trade Act of
4 1974 (19 U.S.C. 2465) is amended by striking “December
5 31, 2010” and inserting “July 31, 2013”.

6 (b) EFFECTIVE DATE.—

7 (1) IN GENERAL.—The amendment made by
8 subsection (a) shall apply to articles entered on or
9 after the 15th day after the date of the enactment
10 of this Act.

11 (2) RETROACTIVE APPLICATION FOR CERTAIN
12 LIQUIDATIONS AND RELIQUIDATIONS.—

13 (A) IN GENERAL.—Notwithstanding sec-
14 tion 514 of the Tariff Act of 1930 (19 U.S.C.
15 1514) or any other provision of law and subject
16 to subparagraph (B), any entry of an article to
17 which duty-free treatment or other preferential
18 treatment under title V of the Trade Act of
19 1974 would have applied if the entry had been
20 made on December 31, 2010, that was made—

21 (i) after December 31, 2010, and

22 (ii) before the 15th day after the date
23 of the enactment of this Act,

24 shall be liquidated or reliquidated as though
25 such entry occurred on the 15th day after the
26 date of the enactment of this Act.

1 (B) REQUESTS.—A liquidation or reliqui-
2 dation may be made under subparagraph (A)
3 with respect to an entry only if a request there-
4 for is filed with U.S. Customs and Border Pro-
5 tection not later than 180 days after the date
6 of the enactment of this Act that contains suffi-
7 cient information to enable U.S. Customs and
8 Border Protection—

9 (i) to locate the entry; or

10 (ii) to reconstruct the entry if it can-
11 not be located.

12 (C) PAYMENT OF AMOUNTS OWED.—Any
13 amounts owed by the United States pursuant to
14 the liquidation or reliquidation of an entry of
15 an article under subparagraph (A) shall be
16 paid, without interest, not later than 90 days
17 after the date of the liquidation or reliquidation
18 (as the case may be).

19 (3) DEFINITION.—As used in this subsection,
20 the terms “enter” and “entry” include a withdrawal
21 from warehouse for consumption.

22 **SEC. 2. MERCHANDISE PROCESSING FEES.**

23 For the period beginning on October 1, 2011, and
24 ending on June 30, 2014, section 13031(a)(9) of the Con-

1 consolidated Omnibus Budget Reconciliation Act of 1985 (19
2 U.S.C. 58c(a)(9)) shall be applied and administered—

3 (1) in subparagraph (A), by substituting
4 “0.3464” for “0.21”; and

5 (2) in subparagraph (B)(i), by substituting
6 “0.3464” for “0.21”.
