AN ACT

To amend the SOAR Act by clarifying the scope of coverage of the Act.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "SOAR Technical Cor-
- 3 rections Act".
- 4 SEC. 2. USE OF FUNDS.
- 5 Section 3007(a)(4)(F) of the Scholarships for Oppor-
- 6 tunity and Results Act (Public Law 112–10; 125 Stat.
- 7 203) is amended to read as follows:
- 8 "(F) ensures that, with respect to core
- 9 academic subjects (as such term is defined in
- section 9101(11) of the Elementary and Sec-
- ondary Education Act of 1965 (20 U.S.C.
- 12 7801(11)), participating students are taught by
- a teacher who has a baccalaureate degree or
- 14 equivalent degree, whether such degree was
- awarded in or outside of the United States.".
- 16 SEC. 3. NATIONALLY NORM-REFERENCED STANDARDIZED
- 17 **TESTS.**
- 18 Section 3008(h) of the Scholarships for Opportunity
- 19 and Results Act (Public Law 112–10; 125 Stat. 205) is
- 20 amended by striking paragraph (2) and inserting the fol-
- 21 lowing:
- 22 "(2) Administration of tests.—The Insti-
- tute of Education Sciences shall administer nation-
- ally norm-referenced standardized tests, as described
- in paragraph (3)(A) of section 3009(a), to students
- participating in the evaluation under section 3009(a)

- 1 for the purpose of conducting the evaluation under
- 2 such section, except where a student is attending a
- 3 participating school that is administering the same
- 4 nationally norm-referenced standardized test in ac-
- 5 cordance with the testing requirements described in
- 6 paragraph (1).
- 7 "(3) Test results.—Each participating
- 8 school that administers the nationally norm-ref-
- 9 erenced standardized test described in paragraph (2)
- to an eligible student shall make the test results,
- 11 with respect to such student, available to the Sec-
- retary as necessary for evaluation under section
- 13 3009(a).".
- 14 SEC. 4. EVALUATIONS.
- Section 3009(a)(3) of the Scholarships for Oppor-
- 16 tunity and Results Act (Public Law 112-10; 125 Stat.
- 17 206) is amended—
- 18 (1) in subparagraph (A), by inserting before the
- semicolon the following: "in a manner consistent
- with section 3008(h)"; and

- 1 (2) in subparagraph (C), by inserting ", if re-
- 2 quested by the Institute of Education Sciences,"
- 3 after "will participate".
