A BILL

To amend the SOAR Act by clarifying the scope of coverage
of the Act.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “SOAR Technical Cor-
 5 rections Act”.

6 **SEC. 2. USE OF FUNDS.**

7 Section 3007(a)(4)(F) of the Scholarships for Oppor-
 8 tunity and Results Act (Public Law 112–10; 125 Stat.
 9 203) is amended to read as follows:

10 “(F) ensures that participating students
 11 are taught by core subject matter teachers who
 12 have a baccalaureate degree or equivalent de-
 13 gree, whether such degree was awarded in or
 14 outside of the United States.”.

15 **SEC. 3. NATIONALLY NORM-REFERENCED STANDARDIZED**
 16 **TESTS.**

17 Section 3008(h) of the Scholarships for Opportunity
 18 and Results Act (Public Law 112–10; 125 Stat. 205) is
 19 amended by striking paragraphs (1) and (2) and inserting
 20 the following:

21 “(1) IN GENERAL.—The Institute of Education
 22 Sciences shall administer nationally norm-referenced
 23 standardized tests, as described in paragraph (3)(A)
 24 of section 3009(a), to students participating in the
 25 evaluation under section 3009(a) for the purpose of

1 conducting the evaluation under such section, except
 2 where a student is attending a participating school
 3 that is administering the same nationally norm-ref-
 4 erenced standardized test.

5 “(2) TEST RESULTS.—Each participating
 6 school that administers the nationally norm-ref-
 7 erenced standardized test described in paragraph (1)
 8 to an eligible student shall make the test results,
 9 with respect to such student, available to the Sec-
 10 retary as necessary for evaluation under section
 11 3009(a).”.

12 **SEC. 4. EVALUATIONS.**

13 Section 3009(a)(3) of the Scholarships for Oppor-
 14 tunity and Results Act (Public Law 112–10, 125 Stat.
 15 206) is amended—

16 (1) in subparagraph (A), by inserting before the
 17 semicolon the following: “in a manner consistent
 18 with section 3008(h)”; and

19 (2) in subparagraph (C), by inserting “, if re-
 20 quested by the Institute of Education Sciences,”
 21 after “will participate”.

22 **SECTION 1. SHORT TITLE.**

23 *This Act may be cited as the “SOAR Technical Correc-*
 24 *tions Act”.*

1 **SEC. 2. USE OF FUNDS.**

2 *Section 3007(a)(4)(F) of the Scholarships for Oppor-*
 3 *tunity and Results Act (Public Law 112–10; 125 Stat. 203)*
 4 *is amended to read as follows:*

5 *“(F) ensures that participating students are*
 6 *taught by core subject matter teachers who have*
 7 *a baccalaureate degree or equivalent degree,*
 8 *whether such degree was awarded in or outside*
 9 *of the United States.”.*

10 **SEC. 3. NATIONALLY NORM-REFERENCED STANDARDIZED**
 11 **TESTS.**

12 *Section 3008(h) of the Scholarships for Opportunity*
 13 *and Results Act (Public Law 112–10; 125 Stat. 205) is*
 14 *amended by striking paragraph (2) and inserting the fol-*
 15 *lowing:*

16 *“(2) ADMINISTRATION OF TESTS.—The Institute*
 17 *of Education Sciences shall administer nationally*
 18 *norm-referenced standardized tests, as described in*
 19 *paragraph (3)(A) of section 3009(a), to students par-*
 20 *ticipating in the evaluation under section 3009(a) for*
 21 *the purpose of conducting the evaluation under such*
 22 *section, except where a student is attending a partici-*
 23 *pating school that is administering the same nation-*
 24 *ally norm-referenced standardized test.*

25 *“(3) TEST RESULTS.—Each participating school*
 26 *that administers the nationally norm-referenced*

1 *standardized test described in paragraph (2) to an el-*
2 *igible student shall make the test results, with respect*
3 *to such student, available to the Secretary as nec-*
4 *essary for evaluation under section 3009(a).”.*

5 **SEC. 4. EVALUATIONS.**

6 *Section 3009(a)(3) of the Scholarships for Opportunity*
7 *and Results Act (Public Law 112–10; 125 Stat. 206) is*
8 *amended—*

9 *(1) in subparagraph (A), by inserting before the*
10 *semicolon the following: “in a manner consistent with*
11 *section 3008(h)”;* and

12 *(2) in subparagraph (C), by inserting “, if re-*
13 *quested by the Institute of Education Sciences,” after*
14 *“will participate”.*
