- 4 For an additional amount for "Flood Control and
- 5 Coastal Emergencies", as authorized by section 5 of the
- 6 Act of August 18, 1941 (33 U.S.C. 701n), for necessary
- 7 expenses to prepare for flood, hurricane, and other natural
- 8 disasters and support emergency operations, repair, and
- 9 other activities as authorized by law, in response to a
- 10 major disaster declared pursuant to the Robert T. Staf-
- 11 ford Disaster Relief and Emergency Assistance Act (42)
- 12 U.S.C. 5121 et seq.), \$388,000,000, to remain available
- 13 until expended: Provided, That such amount is designated
- 14 by the Congress as being for disaster relief pursuant to
- 15 section 251(b)(2)(D) of the Balanced Budget and Emer-
- 16 gency Deficit Control Act of 1985: Provided further, That
- 17 the Assistant Secretary of the Army for Civil Works shall
- 18 submit to the Committees on Appropriations of the House
- 19 of Representatives and the Senate a monthly report detail-
- 20 ing the allocation and obligation of these funds, beginning
- 21 not later than 60 days after the date of the enactment

5	For an additional amount for continuing disability re-
6	views under titles II and XVI of the Social Security Act
7	and for the cost associated with conducting redetermina-

9	Act, not more than \$483,484,000 may be expended, as
10	authorized by section 201(g)(1) of the Social Security Act,
11	from any one or all of the trust funds referred to therein:
12	Provided, That such amount is additional new budget au-
13	thority specified for purposes of subsection 251(b)(2)(B)
14	of the Balanced Budget and Emergency Deficit Control

20	TITLE III—GENERAL PROVISION
21	SEC. 301. Each amount appropriated or made avail-
22	able in this Act is in addition to amounts otherwise appro-
23	priated for the fiscal year involved.

- 2 priations Act, 2012".
