A BILL

3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Removal Clarification
5	Act of 2011".
6	SEC. 2. REMOVAL OF CERTAIN LITIGATION TO FEDERAL
7	COURTS.
8	(a) Clarification of Inclusion of Certain
9	Types of Proceedings.—Section 1442 of title 28,
10	United States Code, is amended—
11	(1) in subsection (a), in the matter preceding
12	paragraph (1)—
13	(A) by inserting "that is" after "or crimi-
14	nal prosecution";
15	(B) by inserting "and that is" after "in a
16	State court"; and
17	(C) by inserting "or directed to" after
18	"against"; and
19	(2) by adding at the end the following:
20	"(c) As used in subsection (a), the terms 'civil action'
21	and 'criminal prosecution' include any proceeding (wheth-
22	er or not ancillary to another proceeding) to the extent
23	that in such proceeding a judicial order, including a sub-
24	poena for testimony or documents, is sought or issued. If
25	removal is sought for a proceeding described in the pre-

- 1 vious sentence, and there is no other basis for removal,
- 2 only that proceeding may be removed to the district
- 3 court.".

- 16 that is removable under section 1442(a) is a proceeding
- 17 in which a judicial order for testimony or documents is
- 18 sought or issued or sought to be enforced, the 30-day re-
- 19 quirement of subsections (b) and (c) is satisfied if the per-
- 20 son or entity desiring to remove the proceeding files the
- 21 notice of removal not later than 30 days after receiving,
- 22 through service, notice of any such proceeding.".
