# A BILL

To amend title 38, United States Code, to require the Secretary of Veterans Affairs to provide notice to individuals whose sensitive personal information is involved in a data breach, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Veterans Data Breach
- 5 Timely Notification Act".

- 5 (a) IN GENERAL.—Subchapter III of chapter 57 of
- 6 title 38, United States Code is amended by inserting after
- 7 section 5724 the following new section:

### 8 "§ 5724A. Data breach notification

- 9 "(a) Notification Requirement.—Except as pro-
- 10 vided in subsection (d), in the event of a data breach with
- 11 respect to sensitive personal information that is processed
- 12 or maintained by the Secretary, by not later than five busi-
- 13 ness days after the data breach, the Secretary shall notify
- 14 the appropriate committees of Congress and each indi-
- 15 vidual whose sensitive personal information is involved in
- 16 the data breach is notified of the data breach. If the Sec-
- 17 retary determines that providing such notification within
- 18 five business days is not feasible due to circumstances nec-
- 19 essary to accurately identify the individuals whose sen-
- 20 sitive personal information is involved in the data breach
- 21 or to prevent further breach or unauthorized disclosure
- 22 and reasonably restore the integrity of the data system
- 23 the Secretary shall provide such notification not later than
- 24 10 business days after the data breach.
- 25 "(b) Contracts for Data Processing or Main-
- 26 TENANCE.—If the Secretary enters into a contract for the

- 1 performance of any Department function that requires ac-
- 2 cess to sensitive personal information, the Secretary shall
- 3 require as a condition of the contract that the contractor
- 4 agree to provide notification of data breaches in the same
- 5 manner as required of the Secretary under subsection (a).
- 6 "(c) METHOD AND CONTENT OF NOTIFICATION.—
- 7 (1) Notification provided to an individual under subsection
- 8 (a) shall be provided clearly and conspicuously by one of
- 9 the following methods:
- 10 "(A) Written notification.
- 11 "(B) Notification by email or other electronic
- means, if the Secretary's primary method of commu-
- nication with the individual is by email or such other
- 14 electronic means.
- 15 "(2) Regardless of the method by which notification
- 16 is provided to an individual under paragraph (1), such no-
- 17 tification shall include—
- 18 "(A) a description of the sensitive personal in-
- 19 formation involved in the data breach;
- 20 "(B) a telephone number that the individual
- 21 may use, at no cost to the individual, to contact an
- appropriate employee of the Department to inquire
- about the data breach or the individual's sensitive
- 24 personal information maintained by the Department;

- "(C) notice that the individual is entitled to re-1 2 ceive, at no cost to such individual, credit protection services under section 5724 of this title; 3 "(D) the toll-free contact telephone numbers 5 and addresses for the major credit reporting agen-6 cies; and 7 "(E) a toll-free telephone number and website 8 address whereby the individual may obtain informa-9 tion regarding identity theft. 10 "(d) Notification of General Public.—The Secretary, acting through the Office of Public Affairs of the Department, shall notify the general public concerning any data breach involving sensitive personal information by not later than five working days after the incident, unless 14 15 the Secretary determines that to do so is not feasible due to circumstances necessary to accurately identify the indi-16
- 19 ized disclosure and reasonably restore the integrity of the

viduals whose sensitive personal information is involved in

the data breach or to prevent further breach or unauthor-

- 20 data system, such notification shall be made as soon as
- 21 possible.
- 22 "(e) Appropriate Committees of Congress.—In
- 23 this section, the term 'appropriate committees of Con-
- 24 gress' means the Committee on Veterans Affairs' of the

- 1 House of Representatives and the Committee on Veterans'
- 2 Affairs of the Senate.".
- 3 (b) CLERICAL AMENDMENT.—The table of sections
- 4 at the beginning of such chapter is amended by inserting
- 5 after the item relating to section 5724 the following new
- 6 item:

"5724A. Data breach notification.".

- 7 (c) Effective Date.—The amendments made by
- 8 this section shall apply with respect to a data breach oc-
- 9 curring on or after the date that is 90 days after the date
- 10 of the enactment of this Act.
