### A BILL

To amend title 18, United States Code, to provide penalties for aiming laser pointers at airplanes, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Securing Aircraft
- 5 Cockpits Against Lasers Act of 2011".
- 6 SEC. 2. PROHIBITION AGAINST AIMING A LASER POINTER
- 7 AT AN AIRCRAFT.
- 8 (a) Offense.—Chapter 2 of title 18, United States
- 9 Code, is amended by adding at the end the following:
- 10 "§ 39A. Aiming a laser pointer at an aircraft
- 11 "(a) Whoever knowingly aims the beam of a laser
- 12 pointer at an aircraft in the special aircraft jurisdiction
- 13 of the United States, or at the flight path of such an air-
- 14 craft, shall be fined under this title or imprisoned not
- 15 more than 5 years, or both.
- 16 "(b) As used in this section, the term 'laser pointer'
- 17 means any device designed or used to amplify electro-
- 18 magnetic radiation by stimulated emission that emits a
- 19 beam designed to be used by the operator as a pointer
- 20 or highlighter to indicate, mark, or identify a specific posi-
- 21 tion, place, item, or object.
- 22 "(c) This section does not prohibit aiming a beam
- 23 of a laser pointer at an aircraft, or the flight path of such
- 24 an aircraft, by—

- "(1) an authorized individual in the conduct of 1 2 research and development or flight test operations conducted by an aircraft manufacturer, the Federal 3 Aviation Administration, or any other person authorized by the Federal Aviation Administration to con-5 6 duct such research and development or flight test 7 operations:
  - "(2) members or elements of the Department of Defense or Department of Homeland Security acting in an official capacity for the purpose of research, development, operations, testing or training; or
- 12 "(3) by an individual using a laser emergency 13 signaling device to send an emergency distress sig-14 nal.
- "(d) The Attorney General, in consultation with the Secretary of Transportation, may provide by regulation, 16
- 17 after public notice and comment, such additional excep-
- 18 tions to this section, as may be necessary and appropriate.
- 19 The Attorney General shall provide written notification of
- 20 any proposed regulations under this section to the Com-
- mittees on the Judiciary of the House and Senate, the 21
- 22 Committee on Transportation and Infrastructure in the
- 23 House, and the Committee on Commerce, Science and
- 24 Transportation in the Senate not less than 90 days before
- such regulations become final.". 25
