A BILL

To expand the workforce of veterinarians specialized in the care and conservation of wild animals and their ecosystems, and to develop educational programs focused on wildlife and zoological veterinary medicine.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.
- 4 (a) Short Title.—This Act may be referred to as
- 5 the "Wildlife Veterinarians Employment and Training
- 6 Act" or the "Wildlife VET Act".

3 SEC. 2. FINDINGS.

- 4 Congress makes the following findings:
- 5 (1) Fish and wildlife are important natural re-
- 6 sources of the United States. They belong to all citi-
- 7 zens, and are managed in perpetuity by State and
- 8 Federal conservation agencies, often with significant
- 9 assistance from universities, zoos, aquariums, and
- 10 nonprofit and non-governmental organizations.
- 11 (2) Wildlife and zoological veterinarians are the
- primary source of essential health care for wild ani-
- mals in their natural habitat and in captivity in fa-
- 14 cilities such as zoos, wildlife refuges, breeding re-
- serves, and aquariums.

- (3) Wildlife and zoological veterinarians have the resources and expertise necessary to help re-spond to environmental disasters and address short-term and long-term impacts on wildlife and their habitats. Wildlife and zoological veterinarians have proven to be essential to the rescue and rehabilita-tion efforts in the Gulf of Mexico region following the Deepwater Horizon oil spill that began on April 20, 2010.
 - (4) According to the Department of the Interior, wildlife disease expertise and resources are critical to protecting both human and animal life.
 - (5) Wildlife veterinarians have been actively involved in preventing, detecting, and responding to such important exotic, dangerous, and zoonotic diseases as anthrax, avian influenza, brucellosis, tuberculosis, West Nile virus, SARS, chronic wasting disease, and foot and mouth disease.
 - (6) Globalization, climate change, and wildlife habitat loss and alteration, along with a growing interface among humans, livestock, and wildlife have increased the threat posed by emerging infectious diseases to humans, domestic animals, and wildlife.
 - (7) According to the February 2009 report by the Government Accountability Office entitled "Vet-

- erinarian Workforce: Actions Are Needed to Ensure
 Sufficient Capacity for Protecting Public and Animal Health", the Nation is facing a growing shortage of veterinarians, and the Federal Government
 may not have the necessary veterinarian workforce
 to control pandemic and large-scale outbreaks of disease.
 - (8) There is a shortage of positions for wildlife and zoological veterinarians at the State, Federal, nonprofit, and university levels due to inadequate funding. According to the American Veterinary Medical Association ("AVMA"), less than one percent of AVMA members identify themselves as wildlife or zoological veterinarians.
 - (9) According to the AVMA, a growing number of students enter veterinary schools with an interest in wildlife or zoological veterinary medicine, but choose different fields of study and practice due to the small number of positions available for wildlife and zoological veterinarians upon graduation.
 - (10) Veterinary students face large educational debt upon graduation. According to the AVMA, graduating student loan debt averaged \$142,613 in 2011, a 6.5 percent increase from 2010.

- 1 (11) According to the American Association of 2 Wildlife Veterinarians ("AAWV") and National Association of Federal Veterinarians ("NAFV"), sala-3 ries for wildlife and zoological veterinarians are rel-5 atively low compared to the average salaries of vet-6 erinarians in companion animal medicine. Lower sal-7 aries, combined with high educational debt and the 8 small number of positions available in wildlife and 9 zoological veterinary medicine, discourage students 10 from pursuing careers in wildlife or zoological veterinary medicine.
 - (12) According to the AAWV and NAFV, most schools and colleges of veterinary medicine lack both a comprehensive curriculum and sufficient numbers of formal educational programs specializing in wildlife or zoological veterinary medicine to adequately prepare graduates for a competitive workplace.
 - (13) According to the AVMA, while some training opportunities exist for aspiring wildlife and zoological veterinarians, such opportunities are not available each year, pay low salaries or stipends, if any, and are highly competitive.
- 23 SEC. 3. PURPOSES.

24 The purposes of this Act are—

- 1 (1) to create new funded positions for wildlife 2 and zoological veterinarians;
- 3 (2) to limit the amount of educational debt for 4 veterinary medicine students while providing incen-5 tives to study and practice wildlife or zoological vet-6 erinary medicine;
- 7 (3) to help schools and colleges of veterinary 8 medicine develop or improve pilot curricula special-9 izing in wildlife and zoological veterinary medicine; 10 and
- 11 (4) to expand the number of training programs 12 in wildlife or zoological veterinary medicine for vet-13 erinary students.

14 SEC. 4. DEFINITIONS.

- For purposes of this Act, the following definitions 16 apply:
- 17 (1) Accredited school or college of vet-18 ERINARY MEDICINE.—The term "accredited school 19 or college of veterinary medicine" means an institu-20 tion of higher education (as defined in section 101 21 of the Higher Education Act of 1965 (20 U.S.C. 22 1001)) that provides an educational program for 23 which the institution awards a doctoral degree in 24 veterinary medicine.

- 1 (2) DOCTORAL DEGREE IN VETERINARY MEDI2 CINE.—The term "doctoral degree in veterinary medicine" means a doctor of veterinary medicine or veterinary medical doctor from an accredited school or college of veterinary medicine.
 - (3) Graduate degree in veterinary medicine" means a master's degree or Ph.D. in veterinary medicine or wildlife health management from an accredited school or college of veterinary medicine or a public or nonprofit department or school described in paragraph (8)(E).
 - (4) Secretary.—The term "Secretary" means the Secretary of the Interior.
 - (5) STATE OR TERRITORY.—The term "State or Territory" means each of the several States, the District of Columbia, the Commonwealth of Puerto Rico, Guam, American Samoa, the United States Virgin Islands, and the Commonwealth of the Northern Mariana Islands, and each federally recognized Indian tribe.
 - (6) VETERINARY MEDICINE.—The term "veterinary medicine" means all branches of, and specialties included within, the practice of veterinary medicine, including—

1	(A) the diagnosis, treatment, correction,
2	change, alleviation, prevention, management of,
3	or research on animal disease, illness, pain, de-
4	formity, defect, injury, or other physical, dental,
5	or mental conditions; and
6	(B) the management of ecosystems on
7	which wildlife and zoological populations de-
8	pend.
9	(7) WILDLIFE.—The term "wildlife" means any
10	member of the animal kingdom and includes mam-
11	mals, fish, birds, amphibians, reptiles, mollusks, or
12	arthropods. Such term does not include plant or
13	plant matter or any other member of another king-
14	dom.
15	(8) WILDLIFE OR VETERINARY INSTITUTION.—
16	The term "wildlife or veterinary institution"
17	means—
18	(A) any agency or department of a State
19	or Territory or of the Federal Government that
20	employs wildlife or zoological veterinarians, in-
21	cluding a wildlife conservation or natural re-
22	source management agency;
23	(B) a nonprofit wildlife conservation orga-
24	nization:

1	(C) a zoo or aquarium accredited by the
2	Association of Zoos and Aquariums;
3	(D) an accredited school or college of vet-
4	erinary medicine;
5	(E) a public or nonprofit department of
6	comparative medicine, department of veterinary
7	science, department of the environment and
8	natural resources, school of public health, or
9	school of medicine that is accredited by a na-
10	tionally recognized accrediting agency or asso-
11	ciation recognized by the Secretary of Edu-
12	cation;
13	(F) a State or Territory, national, allied,
14	or regional veterinary organization or specialty
15	board recognized by the American Veterinary
16	Medical Association; or
17	(G) a university research foundation or
18	veterinary medical foundation.
19	(9) Wildlife or zoological veteri-
20	NARIAN.—The term "wildlife or zoological veteri-
21	narian" means an individual who has received a doc-
22	toral degree in veterinary medicine from an accred-
23	ited school or college of veterinary medicine and
24	practices veterinary medicine as applied to wildlife

3	(4) ecology and wildlife population manage-

6	of endangered, threatened, and sensitive species.
7	(d) Amount of Grant.—The amount of a grant

9	tion shall be determined by the Secretary, taking into ac-
10	count such factors as the Secretary may consider appro-

12	(1) the contents of the proposal submitted by
13	the wildlife or veterinary institution under subsection

14	life and zoological veterinarians, the Secretary shall estab-

18	payments on their behalf for repayment of their edu-
19	cational loans.
20	(b) Eligible Individual.—For purposes of this
21	section, an individual shall be treated as an eligible indi-
22	vidual if the individual—
23	(1) is a United States citizen, national, or law-
24	ful permanent resident;
25	(2) either—

1	(A) has received, not before the date that
2	is 10 years prior to the date on which the indi-
3	vidual submits an application under paragraph
4	(3)—
5	(i) a doctoral degree in veterinary
6	medicine; or
7	(ii) a graduate degree in veterinary
8	medicine, providing that the individual re-
9	ceived such degree after receiving a doc-
10	toral degree in veterinary medicine;
11	that has been approved by the Secretary for

13	(B) is enrolled in a full-time or part-time
14	program that—

4	(c) AGREEMENT.—
5	(1) In general.—No payment shall be made
6	on behalf of an eligible individual under the Wildlife
7	and Zoological Veterinary Workforce Loan Repay-
8	ment Program unless the eligible individual has en-
9	tered into an agreement with the Secretary under
10	this subsection.
11	(2) Contents.—An agreement under this sub-
12	section shall contain—
13	(A) an agreement by the Secretary to
14	make payments under subsection (e); and
15	(B) an agreement by the eligible indi-
16	vidual—
17	(i) to serve for a period of no fewer
18	than 4 consecutive years at a wildlife or
19	veterinary institution as—
20	(I) a full-time wildlife or zoolog-
21	ical veterinarian; or
22	(II) with the approval of the Sec-
23	retary, a part-time wildlife or zoolog-
24	ical veterinarian, if no full-time posi-
25	tions are available; and

1	(ii) to complete the service in clause
2	(i) not later than 10 years after the later
3	of the date on which the eligible indi-
4	vidual—
5	(I) receives a doctoral or grad-
6	uate degree in veterinary medicine
7	under subsection (b)(2); and
8	(II) enters into the agreement
9	under subsection (a).
10	(d) Preference.—In making payments under this
11	section, the Secretary shall give preference to an eligible
12	individual who—
13	(1) holds or is pursuing a doctoral or graduate
14	degree in veterinary medicine with a specialty in
15	wildlife or zoological veterinary medicine; or
16	(2) is currently practicing wildlife or zoological
17	veterinary medicine.
18	(e) Payments.—
19	(1) In general.—Payments on behalf of an el-
20	igible individual under this section shall include pay-
21	ment of the principal and interest on the govern-
22	ment loans of the eligible individual, to the extent
23	that the loans cover such expenses as are determined
24	by the Secretary to be associated with obtaining a

1	doctoral or graduate degree in veterinary medicine
2	under subsection (b)(2), including—
3	(A) tuition expenses;
4	(B) reasonable living expenses; and
5	(C) all other reasonable educational ex-
6	penses incurred by the grantee, including fees,
7	laboratory expenses, and expenses for books
8	and equipment.
9	(2) Amount.—
10	(A) In general.—Subject to the limita-
11	tions in subparagraph (B), the Secretary shall
12	develop regulations to determine the amounts of
13	payments for each eligible individual under this
14	section, considering factors including—
15	(i) the degree held or pursued by the
16	eligible individual;
17	(ii) the training programs in which
18	the eligible individual has participated;
19	(iii) the total loan balance paid by the
20	eligible individual;
21	(iv) the extent to which such deter-
22	mination affects the ability of the Sec-
23	retary to maximize the number of agree-
24	ments that can be provided under this sec-

1	tion from the amounts appropriated for
2	such agreements; and
3	(v) the extent to which such deter-
4	mination provides an incentive to serve as
5	a wildlife or zoological veterinarian.
6	(B) Limitations.—Payments on behalf of
7	an eligible individual under this section shall
8	not exceed, for each year of service under sub-
9	section (c)(2)(B)(i)—
10	(i) \$35,000 in aggregate; or
11	(ii) if the total loans of the eligible in-
12	dividual are less than \$140,000, an
13	amount that does not exceed an amount
14	that is two-thirds of the eligible loan bal-
15	ance.
16	(3) PAYMENT SCHEDULE.—The Secretary may
17	enter into an agreement with the holder of any loan
18	for which payments are made to establish a schedule
19	for making payments under this subsection.
20	(f) Breach of Agreement.—
21	(1) In general.—Subject to paragraphs (2)
22	and (3), in the case of any agreement entered into
23	under subsection (a), an eligible individual shall be
24	liable to the Federal Government for an amount, as
25	determined by the Secretary, not to exceed the total

- amount of any payments made by the Secretary on behalf of the eligible individual under this section, and for interest on such amount at the maximum legal prevailing rate, as determined by the Treasurer of the United States, if the eligible individual fails to meet a term of the agreement in subsection (c)(2)(B).
 - (2) DEATH.—Any obligation of an eligible individual under the Wildlife and Zoological Veterinary Workforce Loan Repayment Program for service or payment of damages shall be cancelled upon the death of the eligible individual.
 - (3) WAIVER OR SUSPENSION OF LIABILITY.—
 The Secretary shall provide for the partial or total
 waiver or suspension of liability under paragraph
 (1), or of an obligation under subsection (e)(2), if—
 - (A) the eligible individual is called to active duty in the Armed Forces of the United States;
 - (B) compliance by the eligible individual with the agreement is impossible or would cause extreme hardship to the eligible individual; or
 - (C) enforcement of the agreement with respect to the eligible individual would be unconscionable.

- 1 (4) DATE CERTAIN FOR RECOVERY.—Any
 2 amount that the Federal Government is entitled to
 3 recover under paragraph (1) shall be paid to the
 4 United States not later than 3 years after the date
 5 on which the United States becomes so entitled.
 - (5) AVAILABILITY.—Amounts recovered under paragraph (1) shall be available to the Secretary for making payments under this section and shall remain available for such purpose until expended.

3	(c) Award.—
4	(1) In general.—No scholarship shall be
5	awarded to an eligible student under the Wildlife
6	and Zoological Veterinary Workforce Scholarship
7	Program until the Secretary has accepted the appli-
8	cation and written contract submitted by the eligible
9	student under subsection (b)(4).
10	(2) Notice.—The Secretary shall provide
11	prompt written notice to an individual upon the ac-
12	ceptance by the Secretary, under paragraph (1), of
13	a written contract.
14	(d) Written Contract.—A written contract be-
15	tween the Secretary and an eligible student under this
16	subsection shall contain—
17	(1) an agreement by the Secretary to provide
18	the eligible student with a scholarship for each year
19	of the course of study or program described in sub-
20	section (b)(3), for a period of no more than 4 years;
21	(2) an agreement by the eligible student to—
22	(A) accept the scholarship;
23	(B) maintain enrollment in the approved
24	course of study or program described in sub-

1	section (b)(3) until the individual completes the
2	course of study or program;
3	(C) maintain, over the course of the course
4	of study or program described in subsection
5	(b)(3), such level of academic standing as is de-
6	termined by the accredited school or college of
7	veterinary medicine, under regulations pre-
8	scribed by the Secretary, to be acceptable;
9	(D) commence service at a wildlife or vet-
10	erinary institution no later than 4 years after
11	the date the eligible student graduates from the
12	accredited school or college of veterinary medi-
13	cine; and
14	(E) serve at the wildlife or veterinary insti-
15	tution in subparagraph (D) for a period of no
16	fewer than 4 consecutive years as—
17	(i) a full-time wildlife or zoological
18	veterinarian; or
19	(ii) with the approval of the Secretary,
20	a part-time wildlife or zoological veteri-
21	narian, if no full-time positions are avail-
22	able;
23	(3) a provision that any financial obligation of
24	the United States arising out of a contract entered
25	into under this section and any obligation of the in-

1	dividual which is conditioned thereon, is contingent
2	upon funds being appropriated for scholarships
3	under this section;
4	(4) a statement of the damages to which the
5	United States shall be entitled, under subsection (i),
6	for a breach of contract; and
7	(5) such other statements of the rights and li-
8	abilities of the Secretary and of the individual as are
9	not inconsistent with the provisions of this title.
10	(e) Amount of Scholarship.—With respect to an
11	eligible student:
12	(1) In general.—Subject to the limitation in
13	paragraph (2), in determining the amount of a
14	scholarship, the Secretary shall consider factors in-
15	cluding—
16	(A) the degree that the eligible student is
17	pursuing or plans to pursue;
18	(B) educational costs;
19	(C) the financial need of the eligible stu-
20	dent;
21	(D) the extent to which such determination
22	affects the ability of the Secretary to maximize
23	the number of scholarships that can be provided
24	under this section from the amounts appro-
25	priated for such scholarships: and

1	(E) the extent to which such determination
2	provides an incentive to serve as a wildlife or
3	zoological veterinarian.
4	(2) Limitation.—The amount of a scholarship
5	shall not exceed \$35,000 for any school year.
6	(f) USE OF FUNDS.—Amounts received under a
7	scholarship under this section shall be used to cover such
8	expenses, with respect to an eligible student, as are deter-
9	mined by the Secretary to be appropriate, including—
10	(1) tuition expenses;
11	(2) reasonable living expenses; and
12	(3) all other reasonable educational expenses in-
13	curred by the eligible student, including fees, labora-
14	tory expenses, and expenses for books and equip-
15	ment.
16	(g) Payments to Educational Institution.—
17	Under the Wildlife and Zoological Veterinary Workforce
18	Scholarship Program, the Secretary may contract with the
19	accredited school or college of veterinary medicine in which
20	an eligible student is enrolled or has been accepted for
21	enrollment to make payments for tuition, reasonable living
22	expenses, and other reasonable educational expenses under
23	subsection (f).
24	(h) Breach of Contract.—

1	(1) Liability.—Subject to paragraphs (2) and
2	(3), an eligible student who has entered into a writ-
3	ten contract with the Secretary under this section
4	shall be liable to the United States for the following
5	amounts:
6	(A) Failure to complete course of
7	STUDY OR PROGRAM.—The eligible student
8	shall be liable for the total amount that has
9	been paid to the eligible student under this sec-
10	tion, and for interest on such amount at the
11	maximum legal prevailing rate, as determined
12	by the Treasurer of the United States, if, under
13	the course of study or program under sub-
14	section (b)(2), the eligible student—
15	(i) fails to maintain an acceptable
16	level of academic standing under sub-
17	section $(d)(2)(C)$;
18	(ii) is dismissed from the accredited
19	school or college of veterinary medicine for
20	disciplinary reasons; or
21	(iii) voluntarily ceases to participate
22	in the course of study or program before
23	completion of the course of study or pro-
24	gram.

1	(B) Failure to complete service ob-
2	LIGATION.—The eligible student shall be liable
3	for an amount, as determined by the Secretary,
4	not to exceed the total amount that has been
5	awarded to the eligible student under this sec-
6	tion, and for interest on such amount at the
7	maximum legal prevailing rate, as determined
8	by the Treasurer of the United States, if the el-
9	igible student fails to begin or complete the
10	service obligation under subsection $(d)(2)(D)$.
11	(2) Death.—Any obligation of an eligible stu-
12	dent under the Wildlife and Zoological Veterinary
13	Workforce Scholarship Program for service or pay-
14	ment of damages shall be cancelled upon the death
15	of the eligible student.
16	(3) Waiver or suspension of liability.—
17	The Secretary shall provide for the partial or total
18	waiver or suspension of liability under paragraph
19	(1), or of an obligation under subsection (d)(2), if—
20	(A) the eligible student is called to active
21	duty in the Armed Forces of the United States;
22	(B) compliance by the eligible student with
23	the written contract is impossible or would
24	cause extreme hardship to the eligible student;

or

- 1 (C) enforcement of the written contract 2 with respect to the eligible student would be un-3 conscionable.
- 4 (4) DATE CERTAIN FOR RECOVERY.—Any
 5 amount that the Federal Government is entitled to
 6 recover under paragraph (1) shall be paid to the
 7 United States not later than 3 years after the date
 8 the United States becomes so entitled.
 - (5) AVAILABILITY.—Amounts recovered under paragraph (1) shall be available to the Secretary for making loan repayments under this section and shall remain available for such purpose until expended.
- 13 (6) REGULATIONS.—Prior to implementation of 14 the Wildlife and Zoological Veterinary Workforce 15 Scholarship Program, the Secretary shall establish, 16 by regulation, procedures for determining the 17 amount of the repayment required under paragraph 18 (1).
- 19 (i) AUTHORIZATION OF APPROPRIATIONS.—There is 20 authorized to be appropriated to carry out this section 21 \$3,000,000 for each of fiscal years 2012 through 2016. 22 Amounts appropriated under this subsection are author-
- 23 ized to remain available until expended.

5	SEC. 201. GRANTS TO ACCREDITED SCHOOLS AND COL-
6	LEGES OF VETERINARY MEDICINE FOR CUR-

9	(a) Establishment.—Not later than 1 year after
10	the date of enactment of this Act, the Secretary shall es-
11	tablish a pilot program to award grants to accredited
12	schools and colleges of veterinary medicine to develop or
13	improve new or existing curricula that specialize in wildlife
14	or zoological veterinary medicine, to be available to veteri-
15	nary students in the final years of a program for which
16	the accredited schools or colleges of veterinary medicine
17	award a doctoral degree in veterinary medicine.
18	(b) Eligibility.—To be eligible for a grant under
19	this section, an accredited school or college of veterinary
20	medicine shall submit to the Secretary a proposal—

22	as the Secretary may require; and
23	(2) containing such information as the Sec-
24	retary may require, including a description of—

1	(A) the proposed curriculum in wildlife or
2	zoological veterinary medicine under subsection

7	(c) AWARD.—The Secretary shall establish proce-
8	dures to ensure that proposals are rigorously reviewed and

19	SEC. 202. GRANTS TO DEVELOP TRAINING PROGRAMS IN

22	(a) In General.—The Secretary shall award com-
23	petitive grants to eligible wildlife or veterinary institutions
24	to establish or expand, for traineeship candidates, training
25	programs that will enhance the ability of a trainee to prac-

1	tice as a wildlife or zoological veterinarian, as determined
2	by the Secretary of the Interior. Such training programs
3	may include externship, internship, fellowship, or resi-
4	dency programs.
5	(b) Eligible Wildlife or Veterinary Institu-
6	TION.—To be eligible for a grant under this section, a
7	wildlife or veterinary institution shall submit to the Sec-
8	retary a proposal designed to create or expand one or more
9	training programs for traineeship candidates. The pro-
10	posal—
11	(1) shall be submitted at such time and in such
12	form and manner as the Secretary may require; and
13	(2) shall contain such information as the Sec-
14	retary may require, including a description of—
15	(A) each training program to be created or
16	expanded;
17	(B) the skills to be imparted by each train-
18	ing program;
19	(C) how the wildlife or veterinary institu-
20	tion will use the funds provided under a grant;
21	and
22	(D) how each training program will help a
23	trainee advance conservation and management
24	goals for wildlife or zoological animal popu-
25	lations.

1	(c) Consideration of Proposals.—
2	(1) Preference.—In awarding a grant under
3	this section, the Secretary shall give preference to an
4	eligible wildlife or veterinary institution offering a
5	training program—
6	(A) at rotating sites, particularly in the
7	case of a residency program; and
8	(B) under which trainees conduct research
9	and teach veterinary students.
10	(2) Procedures.—The Secretary shall estab-
11	lish procedures to ensure that proposals are rigor-
12	ously reviewed and that grants are competitively
13	awarded.
14	(d) Traineeship Candidate.—For purposes of this
15	section, an individual shall be treated as a traineeship can-
16	didate if the individual—
17	(1) is a citizen of the United States, a national,
18	or a lawful permanent resident;
19	(2) expresses a profound interest in wildlife or
20	zoological veterinary medicine and a commitment to
21	becoming a wildlife or zoological veterinarian; and
22	(3) has submitted to a wildlife or veterinary in-
23	stitution offering a training program under sub-
24	section (a) an application for the training program

1	containing such information as may be required by
2	the wildlife or veterinary institution.
3	(e) Financial Assistance Under Training Pro-
4	GRAM.—Under a training program, a trainee shall, for the
5	duration of the training program, be provided with—
6	(1) a stipend, in an amount based on criteria
7	to be determined by the wildlife or veterinary insti-
8	tution, including—
9	(A) the type and length of the training
10	program;
11	(B) the responsibilities assigned to the
12	trainee as part of the training program;
13	(C) the academic level or degree held by
14	the trainee; and
15	(D) the relevant experience of the trainee;
16	and
17	(2) such other financial assistance as the wild-
18	life or veterinary institution determines necessary
19	and is approved by the Secretary.
20	(f) Approval of Placement Under Training
21	Program.—
22	(1) In General.—No traineeship candidate
23	shall be placed in a training program without the
24	approval of the Secretary.

1	(2) Notice.—A traineeship candidate shall be
2	informed of placement in a training program upon
3	approval by the Secretary.
4	(g) Amount of Grant.—The Secretary shall deter-
5	mine the amount of a grant awarded under this section
6	for a training program, taking into account such factors
7	as the Secretary considers appropriate, including—
8	(1) the type of training that the wildlife or vet-
9	erinary institution desires to create or expand;
10	(2) the contents of the proposal submitted by
11	the wildlife or veterinary institution under subsection
12	(b); and
13	(3) the number of grants available to all wildlife
14	or veterinary institutions.
15	(h) USE OF GRANT FUNDS.—Under this section,
16	amounts received under a grant shall be applied to such
17	costs as the Secretary considers appropriate for the plan-
18	ning, development, and operation of the training program,
19	including the costs associated with—
20	(1) the development of the curriculum to be
21	used in the program;
22	(2) practicum experiences;
23	(3) the acquisition of new equipment; and
24	(4) the stipend and other financial assistance
25	provided to the trainee under subsection (e)
