A BILL

To reduce the operating costs of the United States Postal Service, to provide for continued postal services for certain areas, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting Post Offices
5 Act”.

6 **SEC. 2. CALCULATION OF POSTAL SERVICE RETIREE**
7 **HEALTH BENEFIT PAYMENTS.**

8 Section 8909a(d)(3) of title 5, United States Code,
9 is amended as follows:

10 (1) Subparagraph (A) is repealed.

1 (2) In subparagraph (B), by striking “2017”
2 and inserting “2012”.

3 **SEC. 3. NONPOSTAL SERVICES; POST OFFICE CLOSURES.**

4 (a) NONPOSTAL SERVICES.—Subsection (a) of sec-
5 tion 404 of title 39, United States Code, is amended—

6 (1) in paragraph (7), by striking “and” at the
7 end;

8 (2) in paragraph (8), by striking the period and
9 inserting “; and”; and

10 (3) by adding at the end the following:

11 “(9) to provide nonpostal services.”.

12 (b) POST OFFICE CLOSURES.—Subsection (e) of such
13 section is amended to read as follows:

14 “(e)(1) Notwithstanding subsections (a)(3) or (d),
15 the Postal Service may not close or consolidate any post
16 office or other postal facility that is located in a ZIP Code
17 that has a high rate of poverty and a high rate of unem-
18 ployment. To determine whether a ZIP Code has a high
19 rate of poverty or unemployment, the Postmaster General
20 shall consult with the Secretary of Commerce and the Sec-
21 retary of Labor.

22 “(2) Not later than 1 year after the date of enact-
23 ment of this subsection, the Postmaster General shall sub-
24 mit a report to Congress on alternative uses with respect

1 to under-used postal facilities, including whether such fa-
2 cilities could offer nonpostal services and products.”.

3 **SEC. 4. RATE REGULATION FOR MARKET-DOMINANT PROD-**
4 **UCTS.**

5 (a) IN GENERAL.—Notwithstanding section 3622 of
6 title 39, United States Code, the Postmaster General shall
7 have the authority to regulate rates for market-dominant
8 products. Such authority shall not apply to the rate dis-
9 counts established under subsection (e) of such section.

10 (b) NOTIFICATION.—If the Postmaster General de-
11 termines under subsection (a) that an adjustment in a rate
12 for a market-dominant product is necessary, the Post-
13 master General shall provide public notice of such adjust-
14 ment not later than 45 days before the implementation
15 of such adjustment.

16 (c) CONSUMER PRICE INDEX.—In determining
17 whether an adjustment in a rate for a market-dominant
18 product is reasonable, the Postmaster General may com-
19 pare the percentage change of such adjustment with the
20 percentage change of the Consumer Price Index for All
21 Urban Consumers unadjusted for seasonal variation dur-
22 ing the 12-month period preceding the date the Post-
23 master General files notice of such adjustment pursuant
24 to subsection (b).
