10	FOR CERTAIN FDUS LOANS.—The Secretary of Edu-
11	cation shall provide an opportunity for each bor-
12	rower who has a Federal Direct Unsubsidized Staf-
13	ford Loan that was made before the date of enact-
14	ment of this section and who has not yet entered re-
15	payment on such loan on the date that is 60 days
16	after such date of enactment to elect a 12-month
17	grace period, in accordance with section $428(b)(7)$ of
18	the Higher Education Act of 1965, as amended by
19	this subsection, before beginning repayment. The
20	Secretary shall—
21	(A) notify each such borrower of the op-
22	portunity for such an election not later than 30
23	days after such date of enactment;

(B) advise each such borrower of the financial consequences of electing such 12-month grace period;

4 (C) not require such a borrower to accept 5 a 12-month grace period in accordance with 6 section 428(b)(7) of the Higher Education Act 7 of 1965 (as amended by this subsection), unless 8 the borrower specifically elects such 12-month 9 grace period during the 90-day period begin-10 ning on the day the Secretary notifies such bor-11 rower of the option to elect such a 12-month 12 grace period, except that a borrower shall make 13 such an election no later than 10 days before 14 the start of the borrower's repayment period, as 15 determined under section 428(b)(7) of the 16 Higher Education Act of 1965 as in effect on 17 the day before the date of enactment of this 18 section; and

(D) in the case of such a borrower who
does not elect such a 12-month grace period
during the period described in subparagraph
(C), determine the start of the borrower's repayment period in accordance with section
428(b)(7) of the Higher Education Act of 1965
