1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FEE DISCLOSURE REQUIREMENT.**

4 Section 904(d)(3)(B) of the Consumer Credit Protec-
5 tion Act (15 U.S.C. 1693b(d)(3)(B)) (commonly known
6 as the “Electronic Fund Transfer Act”) is amended—

7 (1) by striking “REQUIREMENTS.” and all that
8 follows through “The notice required under clauses
9 (i) and (ii)” and inserting “REQUIREMENT.—The
10 notice required under clauses (i) and (ii)” after
11 “NOTICE”; and

12 (2) by striking “, except that during the period
13 beginning” and all that follows and inserting a pe-
14 riod.
