## A BILL

To increase Federal Pell Grants for the children of fallen  
police officers, firefighters, and other public safety officers.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Children of Fallen He-  
5 roes Scholarship Act of 2012”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

8 (1) 2011 was a deadly year for law enforcement  
9 officers, with 163 men and women killed in the line

1 of duty, which is a 15 percent increase from the  
2 number of law enforcement officers killed in the line  
3 of duty in 2010. In 2011, 80 firefighters lost their  
4 lives and 19 paramedics suffered fatalities in the line  
5 of duty.

6 (2) Congress recognizes the sacrifice of the  
7 families of fallen public safety officers.

8 (3) The financial loss for a family with children  
9 could be detrimental for decades.

10 (4) Families who have given the ultimate sac-  
11 rifice deserve the support of the American people as  
12 their children pursue higher education.

13 **SEC. 3. CALCULATION OF FEDERAL PELL GRANT ELIGI-**  
14 **BILITY.**

15 Section 401(f) of the Higher Education Act of 1965  
16 (20 U.S.C. 1070a(f)) is amended by adding at the end  
17 the following new paragraph:

18 “(4)(A) Notwithstanding paragraph (1) or any  
19 other provision of this section, the expected family  
20 contribution of each student described in subpara-  
21 graph (B) shall be deemed to be zero for the period  
22 during which each such student is eligible to receive  
23 a Federal Pell Grant under subsection (c).

24 “(B) Subparagraph (A) shall apply to any stu-  
25 dent at an institution of higher education—

1 “(i) whose parent or guardian—

2 “(I) was actively serving as a police  
3 officer, firefighter, or other public safety  
4 officer; and

5 “(II) died as a result of performing a  
6 public safety service; and

7 “(ii) who was 18 years or less, or was en-  
8 rolled as a full-time or part-time student at an  
9 institution of higher education, as of the time  
10 of the parent or guardian’s death.

11 “(C) For purposes of this paragraph—

12 “(i) the term ‘police officer, firefighter, or  
13 other public safety officer’ means an individual  
14 who—

15 “(I) is a law enforcement officer or  
16 firefighter in a police department or fire  
17 department which is organized and oper-  
18 ated by a State or political subdivision to  
19 provide police protection, firefighting serv-  
20 ices, or emergency medical services for any  
21 area within the jurisdiction of such State  
22 or political subdivision;

23 “(II) is an emergency medical services  
24 provider who provides out-of-hospital emer-

1           gency medical care, including an emer-  
2           gency medical technician or paramedic; or

3           “(III) is a member of a qualified vol-  
4           unteer emergency response organization  
5           who provides firefighting services or emer-  
6           gency medical services; and

7           “(ii) the term ‘qualified volunteer emer-  
8           gency response organization’ means any volun-  
9           teer organization that—

10           “(I) is organized and operated to pro-  
11           vide firefighting or emergency medical  
12           services for persons in the State or polit-  
13           ical subdivision, as the case may be; and

14           “(II) is required (by written agree-  
15           ment) by the State or political subdivision  
16           to furnish firefighting or emergency med-  
17           ical services in such State or political sub-  
18           division.”.

19 **SEC. 4. EFFECTIVE DATE.**

20           The amendment made by section 3 of this Act shall  
21           apply with respect to Federal Pell Grants awarded for aca-  
22           demic year 2013–2014, and each succeeding academic  
23           year.
