## A BILL

To acknowledge donor contributions at the Vietnam Veterans Memorial Visitor Center, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. DONOR CONTRIBUTION ACKNOWLEDGMENTS**

4                       **AT THE VIETNAM VETERANS MEMORIAL VIS-**  
5                       **ITOR CENTER.**

6       (a) SHORT TITLE.—This Act may be cited as the  
7       “Vietnam Veterans Donor Acknowledgment Act of 2012”.

1 (b) DONOR CONTRIBUTION ACKNOWLEDGMENTS.—  
2 Section 6(b) of Public Law 96–297 (16 U.S.C. 431 note)  
3 is amended—

4 (1) in paragraph (4) by striking the “and”  
5 after the semicolon;

6 (2) in paragraph (5) by striking the period and  
7 inserting “; and”; and

8 (3) by inserting at the end the following new  
9 paragraph:

10 “(6) the Secretary of the Interior shall—

11 “(A) acknowledge a donor contribution, in  
12 the form of a permanent statement or credit  
13 line expressing appreciation for such contribu-  
14 tion, inside the visitor center, if—

15 “(i) the donor or the Vietnam Vet-  
16 erans Memorial Fund, Inc. provides the  
17 Secretary with—

18 “(I) such statement or credit  
19 line; or

20 “(II) a plan describing such  
21 statement or credit line and, if the  
22 Secretary accepts the plan for the  
23 statement or credit line under clause  
24 (ii), funding to create such statement  
25 or credit line; and

1           “(ii) the Secretary, in consultation  
2           with the National Capital Planning Com-  
3           mission and Commission of Fine Arts, de-  
4           termines such statement or credit line—

5                     “(I) to be short, discrete, and un-  
6                     obtrusive; and

7                     “(II) does not contain an adver-  
8                     tising slogan or company logo; and

9           “(B) in the case that the Secretary deter-  
10          mines that a statement or credit line provided  
11          under subparagraph (A)(i) does not meet the  
12          requirements under subparagraph (A)(ii)—

13                    “(i) advise the donor or the Vietnam  
14                    Veterans Memorial Fund, Inc. within 15  
15                    days of receipt of such statement or credit  
16                    line under subparagraph (A)(i) of the rea-  
17                    sons that such statement or credit line  
18                    does not meet the requirements under sub-  
19                    paragraph (A)(ii); and

20                    “(ii) allow the donor or the Vietnam  
21                    Veterans Memorial Fund, Inc. to submit a  
22                    corrected statement or credit line.”.
