## A BILL

To provide for Inspector General oversight for Federal entities not otherwise subject to such oversight, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Inspector General Im-  
5 provement Act of 2012”.

6 **SEC. 2. ASSIGNMENT OF INSPECTOR GENERAL TO CERTAIN**  
7 **FEDERAL ENTITIES.**

8 (a) AGENCY FOR INTERNATIONAL DEVELOPMENT.—  
9 In addition to the other duties and responsibilities speci-  
10 fied in the Inspector General Act of 1978 (5 U.S.C. App.)

1 the Inspector General of the Agency for International De-  
2 velopment shall supervise, direct, and control audit and  
3 investigative activities (relating to such audits) pertaining  
4 to programs and operations within each of the following:

5 (1) Trade and Development Agency.

6 (2) Japan–United States Friendship Commis-  
7 sion.

8 (3) Overseas Private Investment Corporation.

9 (b) BOARD OF GOVERNORS OF THE FEDERAL RE-  
10 SERVE SYSTEM.—In addition to the other duties and re-  
11 sponsibilities specified in the Inspector General Act of  
12 1978 (5 U.S.C. App.) the Inspector General of the Board  
13 of Governors of the Federal Reserve System shall super-  
14 vise, direct, and control audit and investigative activities  
15 (relating to such audits) pertaining to programs and oper-  
16 ations within the Financial Institutions Examination  
17 Council.

18 (c) DEPARTMENT OF DEFENSE.—In addition to the  
19 other duties and responsibilities specified in the Inspector  
20 General Act of 1978 (5 U.S.C. App.) the Inspector Gen-  
21 eral of the Department of Defense shall supervise, direct,  
22 and control audit and investigative activities (relating to  
23 such audits) pertaining to programs and operations within  
24 the Selective Service System.

1 (d) DEPARTMENT OF EDUCATION.—In addition to  
2 the other duties and responsibilities specified in the In-  
3 spector General Act of 1978 (5 U.S.C. App.) the Inspector  
4 General of the Department of Education shall supervise,  
5 direct, and control audit and investigative activities (relat-  
6 ing to such audits) pertaining to programs and operations  
7 within each of the following:

8 (1) James Madison Memorial Fellowship Foun-  
9 dation.

10 (2) Christopher Columbus Fellowship Founda-  
11 tion.

12 (3) Morris K. Udall and Stewart L. Udall  
13 Foundation.

14 (4) Barry M. Goldwater Scholarship and Excel-  
15 lence in Education Program.

16 (5) Vietnam Education Foundation.

17 (6) Harry S Truman Scholarship Foundation.

18 (7) National Council on Disability.

19 (e) FEDERAL LABOR RELATIONS AUTHORITY.—In  
20 addition to the other duties and responsibilities specified  
21 in the Inspector General Act of 1978 (5 U.S.C. App.) the  
22 Inspector General of the Federal Labor Relations Author-  
23 ity shall supervise, direct, and control audit and investiga-  
24 tive activities (relating to such audits) pertaining to pro-

1 grams and operations within the National Mediation  
2 Board.

3 (f) DEPARTMENT OF HEALTH AND HUMAN SERV-  
4 ICES.—In addition to the other duties and responsibilities  
5 specified in the Inspector General Act of 1978 (5 U.S.C.  
6 App.) the Inspector General of the Department of Health  
7 and Human Services shall supervise, direct, and control  
8 audit and investigative activities (relating to such audits)  
9 pertaining to programs and operations within each of the  
10 following:

11 (1) Architectural and Transportation Barriers  
12 Compliance Board (Access Board).

13 (2) U.S. Interagency Council on Homelessness.

14 (3) Medicare Payment Advisory Commission.

15 (g) DEPARTMENT OF HOMELAND SECURITY.—In ad-  
16 dition to the other duties and responsibilities specified in  
17 the Inspector General Act of 1978 (5 U.S.C. App.) the  
18 Inspector General of the Department of Homeland Secu-  
19 rity shall supervise, direct, and control audit and inves-  
20 tigative activities (relating to such audits) pertaining to  
21 programs and operations within the Commission on the  
22 Prevention of Weapons of Mass Destruction Proliferation  
23 and Terrorism.

24 (h) DEPARTMENT OF THE INTERIOR.—In addition to  
25 the other duties and responsibilities specified in the In-

1 spector General Act of 1978 (5 U.S.C. App.) the Inspector  
2 General of the Department of the Interior shall supervise,  
3 direct, and control audit and investigative activities (relat-  
4 ing to such audits) pertaining to programs and operations  
5 within each of the following:

6 (1) Arctic Research Commission.

7 (2) Office of the Federal Coordinator for Alas-  
8 ka Natural Gas Transportation.

9 (3) Valles Caldera Trust.

10 (4) International Boundary Commission: United  
11 States and Canada.

12 (5) International Joint Commission: United  
13 States and Canada.

14 (6) Office of Navajo and Hopi Indian Reloca-  
15 tion.

16 (7) Utah Reclamation Mitigation and Conserva-  
17 tion Commission.

18 (8) Dwight D. Eisenhower Memorial Commis-  
19 sion.

20 (9) The portion of the Presidio managed by the  
21 National Park Service.

22 (10) International Boundary and Water Com-  
23 mission.

24 (i) DEPARTMENT OF LABOR.—In addition to the  
25 other duties and responsibilities specified in the Inspector

1 General Act of 1978 (5 U.S.C. App.) the Inspector Gen-  
2 eral of the Department of Labor shall supervise, direct,  
3 and control audit and investigative activities (relating to  
4 such audits) pertaining to programs and operations within  
5 each of the following:

6 (1) Occupational Safety and Health Review  
7 Commission.

8 (2) Federal Mine Safety and Health Review  
9 Commission.

10 (3) Federal Mediation Conciliation Service.

11 (j) DEPARTMENT OF STATE.—In addition to the  
12 other duties and responsibilities specified in the Inspector  
13 General Act of 1978 (5 U.S.C. App.) the Inspector Gen-  
14 eral of the Department of State shall supervise, direct, and  
15 control audit and investigative activities (relating to such  
16 audits) pertaining to programs and operations within the  
17 United States Commission on International Religious  
18 Freedom.

19 (k) DEPARTMENT OF THE TREASURY.—In addition  
20 to the other duties and responsibilities specified in the In-  
21 spector General Act of 1978 (5 U.S.C. App.) the Treasury  
22 Inspector General for Tax Administration shall supervise,  
23 direct, and control audit and investigative activities (relat-  
24 ing to such audits) pertaining to programs and operations  
25 within the United States Tax Court.

1           (l) ENVIRONMENTAL PROTECTION AGENCY.—In ad-  
2 dition to the other duties and responsibilities specified in  
3 the Inspector General Act of 1978 (5 U.S.C. App.) the  
4 Inspector General of the Environmental Protection Agen-  
5 cy shall supervise, direct, and control audit and investiga-  
6 tive activities (relating to such audits) pertaining to pro-  
7 grams and operations within the Marine Mammal Com-  
8 mission.

9           (m) GENERAL SERVICES ADMINISTRATION.—In ad-  
10 dition to the other duties and responsibilities specified in  
11 the Inspector General Act of 1978 (5 U.S.C. App.) the  
12 Inspector General of the General Services Administration  
13 shall supervise, direct, and control audit and investigative  
14 activities (relating to such audits) pertaining to programs  
15 and operations within each of the following:

- 16           (1) National Capital Planning Commission.  
17           (2) Commission of Fine Arts.  
18           (3) Committee for Purchase from People Who  
19           Are Blind or Severely Disabled.

20           (n) GOVERNMENT ACCOUNTABILITY OFFICE.—In  
21 addition to the other duties and responsibilities specified  
22 in section 705 of title 31, United States Code, the Inspec-  
23 tor General of the Government Accountability Office shall  
24 supervise, direct, and control audit and investigative ac-  
25 tivities (relating to such audits) pertaining to programs

1 and operations within the Administrative Conference of  
2 the United States.

3 (o) INTELLIGENCE COMMUNITY.—In addition to the  
4 other duties and responsibilities specified in section 103H  
5 of the National Security Act of 1947 (50 U.S.C. 403–3h),  
6 the Inspector General of the Intelligence Community shall  
7 supervise, direct, and control audit and investigative ac-  
8 tivities (relating to such audits) pertaining to programs  
9 and operations within the Public Interest Declassification  
10 Board.

11 (p) NATIONAL ARCHIVES AND RECORDS ADMINIS-  
12 TRATION.—In addition to the other duties and responsibil-  
13 ities specified in the Inspector General Act of 1978 (5  
14 U.S.C. App.) the Inspector General of the National Ar-  
15 chives and Records Administration shall supervise, direct,  
16 and control audit and investigative activities (relating to  
17 such audits) pertaining to programs and operations within  
18 the Advisory Council on Historic Preservation.

19 (q) NUCLEAR REGULATORY COMMISSION.—In addi-  
20 tion to the other duties and responsibilities specified in  
21 the Inspector General Act of 1978 (5 U.S.C. App.) the  
22 Inspector General of the Nuclear Regulatory Commission  
23 shall supervise, direct, and control audit and investigative  
24 activities (relating to such audits) pertaining to programs



1 and operations within the Nuclear Waste Technical Re-  
2 view Board.

3 (r) OFFICE OF PERSONNEL MANAGEMENT.—In addi-  
4 tion to the other duties and responsibilities specified in  
5 the Inspector General Act of 1978 (5 U.S.C. App.) the  
6 Inspector General of the Office of Personnel Management  
7 shall supervise, direct, and control audit and investigative  
8 activities (relating to such audits) pertaining to programs  
9 and operations within the Federal Retirement Thrift In-  
10 vestment Board.

11 (s) SMITHSONIAN INSTITUTION.—In addition to the  
12 other duties and responsibilities specified in the Inspector  
13 General Act of 1978 (5 U.S.C. App.) the Inspector Gen-  
14 eral of the Smithsonian Institution shall supervise, direct,  
15 and control audit and investigative activities (relating to  
16 such audits) pertaining to programs and operations within  
17 the United States Holocaust Memorial Museum.
