## A BILL

To rescind the third round of funding for the Neighborhood Stabilization Program and to terminate the program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “NSP Termination  
5 Act”.

6 **SEC. 2. RESCISSION OF \$1 BILLION FUNDING FOR 3RD**  
7 **ROUND OF NEIGHBORHOOD STABILIZATION**  
8 **PROGRAM.**

9 Effective on the date of the enactment of this Act,  
10 there are rescinded and permanently canceled all unobli-

1 gated balances remaining available as of such date of en-  
2 actment of the amounts made available by section 1497(a)  
3 of the Dodd-Frank Wall Street Reform and Consumer  
4 Protection Act (Public Law 111–203; 124 Stat. 2209; 42  
5 U.S.C. 5301 note).

6 **SEC. 3. TERMINATION OF NEIGHBORHOOD STABILIZATION**  
7 **PROGRAM.**

8 (a) REPEAL.—Sections 2301 through 2303 of the  
9 Housing and Economic Recovery Act of 2008 (Public Law  
10 110–289; 122 Stat. 2850; 42 U.S.C. 5301 note) are here-  
11 by repealed.

12 (b) TREATMENT OF REMAINING FUNDS.—

13 (1) SAVINGS CLAUSE.—Notwithstanding the re-  
14 peal under subsection (a), any amounts made avail-  
15 able under the provisions specified in paragraph (2)  
16 of this subsection shall continue to be governed by  
17 any provisions of law applicable to such amounts as  
18 in effect immediately before such repeal.

19 (2) REMAINING FUNDS.—The provisions speci-  
20 fied in this paragraph are as follows:

21 (A) Section 2301(a) of the Housing and  
22 Economic Recovery Act of 2008 (Public Law  
23 110–289; 122 Stat. 2850; 42 U.S.C. 5301  
24 note).

1           (B) The second undesignated paragraph  
2           under the heading “Department of Housing  
3           and Urban Development, Community Planning  
4           and Development, Community Development  
5           Fund” in title XII of division A of the Amer-  
6           ican Recovery and Reinvestment Act of 2009  
7           (Public Law 111–5, 123 Stat. 217).

8           (c) TERMINATION.—Upon the obligation of all  
9           amounts made available under the provisions specified in  
10          subsection (b)(2), and outlays to liquidate all such  
11          amounts, the Secretary of Housing and Urban Develop-  
12          ment shall terminate the Neighborhood Stabilization Pro-  
13          gram authorized under the provisions specified in sub-  
14          sections (a) and (b)(2).
