# 1SEC. 2. HEALTH CARE PROVIDER LICENSURE CANNOT BE2CONDITIONED ON PARTICIPATION IN A3HEALTH PLAN.

# (1) HEALTH PLAN.—The term "health plan" has the meaning given such term in section 1171(5) of the Social Security Act (42 U.S.C. 1320d(5)), and includes a basic health program established under section 1331 of the Patient Protection and

15 16 Affordable Care Act (Public Law 111–148), a quali-17 fied health plan offered by a qualified nonprofit 18 health insurance issuer under the Consumer Oper-19 ated and Oriented Plan (CO-OP) program under 20 section 1322 of such Act, a qualified health plan of-21 fered under a health care choice compact under sec-22 tion 1333 of such Act, a multi-state qualified health plan offered under section 1334 of such Act, or 23 24 other health plan offered under title I of such Act. 25 (2)Health CARE PROVIDER.—The term

that is required by State or Federal laws or regula tions to be licensed, registered, or certified to pro vide health care services and is so licensed, reg istered, or certified, or exempted from such require ment by other statute or regulation.
