## **RESOLUTION**

Providing for consideration of the bill (H.R. 2017) making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2012, and for other purposes.

- 1 Resolved, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 2(b) of
- 3 rule XVIII, declare the House resolved into the Committee
- 4 of the Whole House on the state of the Union for consider-
- 5 ation of the bill (H.R. 2017) making appropriations for
- 6 the Department of Homeland Security for the fiscal year

- 1 ending September 30, 2012, and for other purposes. The
- 2 first reading of the bill shall be dispensed with. All points
- 3 of order against consideration of the bill are waived. Gen-
- 4 eral debate shall be confined to the bill and shall not ex-
- 5 ceed one hour equally divided and controlled by the chair
- 6 and ranking minority member of the Committee on Appro-
- 7 priations. After general debate the bill shall be considered
- 8 for amendment under the five-minute rule. Points of order
- 9 against provisions in the bill for failure to comply with
- 10 clause 2 of rule XXI are waived except for section 536.
- 11 During consideration of the bill for amendment, the chair
- 12 of the Committee of the Whole may accord priority in rec-
- 13 ognition on the basis of whether the Member offering an
- 14 amendment has caused it to be printed in the portion of
- 15 the Congressional Record designated for that purpose in
- 16 clause 8 of rule XVIII. Amendments so printed shall be
- 17 considered as read. When the committee rises and reports
- 18 the bill back to the House with a recommendation that
- 19 the bill do pass, the previous question shall be considered
- 20 as ordered on the bill and amendments thereto to final
- 21 passage without intervening motion except one motion to
- 22 recommit with or without instructions.
- SEC. 2. (a) Pending the adoption of a concurrent res-
- 24 olution on the budget for fiscal year 2012, the provisions
- 25 of House Concurrent Resolution 34, as adopted by the

- 1 House, shall have force and effect (with the modification
- 2 specified in subsection (c)) in the House as though Con-
- 3 gress has adopted such concurrent resolution. The alloca-
- 4 tions printed in the report of the Committee on Rules ac-
- 5 companying this resolution shall be considered for all pur-
- 6 poses in the House to be the allocations under section
- 7 302(a) of the Congressional Budget Act of 1974 for the
- 8 concurrent resolution on the budget for fiscal year 2012.
- 9 (b) The chair of the Committee on the Budget shall
- 10 adjust the allocations referred to in subsection (a) to ac-
- 11 commodate the enactment of general or continuing appro-
- 12 priation Acts for fiscal year 2011 after the adoption of
- 13 House Concurrent Resolution 34 but before the adoption
- 14 of this resolution.
- 15 (c) For provisions making appropriations for fiscal
- 16 year 2011, section 3(c) of House Resolution 5 shall have
- 17 force and effect through September 30, 2011.
