RESOLUTION

Declaring that the President shall not deploy, establish, or maintain the presence of units and members of the United States Armed Forces on the ground in Libya, and for other purposes.

- 1 Resolved,
- 2 SECTION 1. STATEMENTS OF POLICY.
- 3 The House of Representatives makes the following
- 4 statements of policy:
- 5 (1) The United States Armed Forces shall be
- 6 used exclusively to defend and advance the national
- 7 security interests of the United States.

- 1 (2) The President has failed to provide Con-2 gress with a compelling rationale based upon United 3 States national security interests for current United 4 States military activities regarding Libya.
- 5 (3) The President shall not deploy, establish, or 6 maintain the presence of units and members of the 7 United States Armed Forces on the ground in Libya 8 unless the purpose of the presence is to rescue a 9 member of the Armed Forces from imminent dan-10 ger.

5	SEC. 3. REPORT TO HOUSE OF REPRESENTATIVES.
6	(a) Contents.—Not later than 14 days after the
7	date of the adoption of this resolution, the President shall
8	transmit to the House of Representatives a report describ-
9	ing in detail United States security interests and objec-
10	tives, and the activities of United States Armed Forces,
11	in Libya since March 19, 2011, including a description
12	of the following:
13	(1) The President's justification for not seeking
14	authorization by Congress for the use of military
15	force in Libya.
16	(2) United States political and military objec-
17	tives regarding Libya, including the relationship be-
18	tween the intended objectives and the operational
19	means being employed to achieve them.
20	(3) Changes in United States political and mili-
21	tary objectives following the assumption of command
22	by the North Atlantic Treaty Organization (NATO).
23	(4) Differences between United States political
24	and military objectives regarding Libya and those of

1	other NATO member states engaged in military ac-
2	tivities.
3	(5) The specific commitments by the United
4	States to ongoing NATO activities regarding Libya.
5	(6) The anticipated scope and duration of con-
6	tinued United States military involvement in support
7	of NATO activities regarding Libya.
8	(7) The costs of United States military, polit-
9	ical, and humanitarian efforts concerning Libya as
10	of June 3, 2011.
11	(8) The total projected costs of United States
12	military, political, and humanitarian efforts con-
13	cerning Libya.
14	(9) The impact on United States activities in
15	Iraq and Afghanistan.
16	(10) The role of the United States in the estab-
17	lishment of a political structure to succeed the cur-
18	rent Libyan regime.
19	(11) An assessment of the current military ca-
20	pacity of opposition forces in Libya.
21	(12) An assessment of the ability of opposition
22	forces in Libya to establish effective military and po-
23	litical control of Libya and a practicable timetable

for accomplishing these objectives.

- (13) An assessment of the consequences of a cessation of United States military activities on the viability of continued NATO operations regarding Libya and on the continued viability of groups opposing the Libyan regime.
 - (14) The composition and political agenda of the Interim Transitional National Council (ITNC) and its representation of the views of the Libyan people as a whole.
 - (15) The criteria to be used to determine United States recognition of the ITNC as the representative of the Libyan people, including the role of current and former members of the existing regime.
 - (16) Financial resources currently available to opposition groups and United States plans to facilitate their access to seized assets of the Libyan regime and proceeds from the sale of Libyan petroleum.
 - (17) The relationship between the ITNC and the Muslim Brotherhood, the members of the Libyan Islamic Fighting Group, al-Qaeda, Hezbollah, and any other group that has promoted an agenda that would negatively impact United States interests.

- 1 (18) Weapons acquired for use, and operations 2 initiated, in Libya by the Muslim Brotherhood, the 3 members of the Libyan Islamic Fighting Group, al-4 Qaeda, Hezbollah, and any other group that has 5 promoted an agenda that would negatively impact
- 6 United States interests.
- 7 (19) The status of the 20,000 MANPADS cited 8 by the Commander of the U.S. Africa Command, as 9 well as Libya's SCUD-Bs and chemical munitions, 10 including mustard gas.
- 11 (20) Material, communication, coordination, fi-12 nancing and other forms of support between and 13 among al-Qaeda operatives, its affiliates, and sup-14 porters in Yemen, the Horn of Africa, and North Af-15 rica.
- 16 (21) Contributions by Jordan, the United Arab 17 Emirates, Qatar, and other regional states in sup-18 port of NATO activities in Libya.
- 19 (b) Transmittal.—The report required by this sec-20 tion shall be submitted in unclassified form, with a classi-
- 21 fied annex, as deemed necessary.
- 22 SEC. 4. FINDINGS.
- 23 (a) The President has not sought, and Congress has 24 not provided, authorization for the introduction or contin-

- 1 ued involvement of the United States Armed Forces in
- 2 Libya.
- 3 (b) Congress has the constitutional prerogative to
- 4 withhold funding for any unauthorized use of the United
- 5 States Armed Forces, including for unauthorized activities
- 6 regarding Libya.
