A BILL

To reauthorize and amend the National Fish and Wildlife Foundation Establishment Act.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Fish and
- 5 Wildlife Foundation Reauthorization Act of 2011".
- 6 SEC. 2. BOARD OF DIRECTORS OF THE FOUNDATION.
- 7 (a) IN GENERAL.—Section 3 of the National Fish
- 8 and Wildlife Foundation Establishment Act (16 U.S.C.
- 9 3702) is amended—

- "(A) IN GENERAL.—For purposes of this Act, an interest in real property shall be treated as including easements or other rights for preservation, conservation, protection, or enhancement by and for the public of natural, scenic, historic, scientific, educational, inspirational, or recreational resources.
- "(B) Encumbered real property.—A gift, devise, or bequest may be accepted by the Foundation even though the gift, devise, or bequest is encumbered, restricted, or subject to beneficial interests of private persons if any

- 21 used for purposes that further the conservation and man-
- 22 agement of fish, wildlife, plants, and other natural re-
- 23 sources.".
