A BILL

To amend title 28, United States Code, to clarify the statutory authority for the longstanding practice of the Department of Justice of providing investigatory assistance on request of State and local authorities with respect to certain serious violent crimes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Investigative Assist-
3 ance for Violent Crimes Act of 2011”.

4 **SEC. 2. INVESTIGATION OF MASS KILLING OR ATTEMPTED**
5 **MASS KILLING AND OTHER VIOLENT CRIMES.**

6 Title 28, United States Code, is amended—

7 (1) in section 530C(b)(1)(L)(i), by striking
8 “2,000,000” and inserting “\$3,000,000”;

9 (2) in section 530C(b)(4), by adding at the end
10 the following: “The authority to conduct or assist in
11 investigations includes the authority to deploy tac-
12 tical response, command and control, and other cri-
13 sis-management assets of the Bureau, as appro-
14 priate; and any such conduct or assistance shall be
15 understood presumptively to be within the scope of
16 Federal office or employment.”;

17 (3) in section 540A—

18 (A) in the section heading, by striking
19 “**Investigation of violent crimes**
20 **against travelers**” and inserting “**Inves-**
21 **tigation of certain violent crimes**”;

22 (B) in subsection (a), by inserting “, in the
23 investigation of violent acts and shootings oc-
24 ccurring in venues such as schools, colleges, uni-
25 versities, non-Federal office buildings, malls,
26 and other public places, and in the investigation

1 of mass killings and attempted mass killings”
2 after “traveler”; and

3 (C) in subsection (c), by adding the fol-
4 lowing new paragraph at the end:

5 “(4) ‘mass killings’ means 3 or more killings in
6 a single incident.”; and

7 (4) in the table of sections at the beginning of
8 chapter 33, by striking the item relating to section
9 540A and inserting the following:

“540A. Investigation of certain violent crimes.”.
