24	"(2) Bulk cargo.—For purposes of this sub-
25	section, the term 'bulk cargo' shall have the meaning

- Lakes, their connecting channels, and the Saint 8
- 9 Lawrence River.".
- (b) Effective Date.—The amendments made by 10
