## A BILL

To preserve the Green Mountain Lookout in the Glacier  
Peak Wilderness of the Mount Baker-Snoqualmie Na-  
tional Forest.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Green Mountain Look-  
5 out Heritage Protection Act”.

6 **SEC. 2. CLARIFICATION OF LEGAL AUTHORITY OF GREEN**  
7 **MOUNTAIN LOOKOUT.**

8 (a) LEGAL AUTHORITY OF LOOKOUT.—Section 4(b)  
9 of the Washington State Wilderness Act of 1984 (Public

1 Law 98–339; 98 Stat. 300; 16 U.S.C. 1131 note) is  
2 amended by striking the period at the end and inserting  
3 the following: “, and except that with respect to the lands  
4 described in section 3(5), the designation of such lands  
5 as a wilderness area shall not preclude the operation and  
6 maintenance of Green Mountain Lookout.”

7 (b) EFFECTIVE DATE.—The amendments made by  
8 this section shall take effect as if included in the enact-  
9 ment of the Washington State Wilderness Act of 1984.

10 **SEC. 3. PRESERVATION OF GREEN MOUNTAIN LOOKOUT**  
11 **LOCATION.**

12 The Secretary of Agriculture, acting through the  
13 Chief of the Forest Service, may not move Green Moun-  
14 tain Lookout from its current location on Green Mountain  
15 in the Mount Baker-Snoqualmie National Forest unless  
16 the Secretary determines that moving Green Mountain  
17 Lookout is necessary to preserve the Lookout or to ensure  
18 the safety of individuals on or around Green Mountain.  
19 If the Secretary makes such a determination, the Sec-  
20 retary shall move the Green Mountain Lookout to a loca-  
21 tion outside of the lands described in section 3(5) of the  
22 Washington State Wilderness Act of 1984 and designated  
23 as a wilderness area in section 4(b) of such Act.
