- To improve the reporting requirements relating to foreign travel by members of Congress and the use of foreign currency.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Cleaning Up Congress
- 5 by Providing Accountability for Congressional Foreign
- 6 Travel Act".

7 SEC. 2. USE OF FOREIGN CURRENCY.

- 8 Section 502(b) of the Mutual Security Act of 1954
- 9 (22 U.S.C. 1754(b)) is amended to read as follows:

3	"(1) LOCAL CURRENCIES FOR MEMBER AND

7	essary to purchase local currencies for the pur-
8	poses of congressional member and employee
9	foreign travel, which—

11	ing local currencies for the use of any indi-
12	vidual whose pay is disbursed by the Chief
13	Administrative Officer of the House of
14	Representatives shall be appropriated from
15	the applicable accounts of the House of
16	Representatives; and
17	"(ii) the amounts necessary for ob-
18	taining local currencies for the use of any
19	individual whose pay is disbursed by the
20	Secretary of the Senate shall be appro-
21	priated from the contingent fund of the
22	Senate.
23	"(B) AVAILABILITY.—The amounts de-
24	scribed in clauses (i) and (ii) of subparagraph
25	(A) shall be made available to Members and

1	employees of the Congress for their local cur-
2	rency expenses when authorized as provided in
3	subparagraph (C).
4	"(C) AUTHORIZATIONS.—The authoriza-
5	tion required for purposes of subparagraph (A)
6	may be provided by—
7	"(i) the Speaker of the House of Rep-
8	resentatives, in the case of a Member or
9	employee of the House of Representatives;
10	"(ii) the chairman of a standing or se-
11	lect committee of the House of Representa-
12	tives, in the case of a member or employee
13	of that committee;
14	"(iii) the President of the Senate, the
15	President pro tempore of the Senate, the
16	majority leader of the Senate, or the mi-
17	nority leader of the Senate, in the case of
18	a Member or employee of the Senate;
19	"(iv) the chairman of a standing, se-
20	lect, or special committee of the Senate in
21	the case of a member or employee of that
22	committee or of an employee of a member
23	of that committee; and

"(v) the chairman of a joint com-1 2 mittee of the Congress in the case of a member or employee of that committee. 3 "(D) REVIEW PROCEDURE.—The following 4 information shall be required and reviewed by 5 6 the authorizing officials under subparagraph 7 (C) before approval or denial of any foreign 8 travel authorization or appropriated dollar ex-9 penditures in connection with travel outside of 10 the United States by any Member or employee: 11 "(i) An explanation of purpose, the 12 itinerary of travel, and the related cost es-13 timates (per diem, lodging, meals, trans-14 portation and other purposes), including 15 the dollar equivalency of any Federal Gov-16 entity transportation ernment mode 17 planned. 18 "(ii) Before using any Federal Gov-19 ernment transportation mode, a Member

or employee shall perform a cost analysis comparison against a commercially available transportation equivalent to determine the most cost effective travel mode. This analysis shall institute all Federal Government transportation mode and commer-

- 1 cially available transportation equivalent 2 cost analysis comparisons. If the Federal 3 Government transportation cost is greater 4 than the commercially available transportation equivalent, a waiver shall be ap-5 6 proved by the authorizing officials under 7 subparagraph (C) permitting the Federal 8 transportation mode, and an explanation 9 and cost differential shall be reported in 10 the consolidated report for committees and 11 joint committees required under paragraph 12 (2)(A) and the Member or employee report 13 required under paragraph (3)(A). 14 "(iii) The names of any other individ-15 uals who are accompanying the Member or 16 employee during the travel, without regard 17 to whether such individuals are Members 18 or employees of Congress and the purpose 19 for their travel. 20 "(iv) Whether the amount of per diem 21 requested is greater than the standard per
- 22 diem provided under chapter 57 of title 5,23 United States Code.

24 "(v) A Member or employee who uses25 commercial air carriers for transportation

1 on official foreign travel business shall use 2 coach or economy class accommodations 3 for flights under 14 hours unless a waiver 4 is obtained. A waiver for business class ac-5 commodations may be obtained by the au-6 thorizing officials under subparagraph (C) for flights under 14 hours and the reasons 7 8 for the waiver shall be reported in the con-9 solidated report for committees and joint 10 committees required under paragraph 11 (2)(A) and the Member or employee report 12 required under paragraph (3)(A).

13 "(E) COST REDUCTION.—Each Member or 14 employee to whom the House of Representatives 15 or the Senate provides a per diem under this 16 subsection shall take such actions as may be 17 necessary to reduce costs incurred for such 18 travel and shall return to the House of Rep-19 resentatives or the Senate (as the case may be) 20 any per diem provided to the Member or em-21 ployee which remains unexpended as of the con-22 clusion of the travel. "(B) AVAILABILITY.—Each consolidated 5 6 report required by this paragraph shall be made 7 available for public inspection on the official 8 public Web sites of the Clerk of the House of 9 Representatives and the Secretary of the Senate 10 on the official public Web sites and shall be 11 published in the Congressional Record within 12 10 legislative days after the report is forwarded 13 pursuant to this paragraph. In the case of the 14 Select Committee on Intelligence of the Senate 15 and the Permanent Select Committee on Intel-16 ligence of the House of Representatives, such 17 consolidated report may, in the discretion of the 18 chairman of the committee, omit such informa-19 tion as would identify the foreign countries in 20 which members and employees of that com-21 mittee traveled.

22 "(3) MEMBER OR EMPLOYEE TRAVEL RE23 PORTS.—

24 "(A) IN GENERAL.—Each Member or em-25 ployee who receives an authorization from the

1	appropriate authorizing official for the purposes
2	of travel outside of the United States under
3	paragraph $(1)(B)$, shall within 7 business days
4	after the completion of the travel involved, sub-
5	mit a report setting forth the information speci-
6	fied in paragraph (2) along with all associated
7	documentation and reimbursable expense re-
8	ceipts to the authorizing officials under para-
9	graph $(1)(C)$.
10	"(B) APPROVAL PROCESS.—The author-
11	izing official shall approve or deny reimbursable
12	expenses submitted under subparagraph (A)
13	within 7 business days after receipt of the re-
14	port and supporting documentation and reim-
15	bursable receipts from the Member or employee.
16	The authorizing official shall keep record of the
17	report, supporting documentation, and reim-
18	bursable receipts for not less than 6 years and
19	3 months.
20	"(C) SUBMISSION TO CLERK OR SEC-
21	RETARY.—
22	"(i) IN GENERAL.—After the author-
23	izing official approves the submission re-
24	quired under subparagraph (A), the Mem-
25	ber or employee shall submit a report with-

1	in 7 business days after the information
2	specified in paragraph (2) to the Clerk of
3	the House of Representatives (in the case
4	of a Member of the House or an employee
5	whose salary is disbursed by the Chief Ad-
6	ministrative Officer of the House) or the
7	Secretary of the Senate (in the case of a
8	Member of the Senate or an employee
9	whose salary is disbursed by the Secretary
10	of the Senate). In the case of an authoriza-
11	tion for a group of Members or employees,
12	such reports shall be submitted for all
13	Members of the group by its chairman, or
14	if there is no designated chairman, by the
15	ranking Member or if the group does not
16	include a Member, by the senior employee
17	in the group.
18	"(ii) PUBLIC INSPECTION.—Each re-
19	port submitted pursuant to this subpara-
20	graph shall be made available for public in-
21	spection as follows:
22	"(I) The statement shall be sub-
23	mitted for publication in the Congres-
24	sional Record.

1	"(II) The statement shall be
2	posted on the official public Web site
3	of the authorizing office.
4	"(III) In the case of a statement
5	submitted with respect to travel of an
6	employee, the statement shall be post-
7	ed on the official public Web site of
8	the employee's employing office.
9	"(IV) In the case of a statement
10	submitted with respect to travel of a
11	Member, the statement shall be post-
12	ed on the official public Web site of
13	the Member.
14	"(iii) Consolidated report.—On a
15	quarterly basis, the Clerk of the House of
16	Representatives and the Secretary of the
17	Senate shall each prepare a consolidation
18	of the reports received by them under this
19	subparagraph with respect to expenditures
20	during the preceding quarter by each
21	Member and employee or by each group in
22	the case of expenditures made on behalf of
23	a group which are not allocable to indi-
24	vidual members of the group. Each such
25	consolidation shall be open to public in-

1	spection and shall be published in the Con-
2	gressional Record and be available on the
3	official public Web sites of the Clerk of the
4	House of Representatives and the Sec-
5	retary of the Senate within 10 legislative
6	days after the consolidation is completed.
7	"(4) Exclusion of information.—A Member
8	or employee may exclude from a statement prepared
9	under this subsection any information which is clas-
10	sified or the disclosure of which would adversely af-
11	fect national security if the Committee, Member, or
12	employee includes documentation in support of the
13	exclusion in the statement prepared under this sub-
14	section.
15	"(5) DEFINITIONS.—In this subsection—
16	"(A) any reference to a 'Member' of the
17	House of Representatives or Senate includes a
18	Delegate or Resident Commissioner to the Con-
19	gress;
20	"(B) the term 'official foreign travel'
21	means any travel outside of the United States
22	for which the costs (including the costs of
23	transportation, lodging, meals, and related ex-
24	penses) may be covered by appropriated funds,
25	including official funds of the House of Rep-

1	resentatives or Senate, under law or the Rules
2	of the House of Representatives or the Stand-
3	ing Rules of the Senate;
4	"(C) the term 'authorizing official' refers
5	to—
6	"(i) the Speaker of the House of Rep-
7	resentatives in the case of a Member or
8	employee of the House;
9	"(ii) the chairman of a standing or se-
10	lect committee of the House of Representa-
11	tives in the case of a member or employee
12	of that committee;

 SEC. 3. STUDY AND REPORT ON EXPENDITURES FOR OFFI

 11
 CIAL FOREIGN TRAVEL.

12 (a) STUDY.—The Comptroller General shall conduct 13 a study of the amount of appropriated funds (including official funds of the House of Representatives and Senate, 14 15 funds made available for the Secretary of Defense or the Secretary of State, and other funds available under any 16 17 Federal law, rule, or regulation) for official travel outside of the United States by Members, officers, and employees 18 19 of the House of Representatives and Senate, and shall in-20 clude in the study the following:

(1) For the period beginning with fiscal year
1994 and ending with the most recent fiscal year for
which relevant information is available, and for each
fiscal year during such period, the amount of such
funds spent on such travel, the number of trips

taken, and a list of the most frequently visited destinations, broken down by travel by Members, travel
by employees, and travel for which payment was
made using funds of committees of the Senate and
the House of Representatives.

6 (2) The source of funds used to pay for such
7 travel, and any limits on the amount which may be
8 spent on such travel or on any component of such
9 travel, such as airfare and accommodations.

10 (3) The types of military aircraft which are
11 used to carry out such travel, the military personnel
12 required to operate such aircraft, and the aggregate
13 and hourly costs involved.

14 (b) REPORT.—Not later than 180 days after the date 15 of the enactment of this Act, the Comptroller General shall submit to the President of the Senate, Speaker of the 16 17 House of Representatives, the Secretary of Defense, and the Secretary of State a report on the study conducted 18 under subsection (a) which shall include such rec-19 20 ommendations as the Comptroller General considers ap-21 propriate for determining the funding level for official 22 travel outside of the United States by Members, officers, 23 and employees of the Senate and the House of Representa-24 tives which will promote transparency and cost savings.

1 SEC. 4. EFFECTIVE DATE.
