#### **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Rural Preventive
- 5 Health Care Training Act of 2011".

## 1 SEC. 2. PREVENTIVE HEALTH CARE TRAINING.

2 Part D of title VII of the Public Health Service Act
3 (42 U.S.C. 294 et seq.) is amended by inserting after sec4 tion 754 the following:

### 5 "SEC. 754A. PREVENTIVE HEALTH CARE TRAINING.

6 "(a) IN GENERAL.—The Secretary may make grants 7 to, and enter into contracts with, eligible applicants to en-8 able such applicants to provide preventive health care 9 training, in accordance with subsection (c), to health care 10 practitioners practicing in rural areas. Such training shall, 11 to the extent practicable, include training in health care 12 to prevent both physical and mental disorders before the 13 initial occurrence of such disorders. In carrying out this subsection, the Secretary shall encourage, but may not re-14 quire, the use of interdisciplinary training project applica-15 16 tions.

17 "(b) LIMITATION.—To be eligible to receive training
18 using assistance provided under subsection (a), a health
19 care practitioner shall be determined by the eligible appli20 cant involved to be practicing, or desiring to practice, in
21 a rural area.

22 "(c) USE OF ASSISTANCE.—Amounts received under
23 a grant made or contract entered into under this section
