A BILL

- To reauthorize the Northwest Straits Marine Conservation Initiative Act to promote the protection of the resources of the Northwest Straits, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Northwest Straits Ma-
- 5 rine Conservation Initiative Reauthorization Act of 2011".

SEC. 2. REAUTHORIZATION OF NORTHWEST STRAITS MA-
RINE CONSERVATION INITIATIVE ACT.
The Northwest Straits Marine Conservation Initiative
Act (title IV of Public Law 105–384; 112 Stat. 3458) is
amended—
(1) in section 402, by striking "Commission (in
this title referred to as the 'Commission')." and in-
serting "Commission."; and
(2) by striking sections 403, 404, and 405 and
inserting the following:
"SEC. 403. FINDINGS.
"Congress makes the following findings:
((1) The marine waters and ecosystem of the
Northwest Straits in Puget Sound in the State of
Washington represent a unique resource of enor-
mous environmental and economic value to the peo-
ple of the United States.
"(2) During the 20th century, the environ-
mental health of the Northwest Straits declined dra-
matically as indicated by impaired water quality, de-
clines in marine wildlife, collapse of harvestable ma-
rine species, loss of critical marine habitats, ocean
acidification, and sea level rise.
"(3) At the start of the 21st century, the

25 Northwest Straits have been threatened by sea level

rise, ocean acidification, and other effects of climate
 change.

"(4) This Act was enacted to tap the unprecedented level of citizen stewardship demonstrated in
the Northwest Straits and create a mechanism to
mobilize public support and raise capacity for local
efforts to protect and restore the ecosystem of the
Northwest Straits.

9 "(5) The Northwest Straits Marine Conserva-10 tion Initiative helps the National Oceanic and At-11 mospheric Administration and other Federal agen-12 cies with their marine missions by fostering local in-13 terest in marine issues and involving diverse groups 14 of citizens.

15 "(6) The Northwest Straits Marine Conserva-16 tion Initiative shares many of the same goals with 17 the National Oceanic and Atmospheric Administra-18 tion, including fostering citizen stewardship of ma-19 rine resources, general ecosystem management, and 20 protecting federally managed marine species.

"(7) Ocean literacy and identification and removal of marine debris projects are examples of ongoing partnerships between the Northwest Straits
Marine Conservation Initiative and the National
Oceanic and Atmospheric Administration.

 call of the Chairperson, but not less frequently than quar terly.

1 "SEC. 406. GOAL AND DUTIES OF THE COMMISSION.

2	"(a) GOAL.—The goal of the Commission is to pro-
3	tect and restore the marine waters, habitats, and species
4	of the Northwest Straits region to achieve ecosystem
5	health and sustainable resource use by—

6 "(1) designing and initiating projects that are 7 driven by sound science, local priorities, community-8 based decisions, and the ability to measure results; 9 "(2) building awareness and stewardship and 10 making recommendations to improve the health of 11 the Northwest Straits marine resources;

12 "(3) maintaining and expanding diverse mem-13 bership and partner organizations;

14 "(4) expanding partnerships with governments
15 of Indian tribes and continuing to foster respect for
16 tribal cultures and treaties; and

17 "(5) recognizing the importance of economic
18 and social benefits that are dependent on marine en19 vironments and sustainable marine resources.

20 "(b) DUTIES.—The duties of the Commission are the21 following:

"(1) To provide resources and technical support
for marine resources committees established under
section 408.

2	grams to monitor the overall health of the marine
3	ecosystem of the Northwest Straits.
4	"(3) To identify factors adversely affecting or
5	preventing the restoration of the health of the ma-
6	rine ecosystem and coastal economies of the North-
7	west Straits.
8	"(4) To develop scientifically sound restoration
9	and protection recommendations, informed by local
10	priorities, that address such factors.
11	"(5) To assist in facilitating the successful im-
12	plementation of such recommendations by developing
13	broad support among appropriate authorities, stake-
14	holder groups, and local communities.
15	"(6) To develop and implement regional
16	projects based on such recommendations to protect
17	and restore the Northwest Straits ecosystem.
18	"(7) To serve as a public forum for the discus-
19	sion of policies and actions of Federal, State, or
20	local government, an Indian tribe, or the Govern-
21	ment of Canada with respect to the marine eco-
22	system of the Northwest Straits.
23	"(8) To inform appropriate authorities and
24	local communities about the marine ecosystem of the

1	Northwest Straits and about issues relating to the
2	marine ecosystem of the Northwest Straits.
3	"(9) To consult with all affected Indian tribes
4	in the region of the Northwest Straits to ensure that
5	the work of the Commission does not violate tribal
6	treaty rights.
7	"(c) BENCHMARKS.—The Commission shall carry out
8	its duties in a manner that promotes the achieving of the
9	benchmarks described in subsection $(f)(2)$.
10	"(d) Coordination and Collaboration.—The
11	Commission shall carry out the duties described in sub-
12	section (b) in coordination and collaboration, when appro-
13	priate, with Federal, State, and local governments and In-
14	dian tribes.
15	"(e) Regulatory Authority.—The Commission
16	shall have no power to issue regulations.
17	"(f) ANNUAL REPORT.—
18	"(1) IN GENERAL.—Each year, the Commission
19	shall prepare, submit to the Committee on Com-
20	merce, Science, and Transportation of the Senate,
21	the Committee on Energy and Commerce of the
22	House of Representatives, and the Under Secretary
23	for Oceans and Atmosphere, and make available to

24 the public an annual report describing—

1	"(A) the activities carried out by the Com-
2	mission during the preceding year; and
3	"(B) the progress of the Commission in
4	achieving the benchmarks described in para-
5	graph (2).
6	"(2) BENCHMARKS.—The benchmarks de-
7	scribed in this paragraph are the following:
8	"(A) Protection and restoration of marine,
9	coastal, and nearshore habitats.
10	"(B) Prevention of loss and achievement of
11	a net gain of healthy habitat areas.
12	"(C) Protection and restoration of marine
13	populations to healthy, sustainable levels.
14	"(D) Protection of the marine water qual-
15	ity of the Northwest Straits region and restora-
16	tion of the health of marine waters.
17	"(E) Collection of high-quality data and
18	promotion of the use and dissemination of such
19	data.
20	"(F) Promotion of stewardship and under-
21	standing of Northwest Straits marine resources
22	through education and outreach.

3 "(a) DIRECTOR.—The Manager of the Shorelands and Environmental Assistance Program of the Depart-4 5 ment of Ecology of the State of Washington may, upon the recommendation of the Commission and the Director 6 7 of the Padilla Bay National Estuarine Research Reserve, 8 appoint and terminate a Director of the Commission. The 9 employment of the Director shall be subject to confirma-10 tion by the Commission.

11 "(b) STAFF.—The Director may hire such other per-12 sonnel as may be appropriate to enable the Commission 13 to perform its duties. Such personnel shall be hired 14 through the personnel system of the Department of Ecol-15 ogy of the State of Washington.

16 "(c) Administrative Services.—If the Governor of the State of Washington makes available to the Commis-17 sion the administrative services of the State of Wash-18 19 ington Department of Ecology and Padilla Bay National Estuarine Research Reserve, the Commission shall use 2021 such services for employment, procurement, grant and fis-22 cal management, and support services necessary to carry 23 out the duties of the Commission.

24 "SEC. 408. MARINE RESOURCES COMMITTEES.

25 "(a) IN GENERAL.—The government of each of the26 counties referred to in subparagraphs (A) through (G) of

1	section $405(a)(1)$ may establish a marine resources com-
2	mittee that—
3	"(1) complies with the requirements of this sec-
4	tion; and
5	((2)) receives from such government the mis-
6	sion, direction, expert assistance, and financial re-
7	sources necessary—
8	"(A) to address issues affecting the marine
9	ecosystems within its county; and
10	"(B) to work to achieve the benchmarks
11	described in section $406(f)(2)$.
12	"(b) Membership.—
13	"(1) IN GENERAL.—Each marine resources
14	committee established pursuant to this section shall
15	be composed of—
16	"(A) members with relevant scientific ex-
17	pertise; and
18	"(B) members that represent balanced rep-
19	resentation, including representation of—
20	"(i) local governments, including plan-
21	ning staff from counties and cities with
22	marine shorelines;
23	"(ii) affected economic interests, such
24	as ports and commercial fishers;

21	dress those needs.
22	"(5) To work closely with county leadership to
23	implement local marine conservation and restoration
24	initiatives.

"(6) To coordinate with the Commission on ma rine ecosystem objectives.

3 "(7) To educate the public and key constitu4 encies regarding the relationship between healthy
5 marine habitats, harvestable resources, and human
6 activities.

7 "SEC. 409. NORTHWEST STRAITS MARINE CONSERVATION8 FOUNDATION.

9 "(a) ESTABLISHMENT.—The Director of the Com-10 mission and the Director of the Padilla Bay National Estuarine Research Reserve may enter into an agreement 11 12 with an organization described in section 501(c)(3) of the 13 Internal Revenue Code of 1986 to establish a nonprofit foundation to support the Commission and the marine re-14 15 sources committees established under section 408 in carrying out their duties under this Act. 16

17 "(b) DESIGNATION.—The foundation authorized by
18 subsection (a) shall be known as the 'Northwest Straits
19 Marine Conservation Foundation'.

"(c) RECEIPT OF GRANTS.—The Northwest Straits
Marine Conservation Foundation may, if eligible, apply
for, accept, and use grants awarded by Federal agencies,
States, local governments, regional agencies, interstate
agencies, corporations, foundations, or other persons to

assist the Commission and the marine resources commit tees in carrying out their duties under this Act.

3 "(d) TRANSFER OF FUNDS.—The Northwest Straits
4 Marine Conservation Foundation may transfer funds to
5 the Commission or the marine resources committees to as6 sist them in carrying out their duties under this Act.

7 "SEC. 410. AUTHORIZATION OF APPROPRIATIONS.

8 "There are authorized to be appropriated to the Sec-9 retary of Commerce for the use of the Commission such 10 sums as may be necessary to carry out the provisions of 11 this title.".
