JOINT RESOLUTION

Making continuing appropriations of local funds of the District of Columbia for fiscal year 2014.

- 1 Resolved by the Senate and House of Representatives
- 2 of the United States of America in Congress assembled,
- 3 Sec. 1. This joint resolution may be cited as the
- 4 "District of Columbia Continuing Appropriations Resolu-
- 5 tion, 2014".

- 1 Sec. 2. (a) The District of Columbia may expend
- 2 local funds under the heading "District of Columbia
- 3 Funds" for such programs and activities under title IV
- 4 of H.R. 2786 (113th Congress), as reported by the Com-
- 5 mittee on Appropriations of the House of Representatives,
- 6 at the rate set forth under "District of Columbia Funds-
- 7 -Summary of Expenses" as included in the Fiscal Year
- 8 2014 Budget Request Act of 2013 (D.C. Act 20–127), as
- 9 modified as of the date of the enactment of this joint reso-
- 10 lution.
- 11 (b) Appropriations made by subsection (a) are pro-
- 12 vided under the authority and conditions as provided
- 13 under the Full-Year Continuing Appropriations Act, 2013
- 14 (division F of Public Law 113-6) and shall be available
- 15 to the extent and in the manner that would be provided
- 16 by such Act.
- 17 Sec. 3. Appropriations made and authority granted
- 18 pursuant to this joint resolution shall cover all obligations
- 19 or expenditures incurred for any project or activity during
- 20 the period for which funds or authority for such project
- 21 or activity are available under this joint resolution.
- Sec. 4. Unless otherwise provided for in this joint
- 23 resolution or in the applicable appropriations Act for fiscal
- 24 year 2014, appropriations and funds made available and
- 25 authority granted pursuant to this joint resolution shall

- 1 be available until whichever of the following first occurs:
- 2 (1) the enactment into law of an appropriation for any
- 3 project or activity provided for in this joint resolution; (2)
- 4 the enactment into law of the applicable appropriations
- 5 Act for fiscal year 2014 without any provision for such
- 6 project or activity; or (3) December 15, 2013.
- 7 Sec. 5. Expenditures made pursuant to this joint res-
- 8 olution shall be charged to the applicable appropriation,
- 9 fund, or authorization whenever a bill in which such appli-
- 10 cable appropriation, fund, or authorization is contained is
- 11 enacted into law.
- 12 Sec. 6. Appropriations made and funds made avail-
- 13 able by or authority granted pursuant to this joint resolu-
- 14 tion may be used without regard to the time limitations
- 15 for submission and approval of apportionments set forth
- 16 in section 1513 of title 31, United States Code, but noth-
- 17 ing in this joint resolution may be construed to waive any
- 18 other provision of law governing the apportionment of
- 19 funds.

- 1 Sec. 7. It is the sense of Congress that this joint
- 2 resolution may also be referred to as the "Provide Local
- 3 Funding for the District of Columbia Act".
